Governor arrives at Council Chamber.

At Two o'clock, p. m., His Excellency the Governor, Lieutenant-Colonel Sir J. Terence N. O'Brien, K.C.M.G., having arrived at the Council Chamber and being seated on the Throne, the Honorable the President commanded the Gentleman Usher of the Black Rod, attendant on the Council, to proceed to the House of Assembly and inform the Members thereof that it is His Excellency's will and pleasure that they attend at the Bar of this House, and they being come thereto, George Henry Emerson, Esquire, a Member for the District of Placentia and St. Mary's, having been presented by the Hon. Sir W. V. Whiteway, Mr. Speaker elect K.C.M.G., as Speaker elect and the choice approved, and the usual privileges claimed and granted, His Excellency was pleased to open the present Session of the Legislature with the following gracious Speech to both Houses:-

- Mr. President and Honourable Gentlemen of the Legis-Governor's Speech. lative Council:
- Mr. Speaker and Gentlemen of the Honourable House of Assembly:

You assemble here to-day for the discharge of the duties you have assumed as the representatives of the people, and I greet you most cordially at the threshold of your deliberations.

Since I last convened the Legislature a General Election has taken place and has resulted in a very strong pronouncement in favor of the policy of my Government.

I am pleased to be able to congratulate you upon the favourable aspect of the Colony's position generally. While the year that has passed has been remarkable for the depression in trade and for the financial embarrassment that has passed like a wave over many parts of the British Empire and America, the trade and commerce of this Colony has not been affected to any appreciable degree. The total absence of business failures bear eloquent testimony to the sound financial position of our country.

The Seal-fishery of last year, I regret to say, was a comparative failure; the total number of seals taken amounting to only one half of the previous year's voyage. This has been attributed to artificial rather than natural causes, and particularly to the Legislation then in force whereby many of the owners of sealing steamers were induced to despatch them from northern ports. I hope that the amendment to the legislation referred to, adopted last Session, will prove advantageous.

Governor's Speech The Cod-Inshery, willied and Continued). dustry, was prosecuted successfully, the exports shewing an increase of two hundred thousand quintals over that of 1892. Owing, however, to the keen competition of our bounty-fed competitors the price realized for this producion was not altogether satisfactory.

> The returns for the Herring and Salmon fisheries do not compare favourably with those of the previous year.

> The Lobster fishery evinced a marked improvement, and the gradual revival of this industry is no doubt due to the restrictive legislation adopted by your honourable Houses.

> The export of Copper Ore and Iron Pyrites are largely in excess of 1892, but the value was considerably below.

> This may also be said of our exports of Lumber.

> Last season was not favourable to agricultural success. The long continuance of wet weather resulted in a very short potato crop. Farmers were, however, compensated to some extent by good crops of hay and fodder.

> Railway extension during the year that has passed has been rapid and eminently satisfactory. The Northern Railway has been completed. The rails have been laid to a point thirty-seven miles to the westward of the Exploits, and the line is graded to the forty-fifth mile. Six miles of the Brigus branch has also been graded.

> This great enterprise has afforded steady employment to more than fifteen hundred of our

operatives since the month of May last, and under Governor's Speech this and other influences there has been a total absence of able-bodied poverty.

I have been much gratified in noticing the progress that is being made in the re-building of this city. The rapidity with which this work is advancing not only manifests the enterprise of our citizens, but also their firm faith in the future prosperity of the Colony.

Mr. Speaker and Gentlemen of the L'onourable House of Assembly:

The Customs' Revenue of last year was in excess of the estimated amount. I have directed the estimates of this year, which have been framed with a due regard to efficiency and economy, to be prepared and forwarded to you without delay.

Mr. President and Honourable Gentlemen of the Legislative Council:

Mr. Speaker and Gentlemen of the Honourable House of Assembly:

It has been the policy of the Government to collect the principal part of its revenue by the taxation of imports; and no change in this policy is at present practicable or desirable. But it is considered by my Government that this taxation does not bear evenly upon the different classes of the community, and an effort will therefore be made during the present Session to so readjust the tariff as to cheapen the cost of living and enable the labouring man to bring within his domestic circle additional comforts and advantages.

In compliance with a resolution of the Legislature I transmitted to Her Majesty's Government

Governor's Speech the Report of the Joint Select Committee appoint--(Continued.) ed to take into consideration the French Treaties' Question, and in June last I received a despatch from the Right Honourable Secretary of State for the Colonies intimating that the said Report had received the most careful consideration of Her Majesty's advisers, who expressed their willingness to meet the views of this Legislature as far as it is possible to do so.

> In view of the pressing importance of this subject I deem it my duty to again urge its early consideration by your honourable Houses.

> In these and all other efforts that you may make to promote the well-being of the people of the Colony, I pray that you may be guided by the hand of Almighty God.

MAY IT PLEASE YOUR EXCELLENCY, --

We, the Legislative Council of Newfoundland, Address. in Session convened, desire to thank Your Excellency for the gracious Speech with which you have been pleased to open the present Session of the Legislature, and for your cordial greeting.

It is a source of gratification that the General Election has resulted in a very strong pronouncement in favour of the policy of your Government.

We receive with pleasure Your Excellency's congratulations on the general prosperity of the Colony during a period of depression in trade and financial embarrassment in many commercial communities.

The comparative failure of our Seal-fishery of last season might have been attributable in some measure to the law then in force, and we trust that the amended legislation will be found of advantage.

Address.—
(Continued.)

The success of the staple industry of last year—the Cod-fishery—is a subject of congratulation, and notwithstanding the depression of prices by the competition of bounty-fed rivals in foreign markets, was of the highest value to our people.

We regret to find that the returns from the Herring and Salmon fisheries do not compare favorably with those of the previous year.

We think that the improvement in the Lobster-fishery, and the gradual revival of this industry, may fairly be attributed to the recent restrictive legislation.

It is to be regretted that although the yield of Copper Ore and Iron Pyrites was largely in excess of that of 1892, its market value was considerably less.

The Agricultural returns of last season, generally, were not encouraging; the yield of the potato, on which our people so largely depend, having been unusually deficient. It is, however, satisfactory to find that there were good crops of hay and fodder.

We are pleased with the information that Railway extension during the past year has been rapid and eminently satisfactory, having afforded employment to more than 1,500 of our operatives during the open season, and has thus been a great factor in preventing poverty.

We are gratified to notice the progress that is being made in the re-building of this city, manifesting the enterprise of our citizens and the firm faith in the future of the Colony.

We concur in the policy of collecting the Address .-(Continued.) principal part of the revenue by taxation of imports, and we are pleased to find that it is proposed during the present Session so to re-adjust the tariff as to cheapen the cost of living, and enable the laboring man to bring within his domestic circle additional comforts and advantages.

> The Legislative Council and House of Assembly do not deem it necessary to enter upon a discussion of the question as to whether Mr. Justice Winter was acting ultra vires or otherwise.

> It is sufficient for these Houses to be informed of the fact of his having so adjudicated, and if the Law be such as to empower any tribunal outside the Legislature to assume the power so to adjudicate then it is the opinion of these Houses that the Law should be amended without delay.

> The Executive Council which has tendered its resignation has the confidence of the Electorate, and as Your Excellency has refused to accept their advice the Legislative Council and House of Assembly respectfully request that Your Excellency
