Governor arrives at Council Chamber;

At Two o'clock, P. M., His Excellency the Governor Sir Herbert Harley Murray, K. C. B., having arrived at the Council Chamber, and being seated on the Throne, the Hon'ble the President commanded the Gentleman Usher of the Black Rod, attendant on the Council, to proceed to the House of Assembly and inform the Members thereof, that it is His Excellency's will and pleasure that they attend at the Bar of this House; and they being come thereto, Henry Y. Mott, Esquire, Member for the District of Burgeo and LaPoile, having been presented by the Hon. the Premier, Sir James S. Winter, K. C. M. G., as Speaker elect, and the choice approved and the usual privileges claimed and granted, His Excellency was pleased to open the

Mr. Speaker elect presented and approved. present Session of the Legislature with the following gracious Speech to both Houses:--

- Mr. President and Honourable Gentlemen of the Le-Governor's Speech.
- Mr. Speaker and Gentlemen of the Honourable House of Assembly:

I am glad to meet you, at the commencement of the Eighteenth General Assembly, and I confidently hope that your deliberations will, under Divine blessing, promote the happiness and prosperity of the people. A prompt disposal of the business brought before you, and a consequent early termination of the Session, will tend to the advantage of the Public Service and of your personal affairs.

The commercial and industrial operations of the year last past were not, I regret to say, attended with success. The Seal and Cod fisheries did not yield a good return, and the prices realized were low. The Lobster packing industry, as to both catch and price, was satisfactorily maintained; and cannot be too carefully protected from injury or destruction. I am glad to learn that an improvement in our Foreign markets has to a large degree restored confidence in commercial operations for the coming season.

Agricultural operations were attended with a fair measure of success. The Hay crop was good. The Potato crop was injured by cold weather in the Spring and Autumn. The continuance of large importations of vegetables such as can be grown here with success should be considered with a view to adopting measures to promote the increase of home produce. It is apparent that in the past

speech.— enough attention and fostering care have not been (Continued.) given to Agriculture in this Colony.

The year was marked with unusual activity in Mining matters. The number of applications for Mineral Licenses was above the average. Workable deposits of Iron were discovered and partially developed in the District of Bay-de-Verde, and in several parts of the District of Twillingate deposits of Copper and other Minerals have been found, the working of which, it is hoped, will be successful. Some Oil Wells have been and others are to be sunk upon or near the West Coast, and the existence of valuable Coal deposits was made more certain by exploration. Altogether the outlook in Mining matters is calculated to encourage our people.

Mr. Speaker and Gentlemen of the Honourable House of Assembly:

The Revenue for the fiscal year 1896-97 was slightly in excess of the estimate, while the expenditure was considerably above. The revenue for the past six months of 1897-98 was below the estimate, and during the same period an undue proportion of the estimated expenditure for the whole year was made, the result being a considerable deficit at the end of the first half of the financial year.

Supplementary estimates for the year 1897-98 and the estimates for 1898-99, will be laid before you. They will be prepared with a view to economy and efficiency in the public service.

You will be asked to give your attention to proposals for a readjustment of the Tariff of import

duties, having for its object a more equal distribu-speech.—
tion of taxation, and the encouragement of industries.

A measure will be submitted to you authorizing the issue of Treasury Notes of the Colony for circulation as legal tender. I believe that the adoption of this system will be found to be of public convenience, and also yield a profit to the Colony.

Bills providing for the payment of certain fees in legal affairs by stamps, and imposing a stamp duty on cheques and other valuable securities will also be brought before you.

Mr. President and Honourable Gentlemen of the Legislative Council:

Mr. Speaker and Gentlemen of the Honourable House of Assembly:

The General Election in October last resulted in the defeat of a majority of the supporters of my late advisers, and in November the present Ministry accepted office. In accordance with their pledge to the people, they have made large reforms in the Civil Service of the Colony in the direction of economy and efficiency, and will continue to do so.

Experience gained during the last General Election demonstrates the necessity of amendments in the "Election Act, 1889," to secure greater freedom and purity in elections, and a Bill for that purpose will be submitted.

It is believed that a Sealing Industry carried on in Sailing Vessels, would result in considerable advantage to a large number of our people. A Bill to provide a bounty for its encouragement will be Speech.— (Continued.)

introduced. Notification of this intention has been given to the public, and it is now certain that a considerable number of vessels will qualify for the bounty this year.

The fisherman-farmers are as a rule the most prosperous class in the Colony. Fishermen without land to till are alternately prosperous and poor. It is, therefore, intended to introduce a Bill providing bounties for clearing and cultivating land, and for assisting settlement by fishermen and others in desirable localities.

It is intended that measures for defining and distributing the work of the various departments of the Civil Service shall be introduced. An Audit and Appropriation Act will also be submitted. The present system, or lack of system, tends to abuse and extravagance, and an efficient audit of the public accounts would be of great value.

It is essential that a suitable Court House should be erected in Saint John's during this year. The building recently occupied by the Union Bank has been purchased for departmental buildings. A Bill to provide the necessary funds for both purposes will be introduced.

Elective boards, for the management of local affairs have been promised to the people. Measures legalizing the creation of such boards have hitherto proven abortive. A Bill to amend the law will be submitted.

The Newfoundland Railway, so-called, was purchased by the Colony for the purpose of facilitating a cansolidation of the Colony's Railway system under one management. This appears necessary to the promotion of internal development. It will

tend, it is believed, to the investment of capital in speech.— industrial operations along and adjacent to the line of railway. Negotiations to procure such a consolidation are progressing, and it is believed that a measure for this purpose can be arranged and submitted during this Session.

In 1891 Her Majesty's Government offered to send out a Commission (1) "to enquire into the "agricultural, and mining resources of the Colony, "and in what manner they may best be developed; "(2) to enquire into the general financial position "of the Colony, and report thereon; (3) to enquire "into and report upon the present condition of "the people resident on or near those portions "of the Coast of Newfoundland which are subject "to the French fishery rights, and to ascertain in "what particular respect the Treaty obligations of "Great Britain and the Colony have operated to "the prejudice of that population, and further, "to report upon what remedies, consistent with "these obligations and with the rights and inte-"rests of other portions of the Empire, may be "practicable to remove the disadvantages under "which the inhabitants of Newfoundland labour." My late advisers agreed to accept the Commission, but not until after such delay that its despatch in 1891 appeared to Her Majesty's Government to be inexpedient. A vote of £2,000 for the expenses of the Commission, was placed in the Imperial estimates. No response was made to this action, but in the Session of the Legislature held in 1892 certain legislation, the enactment of which my late advisers had promised to procure, was rejected in the Assembly, and the Commission was abandoned. The report of such a Commission could not have

failed, I believe, to confer great benefits upon our people. My present advisers desire to procure such a Commission, and negotiations for that purpose will be commenced at an early date. As a basis for such negotiations, it is intended to submit resolutions in favor of a Commission to both branches of the Legislature.

Rules and Regulations to be observed in the LEGISLATIVE COUNCIL OF NEWFOUNDLAND:

1. The President, when he speaks to the House, is always to be uncovered, and is not to adjourn the House, or do anything else as mouthpiece of the House, without the consent of the members first had, excepting the ordinary things about Bills which are of course, wherein the members may likewise over-rule, as for preferring one Bill before another, and such like. And in case of difference among the members, it is to be put to the question; and if the President desire to speak to anything Rules.—
(Continued.)
particular, he shall go to his own place as a member.

- 2. Immediately after the President shall have taken the Chair, the doors shall be closed, and the Journals of the proceeding day be read and confirmed, or if necessary corrected.
- 3. Any member may at any time desire the House to be cleared of strangers, and the President shall immediately give directions to execute the order, without debate.
- 4. When the House is sitting, every member that shall enter, is to give to and receive salutations from the President, and not to sit down in his place unless he has made his obeisance.
- 5. The members in the House are to keep their dignity and order, in sitting, as much as may be, and not remove out of their places without just cause; but when they must needs go across the House, they are to make obeisance to the Chair.
- 6. When any member speaks, he shall address the Chair.
- 7. No member is to speak twice to any Bill at any one time of reading it, or to any other proposition, unless it be to explain himself in some material point of his speech, and then not without leave of the House first obtained. Every member speaks standing and uncovered, and names not the members of the House commonly by their names, but "the member that spoke last"—"last but two," etc.—or some other note of distinction.
- 8. Such members as shall make protestations, or enter their dissents to any votes of the House, as

Rules.— they have a right to do, million (Continued.) House, either with or without their reasons, shall they have a right to do, without asking leave of the cause their protestations or dissents to be entered in the Clerk's book on the next sitting day of this House, before the rising of the House, otherwise the same shall not be entered and shall also sign the same before the rising of the House on the same day.

- 9. All orders of the day, which by reason of any adjournment shall not have been proceeded upon, shall be considered as postponed to the next day on which the House shall sit.
- 10. To prevent misunderstanding, and for avoiding offensive speeches when matters are being debated, either in the House or in Committee, it is for honor's sake thought fit, and is so ordered, that all personal, sharp, or taxing speeches be forborne, and that whoseever answereth another man's speech shall apply his answer to the matter without wrong to the person; and as nothing offensive is to be spoken, so nothing is to be ill-taken, if the party that speaks it shall presently make a fair exposition or clear denial of the words that might bear any ill construction; and if any offence be given in that kind, as the House itself will be very sensible thereof, so it will censure the offender, and give the party offended a fit reparation and a full satisfaction. henve of the House first obtained.
- 11. For avoiding all mistakes, unkindness, or other differences, which may grow to quarrels, tending to the breach of the peace, if any member shall conceive himself to have received an affront or injury from any other member of the House, either in the House, or in Committee, or in any of

the rooms belonging to the Legislative Council, he Rules.—
shall appeal to the House for his reparation; which,
if he shall not do, but occasion or entertain quarrels, declining the justice of the House, then the
member that shall be found therein offending shall
undergo the severe censure of the House.

- 12. When a question is under debate, no motion shall be received in the House, unless to amend it, commit it, postpone it to a certain day, or for the order of the day, or to adjourn.
- 13. One day's notice of all motions, other than for a Committee of Privilege, shall be given to the House; and any motion (with leave of the House) may be withdrawn at any time before amendment or decision.
- 14. No motion prefaced by a written preamble, shall be received by this House.
- 15. When the question has been put by the President, no member is to speak upon the question before voting.
- 16. After the question is put, and the House has voted thereon, no member shall depart out of his place until the House has entered upon some other business.
- 17. At the time of voting the contents shall rise in their places, and the non-contents continue to sit; and the names of the contents and non-contents shall be taken and entered on the minutes.
- 18. The Clerk shall enter no order until the President first demand the assent of the House; and he shall read every order first in the House, before it be entered.

Rules .-

- 19. Each member has a right to require that the (Continued.) question, or motion, in discussion, be read for his information, at any time of the debate.
 - 20. To have more freedom of debate, and to facilitate business, Committees are appointed, either of the whole House, or of individuals; the Committees of the whole House sit in the House, but then the President shall not sit in the Chair.
 - 21. In a Committee of the whole House, the Rules of the House shall be observed in so far as they may be applicable, excepting the Rule limiting the times of speaking; and no motion for the previous question, and for adjournment, can be received, but a member may at any time move that the Chairman do leave the Chair, or report some progress made, and ask leave to sit again.
 - 22. Select Committees usually meet in one of the Committee Rooms. The members of the Committee speak to the rest uncovered, but may sit if they please.
 - 23. At any Committee, members of the House, though not of the Committee, are not excluded from coming in and speaking, but they must not vote; they shall also give place to all that are of the Committee, and shall sit behind them.
 - 24. When anything that has been committed is reported, the members of the Committee stand.
 - 25. No one shall enter at any Committee or Conference, unless members of the House, or such as may be commanded to attend.
 - 26. With regard to messages between the Legislative Council and House of Assembly, one of the Clerks of either House may be the bearer of the

messages from the one to the other; and messages Rules.—
so sent shall be received at the Bar by one of the
Clerks of the House to which they are sent at any
time, whilst it is sitting or in committee, without
interrupting the business then proceeding.

- 27. None are to speak at a Conference with the Lower House, but those that are of the Committee; and when any thing from such Conference is reported, all the members of that Committee present are to stand up.
- 28. As it might deeply intrench on the privileges of this House for any member to answer an accusation in the House of Assembly, either in person or by sending his answer in writing, or by his counsel there; upon serious consideration had thereof, and perusal of the precedents in the Upper House of the Imperial Parliament, it is ordered, that no member of this House shall either go down to the House of Assembly, or send his answer in writing, or appear by counsel to answer any accusation there, upon penalty of being committed to the Black Rod, or to prison during the pleasure of this House.
- 29. No member or officer of this House shall attend before the House of Assembly, or any Committee thereof, on any orders of theirs without permission of the House.
- 30. It is the right of every member of this House to bring in a Bill, and pray that it may be read.
- 31. Bills may be opposed at any stage, but the principle is usually debated at the second reading.
- 32. No arguments against the principle of a Bill shall be had or admitted in any Committee of the whole House upon such Bill.

Rules.— (Continued.)

- 33. No Bill shall be read twice on the same day; unless the House, upon motion, shall see special cause for the despatch of business to change the course in any particular instance.
- 34. In a Committee of the whole House, a member may, at any time previous to a Bill being passed entirely, that is say, all the clauses, preamble and title of the same, move to have any particular clause thereof, that may have been passed, re-considered.
- 35. To annex any clause or clauses to a Bill of Aid or Supply, the matter of which is foreign to and different from the matter of the said Bill of Aid or Supply, is unparliamentary.
- 36. All applications for private Bills for the purpose of granting to any individual or individuals any exclusive or peculiar rights or privileges whatever, or for doing any matter or thing which in its operation would affect the rights of other parties, or relate to any particular class of the community; or for making any amendment of a like nature to any former act, shall require a notice, clearly and distinctly specifying the nature and object of the application and (except in the case of existing corporations) signed on behalf of the applicants, to be published in the Royal Gazette and one other newspaper. Such notices shall be continued in each case for a period of at least one month, during the interval of time between the close of preceding session and the consideration of the petition; and copies of newspapers containing the first and last insertion of such notice, shall be sent by the parties inserting such notice to the Clerk of the Legislative Council to be filed. - 37. Every petition which is brought up shall lie Rules.—

- 38. All allegations in every petition for a Private Bill, meant to originate in this House, shall be first referred to a Select Committee, and the matter thereof reported upon, before the introduction of any such Bill.
- 39. Every member who shall introduce a Bill, Petition or Motion, upon any subject which may be referred to a Committee, shall be one of the Committee without being named by the House.
- 40. When a private Bill is brought from the other House, the principle of which is admitted, this House, by message, may either request a communication of the evidence received in proof of the allegations or matter whereon the Bill is founded, or the Committee of this House to whom it may be referred, shall examine the said allegations, and on reporting the Bill, state whether the same or matter thereof be founded, and whether the parties concerned in interest or property therein, have given their consent to the satisfaction of the Committee.
- 41. The foregoing shall be considered a standing instruction to all Committees which shall meet upon private Bills; and further that they require all persons, whose interest or property they shall consider to be affected thereby, to appear in person, before them, to give their consent thereto; and if they cannot personally attend, they may send their consent in writing, which shall be proved to the satisfaction of the Committee; and that when any Committee shall be appointed on a private Bill, notice thereof shall be set up in the lobby of this

42. Any person seeking to obtain any private Bill, giving any exclusive privilege, or profit, or private or corporate advantage, or for any amendment of any former Act, shall be required to deposit with the Clerk of this House a copy of such Bill, with a sum sufficient for printing the same. - Governor's Speech. Mr. President and Honourable Gentlemen of the Legislative Council:
 - Mr. Speaker and Gentlemen of the Honourable House of Assembly:

It affords me gratification to be able to relieve you at the end of a session unprecedented in the history of this Legislature for the number, variety and importance of the subjects dealt with. I appreciate the marked care and assiduity with which you have discharged your duties.

The session was opened earlier in the year than usual, to avoid interruption of your ordinary avocations in the spring season, and it is pleasant to

note that by your industrious attention to the pub-Governor's Speech. —(Continued.) lic business, a session remarkable for the quantity of work done, is also noteworthy for its brevity.

The commercial operations of the season have commenced hopefully, the news from the sealing fleet being such as to warrant the belief that the voyage will be a profitable one. The lively satisfaction with which this news has been received has been marred by the sad disaster which occurred to the crew of the S. S. Greenland, whereby fortyeight of our fellow citizens lost their lives. Her Gracious Majesty the Queen has expressed in kindly language her sympathy with the wives and families of the sufferers-a sympathy with which thousands of her loyal subjects within and without this Colony warmly unite. Your thoughtfulness has been shown by the provision you have so promptly and properly made for the families and relatives of the deceased.

Many important measures have resulted from your deliberations. Especially valuable are the measures for defining the functions of the various departments of the Civil Service, and for conducting the financial affairs of the Colony under stricter supervision and with greater care than heretofore. The Acts with reference to these subjects must tend to win the confidence of capitalists and others outside the Colony. The approval thus won will be increased by the measures amending the "Election Act, 1889," and conferring upon the Judges of the Supreme Court a tenure of their high offices during good behaviour, subject only to removal by Her Majesty, or upon an address from both Houses of the Legislature.

The measures for granting a bounty to sailing vessels prosecuting the seal fishery, and for encouraging the clearing, cultivation and settlement of land are commendable efforts to promote industry in directions best calculated to afford remunerative employment to the people, and establish their prosperity upon a firm and enduring basis. The commissions of enquiry into the Mining and Agricultural resources of the Colony, for the expenses of which you have made provision, and the attempt to procure a market for salted herrings, which you have authorised, are also laudable efforts directed towards the improvement of the industrial condition of the people.

The Act ratifying a Contract for the operation of the railway and telegraph system of the Colony, and providing for a complete system of steam communication in connection with that railway system, and incidentally providing also for the development of the coal areas near Grand Lake, is a measure fraught with important consequences to the future of the Colony. My Ministers are confident that it will be attended with great good, both in the near and distant future, and in the hope that it will be I most heartily concur. The first instalment of the purchase money under the Contract (\$250,000) has been received, and will be disposed of as provided by the Act for that purpose.

Mr. Speaker and Gentlemen of the Honourable House of Assembly:

I thank you for the liberal supplies which you have provided for the Public Service. They shall be expended economically. A re-arrangement of the tariff of Customs and excise duties was a neces-

sity. In performing that duty your work has been Governor's Speech as thorough as circumstances would permit. The requirements of the Public Service have to be met, but it is pleasant to note that you have endeavored to do so in a manner which has materially reduced the duties upon two most important articles of consumption by the people. The changes in the tariff which you have made will have the effect of decreasing the burden which falls upon the less wealthy classes of the people, and also of encouraging industries by which many of the operative population will be afforded employment.

- Mr. President and Honourable Gentlemen of the Legislative Council:
- Mr. Speaker and Gentlemen of the Honourable House of Assembly:

The negotiations which you have authorized, for the purpose of obtaining the appointment by Her Majesty's Government of a Commission of Enquiry into certain subjects vitally affecting this Colony, will be entered upon speedily and pursued assiduously.

In these negotiations the right of self-government secured to the Colony will not in the smallest degree be imperilled, and my Ministers are confident that no thought of abating or affecting that right could or would be suggested by Her Majesty's Government. A claim for relief to the Colony will be made by my Ministers upon Her Majesty's Government, upon whose friendliness and sense of justice my Ministers confidently rely. The ancient obligations of the Kingdom were paid by Treaty concessions upon the coasts of this Colony, and to the loss thus entailed upon its people it is but just

Governor's Speech —my Ministers claim—that the Kingdom should —(Continued.) contribute.

The competition of the French, made possible by those concessions, and the operations carried on in and from St. Pierre and Miquelon, hamper and depress our trade, and the Colony calls for assistance in its battle against these conditions.

The Colony has undertaken and effectuated, at its own cost, a railway of importance to the empire, and the burden of taxation thereby imposed bears heavily upon the people, wherefore the Colony claims aid from the empire. These arguments will be impressed by my Ministers upon Her Majesty's Government.

In bidding you farewell, I desire to express to you my best wishes for your prosperity, and for that of the Colony; and I pray that the blessing of Providence may rest upon you and upon the people.
