Governor arrives at Council Chamber;

At Three o'clock, P.M., His Excellency the Govornor, Sir Henry Edward McCallum, K.C.M.G., having arrived at the Council Cham-

ber, and being seated on the Throne, the Honorable the President commanded the Gentleman Usher of the Black Rod, attendant on the Council, to proceed to the House of Assembly and inform the members thereof, that it is His Excellency's will and pleasure that they attend at the Bar of Members of Assembly this House; and they being come thereto, Law- attend Counci Chamber; rence O. B. Furlong, Esq., a member for the District of St. John's East, having been presented by the Honorable W. H. Horwood, Minister of Justice, as Speaker elect, and the choice approved and the usual privileges claimed and granted, His Excellency was pleased to open the present Session of the Legislature with the following gracious Speech to both Houses:—

Mr. Speaker elect presented and approved.

Mr. President and Honourable Gentlemen of the Governor's speech. Legislative Council:

Mr. Speaker and Gentlemen of the Honourable House of Assembly:

Since the last Session of this Legislature the Empire of which we are privileged to be a part has been called upon to mourn the loss of the beloved Sovereign who was for Sixty-four years our Queen. During a reign unprecedently long and glorious Her late Majesty Queen Victoria ever evinced a heartfelt interest in the welfare and prosperity of her subjects throughout Greater Britain, and by her wise and beneficial rule as a constitutional Sovereign, and by her own personality, did much to strengthen the ties of affection which unite the Colonies with the Motherland.

Speech— (Continued)

In no portion of this Empire has Her Majesty's death been more sincerely mourned than in her Colonial dominions, and I venture to think that in no part of these vast dominions has there been sorrow more profound than in this the oldest Colony.

You will, I feel sure, take an early opportunity of expressing your sympathy with the Royal Family in their bereavement, and your loyalty to His Majesty the King.

As you are doubtless aware, the temporary Act for giving effect to the Treaties between Great Britain and France in relation to fishery rights on a portion of the Coast of this Colony, expired on the Thirty-first day of December last. The Secretary of State for the Colonies has invited my Ministers to send a delegation to London to confer with His Majesty's Government on the subject of the Treaty Question, preparatory to the opening of negotiations by His Majesty's Government with the Government of France with a view to a final settlement of the matters in dispute between the two countries. My Ministers have complied with the invitation extended to them by His Majesty's Government, and it is to be hoped that the conference now about to take place, and the negotiations which will take place between His Majesty's Government and the Government of France, may result in a settlement of this longstanding dispute which will prove acceptable to the Legislature and the people of this Colony. In the meantime, and pending the negotiations shortly to be initiated, His Majesty's Government asks speech-Continued. your Legislature to continue the present Act for the ensuing season, and I have, upon the advice of my Ministers, summoned this session for the special purpose of submitting the matter for your immediate consideration.

I feel sure that in view of the special circumstances under which the request of His Majesty's Government is made, it will receive at your hands a gracious and willing response.

It gives me great pleasure to announce that I am in receipt of a cable message from the Right Honourable the Secretary of State for the Colonies acquainting me that His Majesty the King, who remembers with pleasure that Newfoundland was the first Colony which he visited, desires that their Royal Highnesses the Duke and Duchess of Cornwall and York should pay a brief visit to St. John's on their return voyage from Canada in the autumn. His Majesty the King is confident that their Royal Highnesses will receive a cordial welcome from his loyal people in his oldest Colony. As at present arranged, their Highnesses will arrive at St. John's on the 21st October and leave on the 24th October.

I trust that Divine Wisdom may direct you in all your counsels.

We, Your Majesty's loyal subjects, the Legislative Council and House of Assembly of Newfoundland in Session convened, respectfully beg leave to approach Your Majesty with the expression of our profound devotion and homage on your accession to the Throne.

We are moved on this occasion by feelings seemingly not in accord yet really in a natural unison. As the representatives of Your Majesty's

most ancient Colony we heartily grieve for the Address-Continued. death of our beloved Queen, under whose beneficient sway all the British Colonies have attained unwonted progress; while we cannot but rejoice that she is succeeded by a son whose mind and heart have been formed by so wise and bright an exemplar.

Her late Majesty won singular distinction as the unswerving upholder, through a long reign, of the principles of Constitutional Government, and was justly revered as the noblest type of womanhood that ever held the sceptre of Britain. She ruled her subjects with womanly affection, evincing itself in their days of joy and of sorrow by words and deeds of sympathy, amongst the humblest dwellers in the land, as well as in the ranks of the titled and high-born. And how full was their return of love, how truly their Queen reigned in their hearts, has been abundantly manifested in the grief of the whole nation for the magnitude of its loss.

In conveying to Your Majesty our warmest sympathy in the pain of your bereavement, we feel how much this must be assuaged by the memories of the great life that has closed. We fervently pray that Heaven may grant to Your Majesty a long reign, stored with blessings to yourself and to the Empire, and that your rule may be directed by the wisdom and goodness which we regard as Your Majesty's rightful inheritance.

MAY IT PLEASE YOUR EXCELLENCY:-

The Legislative Council in Session convened thank Your Excellency for the Gracious Speech with which you have been pleased to open the present Session of the Legislature. We sincerely deplore with Your Excellency Address—the death of our beloved Queen, the memory of whose long and glorious reign will be ever treasured by Her subjects throughout the Empire. As Colonists we love to recall the anxious interest evinced by Her late Majesty in the well-being of these dependencies, while we recognize how much Her endearing personality contributed to strengthen our bonds of union with the parent country. The civilized world mourns Her demise as a loss to humanity and we believe that not within the British dominions is there deeper sorrow than in the hearts of the people of Newfoundland.

In an Address from both Houses of our Legislature we have assured His Majesty the King of our sympnthy with Him and the Royal Family in their bereavement and of our loyalty to the Throne.

The subject of the renewal of the modus vivendi in relation to the Fishery rights of the French on a portion of the Newfoundland Coast, shall receive our attentive consideration. We trust that the conference of our delegate with the Imperial Government, and the negotiations between the latter and the Government of France will result in a satisfactory settlement of this long pending question.

His Majesty's visit to Newfoundland, and the fact that this was the first Colony so honored, are still and most agreeably remembered here. We gratefully appreciate His Majesty's desire that their Royal Highnesses the Duke and Duchess of

Address— Continued. Cornwall and York shall confer upon us a similar honor next October, and His Majesty may be fully confident that their Royal Highnesses will receive a glad and loyal welcome from the inhabitants of His most ancient Colony.

Governor's Reply. Mr. President and Honourable Gentlemen of the Legislative Council:

I thank you for the Address which you have presented to me and for your graceful, loving references to the irreparable loss which the Nation has sustained by the death of our beloved Queen. I feel confident that the welcome which you will give the Duke and Duchess of Cornwall and York in October next, will be of such a nature that it will form a fitting close to the Royal tour and be evidence to His Majesty the King that His visit to Newfoundland is held in grateful remembrance.

It will be a source of much gratification, not only to the Colony, but to the Nation at large, if the negotiations which are now pending with the Government of France, lead to a satisfactory solution of the long-standing vexatious questions connected with the Fishery rights of that Power.

At Three o'clock, P.M., His Excellency the Governor Sir Henry Edward McCallum, K.C.M.G., having arrived at the Council Chamber and being seated on the Throne, the Honorable the President of the Council directed the Gentleman Usher of the Black Rod to proceed to the House of Assembly and inform the Speaker and Members thereof that it is His Excellency's will and pleasure that they forthwith attend at the Bar of this House; and they being come thereto His Excellency was pleased to give his assent to the following Bill:—

After which His Excellency was pleased to deliver the following Speech:—

- Mr. President and Honourable Gentlemen of the Governor's Speech.

 Legislative Council:
- Mr. Speaker and Gentlemen of the Honourable House of Assembly:
- "The special business for which this Session of the Legislation was convened having been completed, I have much pleasure now in releasing you from further attendance.
- "It affords me much satisfaction to observe the manner in which the request of His Majesty's Government for the re-enactment of the French Treaties' Act has been complied with by your Honourable Houses, and especially does it afford me gratification that your proceedings in this mathave been marked by unanimity.
- "I feel sure that your patriotic conduct will be fully appreciated by His Majesty's Government and that it will facilitate the initiation of the contemplated negotiations with the Government of France. I earnestly hope that these negotiations may result in a settlement of the Treaties' Question favourable to this Colony.

Governor's Speech— (Continued).

"This will be the last occasion that I shall address you, as I leave the Colony next week on promotion to the Governorship of Natal. I am glad, therefore, to have this opportunity of publicly thanking my Ministers, both past and present, for their uniform support and co-operation, and Legislators generally for their courtesy and assistance when discussing with them the direction in which progress and improvement could best be made.

"Much is required still to ameliorate the social, economic, and educational condition of the community. It will be with heartfelt interest that I shall watch the measures to this end, which I trust will be introduced with the least possible delay for the wise and beneficent consideration of this Legislature; and I indulge in the hope that, under Divine Providence, they will be discussed and passed in a spirit of patriotism and unanimity. Farewell."

The Hon. the President then said :-

Prorogation.

It is His Excellency the Governor's will and pleasure that this General Assembly be prorogued until Thursday, the 28th day of March next, then and here to be holden, and this General Assembly stands prorogued accordingly.
