

At three o'clock, p.m., His Excellency the Governor, Sir Walter Edward Davidson, Knight, Commander of the most Distinguished Order of St. Michael and St. George, having arrived at the Council Chamber, and being seated on the Throne, commanded the Gentleman Usher of the Black Rod, through the Honourable the President of the Legislative Council, to let the House of Assembly know-

"It is His Excellency the Governor's pleasure they attend him immediately in this House."

Who being come thereto with their Speaker, His Excellency was pleased to speak as follows :---

Mr. President and Honourable Gentlemen of the Legislative Council:

Mr. Speaker and Gentlemen of the Honourable House of Assembly :

Since the last Session of the Legislature the terrible struggle between the warring nations of Europe has continued to rage with unabated violence. The splendid traditions of the fighting forces of the Empire have been admirably upheld, and in conjunction with our Allies substantial progress has been made towards achieving the result which is inspiring us all, the conclusion of a peace that will preserve the liberties of the world and the advancement of the nations along the pathways of enlightened civilization.

The contingents from this country for military and naval service have, I am proud to say, conducted themselves with such gallantry and devotion to duty as to have won the highest praise from the responsible authorities, and the enthusiastic response made during the past year to the appeals for further recruits is, I am glad to say, likely to be continued on a similar scale during the present year.

At the beginning it was hoped and expected that the war would be short and the end attained without exceptional demands upon the manhood or resources of the Mother Country and the Oversea Dominions. Instead of that, however, the conflict is proving one which threatens the very existence of the British Empire and of the nations associated with her in the effort to maintain civil liberty and the rights of free states. Unexampled calls have been made on the Mother Land and the other portions of the Empire, and they have been nobly met. A measure of compulsory enlistment has been enforced in the British Isles. Canada, Australia, New Zealand and South Africa have undertaken obligations proportionately great; and I have every confidence in the new invitation now being addressed to the young men of the Colony to do their part in the fighting line, and to the rest of our people to recognize what is required from those who remain at home, that there will be a response that will keep Newfoundland where she was at the outset, in the very first rank in proportion to her population and resources.

In view of the growing seriousness of the tonnage problem to the Colony as evidenced by some of its phases at present, measures will be introduced to invest my Ministers with further powers to enable them to deal with this matter in the general interests of the Colony.

The industrial operations of our people during the past year have been attended with highly satisfactory results. The high prices obtained for the staple products of the fisheries, forests and mines have enabled the working classes to enjoy a high degree of prosperity. This is all the more gratifying when we remember how the economic interests of every country have been disturbed by the farreaching effects of the War, and we have surely

cause for thankfulness that here in Newfoundland we have suffered so little.

One of the lessons which this War has taught the peoples of the British Empire is the desirability of promoting inter-Imperial trade, and we may not unreasonably hope that one of the results will be a very great increase in the demands for the products of our fisheries, and that the development of our forest and mineral resources will be even more actively undertaken than heretofore.

Bills will be submitted to you for the consolidation of the laws of the Colony, a work last undertaken twenty-five years ago; for bringing up to date the Education Law; for bringing the law with regard to Weights and Measures into con-

formity with the standards existing in other countries; and to provide for the Municipal Government of the town of St. John's, as well as other measures.

Mr. Speaker and Gentlemen of the Honourable House of Assembly:

The accounts for the past fiscal year, and the Estimates for the coming one will be submitted to you in due course, and I am sure that you will make suitable provision for the requirements of the Public Service, with special reference to the increased obligations which the War will impose on the Colony.

You will be glad to know that there is a very substantial increase in the revenue from all sources, encouraging the hope that at the end of the fiscal year in June next our receipts will suffice to meet the expenditure on current account. It is now apparent that the decrease in revenue for the last fiscal year of \$720,000 was largely due to the reduction in imports, consequent on the uncertainties as to trade development during the first year of the War; but we may reasonably assume, seeing there has been such a marked recovery the present year, that there is no longer any reason to fear a return to the condition of twelve months ago. On the contrary we may hope, as the months pass and the outlook for the Allied cause grows brighter, that this condition will reflect itself in still larger imports and more enhanced prosperity.

Mr. President and Honourable Gentlemen of the Legislative Council :

Mr. Speaker and Gentlemen of the Honourable House of Assembly:

In accordance with the Act passed at the last Session of the Legislature providing for the submission to the electors of the Colony of the question of the prohibition of the importation, manufacture and sale of alcoholic liquors, an election was held in November last resulting in the number of votes polled in the affirmative being a majority of the total number of votes cast and amounting to over forty per cent. of the total number of votes on the register as required under the Statute. Under these circumstances a Proclamation called for by the Statute will issue at an early date, prohibiting the importation, manufacture and sale of intoxicating liquors into or in this Colony at any time after the first day of January, 1917, except as provided for in the said Act.

I commend the duties of the Session to your assiduous care, and pray that the guidance of Divine Providence may attend you. The sentiments of profound loyalty expressed by the Colony and the practical manifestations of patriotism which have supported the same since the beginning of the War will, I feel sure, stimulate you all to the zealous performance of the Session's tasks.

Then the House of Assembly withdrew,

The deceased gentleman, as a member of this Chamber, evinced marked ability and financial acumen in the discussion of all matters of public interest, and whilst holding the highly important position of President of the Legislative Council, at all times displayed dignity, impartiality and sound judgment in the duties of his office.

Resolved,---That a copy of this Resolution be transmitted to the family of the late Honourable John Harris, expressing the sympathy of the Council with them in their great bereavement.

Section 3. After the word "dark," in the third line, strike out the words, "or at any other time when the state of the weather is such as to endanger life and limb."

Section 5. In the sixth line, after the word "death," insert, "within twelve months thereafter."

Section 6. Add, "unless in his opinion the state of the weather is such as may endanger life and limb, under a penalty not exceeding one thou-

sand dollars, to be recovered in a summary manner by any person who shall sue for the same: Provided that the Magistrate or Justice imposing such penalty may, in addition, suspend the certificate of competency held by such officer under this Act for such period as he may deem proper."

Section 7. In the second line strike out, "an adequate supply of fire-rockets of a class to," and substitute therefor, "a supply of fire-rockets of such class and in such quantity as may."

Section 8. In the first line, after the word "ship," insert, "without lawful excuse."

In the third line, after the word "shall," in-

sert, "unless he has positive and trustworthy information that such sealer is safe on board some other ship."

In the ninth line, after the word "intervals," insert, "during the hours of darkness, unless the weather is such as to prevent such rockets from being visible from the ice."

Section 9. In the fourth line, strike out the word "shall," and substitute therefor, "may in his discretion."

Section 13. Strike out the whole section and substitute the following:

13 (a). No steel ship shall be cleared for the seal fishery from any port in the island of New-foundland until forty-eight hours after the time fixed for the sailing of the wooden ships. Steel

ships under eight hundred and fifty tons gross, shall, for the purpose of this section, be considered as wooden ships.

(b). It shall be unlawful for any ship to bring into any port in this Colony, in any one seal-fishing season, more than thirty-five thousand seals, or more than a gross weight in seal pelts of seven hundred tons; and any surplus above the limits hereinbefore provided shall be confiscated by the Minister of Marine and Fisheries and sold, and the proceeds thereof shall be paid over to the Marine Disasters Fund.

(c). It shall be lawful for the Minister of Marine and Fisheries to cause all ships to be surveyed, and a special load line marked thereon for the purposes of the seal fishery, and no ship shall be loaded below the load line so fixed, under a penalty not exceeding two thousand five hundred dollars, to be recovered from the master of such ship in a summary manner, in an action in the name of the Minister of Marine and Fisheries, whose duty it shall be to see to the enforcement of this section. Any penalty recovered under this section shall be paid over to the Marine Disasters Fund.

Section 14. Strike out sub-section (a), and substitute the following:

(a). No owner of a ship shall put on board or authorize the putting on board said ship of more than two guns, under a penalty not exceeding one thousand dollars, to be recovered from such owner

in a summary manner by any person who shall sue for the same : and any person who shall bring or put on board such ship any gun or guns shall be subject to a similar penalty.

In sub-section (b), fourth line, strike out the word "owner" and substitute "master."

Section 16. Strike out the whole section.

Section 18. In the sixth line, after the words "Master Watch," insert, "which rules and regulations shall be approved by the Governor in Council."

Section 19. Add the following as sub-sections (f) and (g):

(f). Where a sealer has given notice under section 20 of this Act, he shall, if so required by the owner of the ship submit himself for examination by a duly qualified medical practitioner, provided and paid by such owner; and if he refuses to submit himself to such examination, or in any way obstructs the same, his right to compensation and to take or prosecute any proceedings under this Act in relation to compensation, shall be suspended until such examination has taken place.

(g). Any sealer receiving weekly payments under this Act shall, if so required by the owner of the ship, from time to time submit himself for examination by a duly qualified medical practitioner, provided and paid by such owner. If the sealer refuses to submit himself to such examination, or in any way obstructs the same, his right

to such weekly payments shall be suspended until such examination has taken place.

Section 21. In the seventh line strike out the figures "20," and substitute therefor "19."

Section 23. Strike out the whole section and substitute the following :

23. The Second Hand and Master Watches of any ship shall have the right to dispose of the crew's share of seals brought in by any such ship. No agreement for the sale of such seals made prior to the arrival of the ship in port at the end of her voyage shall be binding on either party. Any agreement made by the Second Hand or Master Watches under this section, shall be in writing, and shall be irrevocable after the ship has begun discharging her seals.

After section 23 insert the following as a new section 24, and renumber sections 24, 25 and 26, as 25, 26 and 27, respectively:

24. No person shall be liable to any penalty or forfeiture provided by this Act unless some prosecution, action, or suit in respect of the offence committed, shall be commenced against such person within the space of six months after the commission of such offence. All penalties by this Act provided, may be recovered in a summary manner before a Stipendiary Magistrate or a Justice.

Section 24 (renumbered 25). In the first and second lines strike out "one hundred," and substitute "fifty."

Section 25 (renumbered 26). Strike out the section and substitute the following:




