At 12 o'clock p.m. the Honourable Sir Patrick T. McGrath, Knight Commander of the Order of the British Empire, President of the Legislative Council, the Honourable Robert K. The Honourable Sir Patrick T. McGrath, K.B.E., President of the Legislative Council, addressing both Houses of the Legislature then said:

Honourable Gentlemen of the Legislative Council: Gentlemen of the Honourable House of Assembly:

It is not convenient for His Excellency the Governor to declare the reasons of his calling this General Assembly on this day and it being necessary that a Speaker of the House of Assembly should be first chosen. You Gentlemen of the House of Assembly repair to the place where you are to sit and there proceed to the appointment of some proper person to be your Speaker and present such person whom you shall so choose this day at three o'clock for His Excellency's approbation.

The House of Assembly then withdrew.

The House was adjourned during pleasure.

After some time the House was resumed.

At three o'clock p.m. His Excellency the Governor Sir Charles Alexander Harris, Knight Commander of the Most Distinguished Order of St. Michael and St. George, Companion of the

Bath, Commander of the Royal Victorian Order, having arrived at the Council Chamber, and being seated on the Throne commanded the Gentleman Usher of the Black Rod through the Honourable President of the Legislative Council to let the House of Assembly know:

"It is His Excellency the Governor's pleasure that they attend him immediately in this House."

Who being come thereto, William J. Higgins, Esquire, a Member for the District of St. John's East, having presented himself as Speaker-Elect and the choice approved, His Excellency the Governor was pleased to speak as follows:

- Mr. President and Honourable Gentlemen of the Legislative Council:
- Mr. Speaker and Gentlemen of the Honourable House of Assembly:

On this, the first occasion of meeting you in session, I believe that you would wish me to refer to the recent more complete recognition of the status of Newfoundland as one of His Majesty's self-governing Doimnions. I on my part am anxious to assure you that the welfare of this oldest and most loyal dependency of the Crown will be the daily object of my thoughts and solicitude.

The fisheries of the country have been conducted with more than the ordinary measure of success during the past year, and, thanks to the exertions of the Tonnage Committee, and to improved

markets, the returns for the products exported have shown a marked improvement over past years.

This gratifying improvement has in turn resulted in an increase of imports so that the value of our total trade has increased from thirty-five million three hundred and ninety-six thousand eight hundred and twenty-nine dollars to forty-trhee million seven hundred thousand and seventy-two dollars for the twelve months ending June 30th, 1917.

The Seal Fishery, which has just closed, was successful, and has proved especially remunerative to the men engaged therein.

The outlook for the coming Codfishery is most encouraging. Every energy will, however, have to be bent to the purpose of securing sufficient tonnage to market the catch and ensure that those engaged shall obtain the full fruits of their activities.

The prospect of an insufficient supply of salt for the fisheries is causing my Ministers serious concern. Both the material and the tonnage to carry it are difficult to obtain, but prospects appear to be improving and it is hoped that the conjoint efforts of the Salt Committee and the Ministry of Shipping will avert any serious shortage.

On Sunday, February the 24th last, the appalling disaster of the loss of the S.S. Florizel brought sorrow and desolation into many homes in the Dominion. Especially did the business section of the Capital City suffer the loss of some of the most prominent and successful members of the com-

mercial body. The tragedy was accentuated by the helplessness of the onlookers who, on the Sunday, could do nothing in the boiling seas to save life, but the heroic work of the rescuers on the following day formed a record of which Newfoundland can forever be proud. Of one-hundred and thirtyseven passengers and crew only forty-four were rescued. It is a comfort and consolation to the bereaved relatives that most of the bodies of the lost have been recovered from the sea and restored to their loved ones for Christian burial. The loss of the ship, moreover, in view of the great scarcity of tonnage, is a serious blow to the trade of the country. My Ministers, without delay, appointed a Marine Court which is instituting a most searching enquiry into the causes of the wreck.

Mr. Speaker and Gentlemen of the Honourable House of Assembly:

The Revenue for the last financial year showed a substantial increase over the Expenditure, and the Surplus resulting was largely applied to the War expenditure of the Dominion. Another large Surplus is anticipated for the fiscal year shortly to terminate.

The Estimates for the several departments of the Public Service will be laid before you in due course and will, I am sure, receive your most favourable consideration, as they have been framed with due regard to economy and the exigencies of the extra-ordinary situation with which we are now confronted. Your consideration will also be invited to the question of devising means for the raising of a Loan locally for War purposes.

- Mr. President and Honourable Gentlemen of the Legislative Council:
- Mr. Speaker and Gentlemen of the Honourable House of Assembly:

Since the last session of the Legislature the titanic struggle raging in Europe, in which Great Britain and her Allies are engaged, has shown no sign of diminishing, but on the contrary has assumed even vaster proportions and more menacing aspects. The lamentable breakdown of Russia as an effective belligerent in the Entente cause, which enabled the enemy to release vast armies from the eastern front and hurl them against the Allied line in France, has brought about a crisis in the great struggle which cannot but cause the gravest anxiety. In this hour of destiny, fraught with the most momentous issues for the British Empire and the world, Newfoundland is called upon, in common with the Mother Country and the other oversea Dominions, to make further sacrifices in order to avert disaster. The Imperial War Council is calling on all portions of the Empire for additional men to aid in winning the War. "Men! Men! Men!" is the cry of the Prime Minister of the Home Land. This cry is echoed by the members of the Newfoundland Regiment, whose valour has won approbation from His Majesty the King in the bestowal of the honourable prefix "ROYAL" to the Regiment. Confronted with these urgent appeals for assistance, Newfoundland must and will do her full duty.

Your immediate consideration will be asked to the need of enrolling men to replenish the ranks of the Royal Newfoundland Regiment by Selective Conscription, and a measure designed to accomplish that object will be laid before you without delay.

Varied and perplexing problems having arisen in connection with the social, commercial and industrial activities of the country as a result of the extraordinary conditions brought about by the operations of War, a union of political parties was arranged in July last, in order that the undivided strength of the community might be devoted to grappling with these difficulties and carrying on the public affairs. Committees to deal with the matters of procuring Tonnage and Salt were appointed, and also a Board of Food Control. These problems are becoming daily more pressing and accentuated and there is urgent need for united effort, undistracted by political turmoil, in order to cope with them. To ensure this aim a measure to extend the term of the present General Assembly will be submitted for your consideration.

The undying gratitude of the country is due to those who have given their loved ones to the cause of Empire in the great crusade now being waged against the hosts of tyranny and oppression. Our condolences go out to those whose sons have made the Supreme Sacrifice in defending their Empire and their native land, those "Martyrs in the cause of Liberty" who have died that others might live, and the memory of whose deeds will form an imperishable page in the history of this country for all time. To these men we all owe it that they shall not be found to have died in vain.

Our sympathy is also with those who have fought the good fight valiantly and well and who have returned to their homes unfit for further active service, bearing honourable scars sustained in action, mute testimonies to their courage and devotion to duty.

The Government recognizes the duty of the community to see that these men are enabled in their future life to overcome as far as possible the disabilities which their bravery and self-sacrifice have inflicted upon them and they are already actively considering the matter.

Despite the trials and tribulations engendered by the Great War, Newfoundland has been especially blessed by Divine Providence. To the God of Battles I commend your efforts and sacrifices, I pray that He may inspire you with a high sense of duty in your deliberations, and protect our beloved country and our common Empire through the perilous ways through which we are now passing, till we arrive at a complete and enduring peace.

The House then withdrew.

His Excellency the Governor then retired.

The Honourable the President reported His Excellency's Speech and the same was read by the Clerk.

On motion of the Honourable Mr. Ellis the following Resolutions were unanimously passed:

Resolved: That this House desires to record its sense of the loss sustained by it through the decease of the Honourable James Ryan who for the past few years occupied a seat in this Council and was a valuable acquisition to the Chamber because of his wide knowledge of the Country's affairs.

Resolved: Further that a copy of the foregoing Resolution be sent to Mrs. Ryan with an expression of the sympathy of the Council with her and the family of their late brother Member on the loss they have sustained.

On motion of the Honourable Mr. Harvey, seconded by the Honourable Mr. Bishop, the following Resolution was unanimously passed:

Resolved: That this House records its pleasure and hereby tenders its heartiest congratulations to its President The Hon. Sir. P. T. McGrath upon the well deserved honour recently conferred upon him by our Most Gracious Sovereign through his appointment to the rank of Knight Commander of the Order of the British Empire.

Ordered,—That a Select Committee be appointed to draft an Address to the Governor in Reply to His Excellency's Speech at the opening of the present Session of the Legislature.

Ordered,—That the Honourables Messrs. Mews, McNamara, Anderson, Cook and Bell be a Committee for that purpose.

The Hon. Mr. Anderson brought in a Bill "Respecting Certain Changes in the Hours of the Day and Night," which was received and read a first time, and

Ordered,—To be read a second time to-mor-row.

The Hon. Mr. Anderson gives notice that he will on to-morrow move the suspension of the 33rd Rule of this House with regard to the Bill "Respecting Certain Changes in the Hours of the Day and Night" and amendments and all things incidental thereto.

The Hon. Mr. Gibbs gives notice that he will on to-morrow ask the Hon. Leader of the Government:

(1) What negotiations took place between the Italian Government and the British Government or representatives of the Italian and the British Governments on the one hand and the Governor of Newfoundland or the Executive Council of this Dominion or any member or Committee thereof on the other hand in relation to the export of codfish

from this Dominion to Italy during the autumn of 1917.

- (2) Whether the steamer Rutenjfel under charter at that time to take fish for "The Charterers Limited" from this country to Italy was upon the advice of the Tonnage Committee of the Executive Council commandeered by the Government to take codfish to Italy.
- (3) If codfish was purchased in this country for the Italian Government, directly or indirectly or through agents during the autumn of 1917, or at any time during the year 1917, if so by whom and in what quantity.
- (4) What price did the Italian Government agree to pay for such codfish and what price was actually paid?
- (5) If any codfish was purchased during the year 1917 on account of or for the Italian Government in this country? If so what was the price paid therefor?
- (6) To lay upon the Table of the House copies of all telegrams, correspondence or other documents relating to all or any of the above matters.

The Hon. Mr. Gibbs gives notice that he will on to-morrow ask the Hon. the Leader of the Government to lay upon the Table of the House all correspondence or documents in relation to the request of the British Government that the produce of the seal fishery of 1918 or any portion thereof be reserved for the use of the British Government.

The Hon. Mr. Gibbs gives notice that he will on to-morrow ask the Hon. the Leader of the Government whether any negotiations have been carried on in the United States, Canada or elsewhere since January 1st, 1918, in relation to the raising of a loan on the credit of the Dominion, whether any loan has been raised, the amount, terms and conditions of same.

Council commandeered by the Government to take codfish to Italy.

- (3) If codfish was purchased in this country for the Italian Government, directly or indirectly or through agents during the autumn of 1917, or at any time during the year 1917, if so by whom and in what quantity?
- (4) What price did the Italian Government agree to pay for such codfish and what prices was actually paid?
- (5) If any codfish was purchased during the year 1917 on account of or for the Italian Government in this country? If so, what was the price paid therefor.
- (6) To lay upon the Table of the House copies of all telegrams, correspondence or other documents relating to all or any of the above matters.

The Hon. Mr. Ellis replied.

A BILL.

AN ACT RESPECTING MILITARY SERVICE.

Whereas to maintain and support the Royal Newfoundland Regiment now engaged in active service overseas for the defence and security of Newfoundland, the preservation of the Empire and of human liberty, it is necessary to provide reinforcements for the Regiment;

AND WHEREAS enough men do not volunteer to provide such reinforcements;

AND WHEREAS it is expedient to secure the men by Selective Draft

- BE IT THEREFORE ENACTED by the Governor, the Legislative Council, and the House of Assembly, in Legislative Session convened, as follows:—
- 1.—This Act may be cited as the "Military Service Act, 1918."
- 2.—In this Act, unless the context otherwise requires,
- "Certificate" means a certificate of exemption from military service under this Act;
- "The Army Act" means the ARMY ACT for the time being in force in the United Kingdom and all regulations and orders made under the authority thereof;
- "Regulations" means regulations made by the Governor-in-Council under the authority of this Act and directions made under such regulations.

"Minister" means Minister of Justice.

"Tribunal" means the Tribunal constituted under this Act.

"Unmarried Men" shall include any man married after April 10th, 1918, and any widower with no child.

"Regiment" means the Royal Newfoundland Regiment.

- (1) Every unmarried male British subject who comes within one of the classes described in section three of this Act, and who:
 - (a) Is ordinarily resident in Newfoundland, or
 - (b) has been at any time since the fourth day of August, 1914, resident in Newfoundland,

shall be liable to be called out as hereinafter provided on active service in the Regiment, either in or beyond Newfoundland, unless he:—

- (a) Comes within the exceptions set out in the schedule, or
 - (b) Reaches the age of forty before the class or sub-class to which he belongs, as described in section three is called out.

Such serivce shall be for the duration of the present war and of demobilization after the conclusion of the war.

- (2) Nothing in this Act shall prevent any man from voluntarily enlisting in the Regiment so long as voluntary enlistment in such Regiment is authorized; or in the Royal Naval Reserve.
- 3.—(1) The men who are liable to be called out shall consist of four classes as follows:—

- Class 1: Those who have attained the age of nineteen years and were born not earlier than the year 1894.
- Class 2: Those who were born in the years 1889 to 1893 both inclusive.
- Class 3: Those who were born in the years 1884 to 1888 both inclusive.
- Class 4: Those who were born in the years 1879 to 1883 both inclusive.
- (2) Any class, except Class 1, shall include men who are transferred thereto from another class as hereinafter provided, and men who have come within Class 1 since the previous class was called out.
- (3) The order in which the classes are described in this section shall be the order in which they may be called out on active service, provided the Governor-in-Council may divide any class into subclasses, in which case the subclasses shall be called out in order of age beginning with the youngest.
- 4.—(1) The Governor-in-Council may from time to time by proclamation call out on active service as aforesaid, either in Newfoundland or beyond Newfoundland, any class or subclass of men described in section three, and all men within the class or subclass so called out shall, from the date of such proclamation, be deemed to be soldiers en-

listed in the Military Forces of Newfoundland and subject to military law for the duration of the present war, and of demobilization thereafter, save as hereinafter provided.

- (2) Men so called out shall report, and shall be placed on active service in the Regiment as may be set out in such proclamation or in regulations, but until so placed on active service shall be deemed to be on leave of absence without pay.
- (3) Any man by or in respect of whom an application for exemption is made as hereinafter provided, shall so long as such application is pending and during the currency of any exemption granted him, be deemed to be on leave of absence without pay.
- (4) Any man who is called out and who without reasonable excuse fails to report as aforesaid, shall be guilty of an offence and shall be liable on summary conviction to imprisonment for any term not exceeding five years with hard labor.
- 5.—(1) A Tribunal shall be established to hear and determine all applications for exemption from service and all other questions or matters arising out of or in connection with the enforcement and operation of this Act and of the provisions and schedule thereof.
- (2) The Tribunal shall be a Court of Record and shall be composed of the Chief Justice and the other two Judges of the Supreme Court—herein called members.

- (3) The Tribunal may be held by one or more member, or members who may exercise all or any part of the powers, functions and jurisdiction by this Act vested in the Tribunal. In all such cases a member so sitting shall be deemed to constitute the Tribunal and any two or more members may sit separately as such Tribunal at the same time, and the rising or adjournment of any one or more of them shall not affect the sitting of the other or others. The Tribunal shall be held to be constituted notwithstanding a vacancy in its membership.
- (4) In case of urgency arising from the absence, illness or a vacancy in the office of any member, it shall be lawful for another member to sit either alone or with a second member for the first named member and to hear and dispose of any application for exemption, matter or question by the first named member partly heard and to use the evidence which may have been taken by or before the first named member.
- (5) All applications for exemption questions and matters shall be heard in public unless the Tribunal in any particular case, due regard being given to the interests of the parties and any other person concerned therein, consider an application matter or question or any part of the proceedings should be heard in private.
- (6) The Tribunal shall have all the same powers as to the summoning and compelling the attendance and examination of witnesses and also as

to process and punishment for contempt as the Supreme Court now has.

- (7) Every determination of a member sitting apart may be reviewed, varied or set aside by the Tribunal constituted by any two, or by the three members, subject in cases in which two only sitting differ in opinion to rehearing and determination before the three members.
- (8) The determination of the Tribunal when constituted of more than one member shall be that of the majority and shall be pronounced by one member only, and such determination shall be final and binding for all purposes whatsoever except that the Tribunal may, upon being satisfied that there are sufficient reasons for doing so rehear and review the same.
- (9) The Tribunal or any two of its members may make rules with respect to its sittings and procedure and define the duties of the Clerk.
- (10) For the purpose of ascertaining the facts relevant to its decision of any application matter or question the Tribunal may hear such witnesses and admit such evidence as it may in its discretion think fit.
- (11) In cases in which it is inconvenient to take evidence before the Tribunal it may in its discretion appoint a commissioner at any place to examine witnesses upon oath, and such commissioner shall have power to summon and compel the at-

ready benefit to the onizing to

tendance before him of such witnesses to find upon any question of fact submitted to him by the Tribunal. The examination of witnesses before any such commissioner shall be taken in public. The Commissioner shall report to the Tribunal the evidence so taken before him and his findings upon any question of fact submitted to him.

- (12) In so far as provision is not otherwise made the procedure of the Tribunal shall be such as is determined by the Tribunal.
- 6.—(1) No member of the Tribunal shall be responsible at law for anything done by him in good faith in the performance of his duties under this Act, and no action shall be taken against any member of the Tribunal in respect to the performance or non-performance of his duties under this Act.
- (2) No proceeding authorized or pending before the Tribunal, and no decision of the Tribunal, shall by means of injunction, prohibition, mandamus, certiorari, habeas corpus, or other process, whether of the like kind or otherwise issuing out of any court, be enjoined, restrained, stayed, removed or subjected to review or consideration upon any ground whether arising out of alleged absence of jurisdiction in the Tribunal, nullity, defect or irregularity of proceedings, or any cause whatsoever nor shall any such decision or proceeding be questioned, reviewed or considered collaterally in any action or proceeding, civil or criminal.

(7) A Clerk of the Tribunal may be appointed by the Governor-in-Council, and it shall be his duty, regularly and without delay, to transmit to the Registrar a copy of the records.

EXEMPTIONS.

- 8.—(1) At any time before a date to be fixed in the proclamation mentioned in section four, or within such further time, if any, as may be permitted by the Tribunal, an application may be made by or in respect of any man in the class or subclass called out by such Proclamation, to the Tribunal for a certificate of exemption, on any of the following grounds:—
 - (a) That it is expedient in the national interest that the man should, instead of being employed in military service, be engaged otherwise.
 - (b) That he has one or two brothers, and one of them is serving, or has served in His Majesty's Noval or Military forces during the present war.
- (c) That he has three or more brothers, and two of them are serving or have served in His Majesty's Naval or Military forces during the present war.
 - (d) That he has persons mainly dependent upon him for support, such as parents, brothers or sisters.
 - (e) Ill health or infirmity.

And if any of the grounds of such application be established, a certificate of exemption shall be granted to such man.

- (2)—(a) A certificate may be conditional as to time or otherwise.
- (b) A certificate may transfer a man to the class next in numerical order.
- (c) When a conditional certificate is granted the conditions shall be stated on the certificate.
 - (d) It shall be the duty of any man holding a conditional certificate within three days after the conditions stated therein cease to exist, or after his exemption terminates, to give notice in writing of such fact to the Registrar; and if he fails without reasonable excuse to do so, he shall be guilty of an offence and liable on summary conviction to a penalty not exceeding two hundred and fifty dollars.
- (3) Subject to such conditions as to application and notice as may be provided by regulations, a certificate may, during the currency thereof, be renewed, varied or withdrawn by the Tribunal.
- (4 Any person who, for the purpose of obtaining a certificate or a condition in a certificate for himself or for any other person, or for the pur-

pose of obtaining the renewal, variation or withdrawal of a certificate, makes any false statement or representation, shall be guilty of an offence under the Act 61, Victoria, (1898) Chapter 40, entitled "An Act Respecting Perjury."

- (5) Any person who alters or tampers with a certificate; or for the purpose of evading this Act, falsely represents himself to be a person to whom a certificate has been granted; or, if granted a certificate, allows, for like purposes, any other person to have possession thereof, shall be guilty of an offence and liable on summary conviction to imprisonment for any term not exceeding six months.
- (6) When a certificate is lost, destroyed or defaced, the Tribunal shall, upon the application of the man to whom it was granted, and upon payment of a fee of fifty cents, issue to him a duplicate of such certificate.

REGULATIONS.

- 9.—The Governor-in-Council may make regulations to secure the full, effective and expeditious operation and enforcement of this Act, and, in particular, but not to limit the generality of the foregoing, may:—
 - (1)—(a) Appoint a Registrar under this Act and define his duties and fix his remuneration.

- (f) Prescribe penalties for peace officers or other officers appointed under the authority of this Act, who are convicted of neglect or refusal to perform duty without reasonable excuse.
- (2) All proclamations and regulations shall be published forthwith in the ROYAL GAZETTE and in such other manner, if any, as the Governor-in-Council may think necessary to ensure knowledge thereof by all persons concerned, and shall forthwith be laid before the Legislature if then in session, and if not in session, within ten days after the next meeting thereof.
- (3) All regulations shall have the same force and effect as if they formed part of this Act.

GENERAL PROVISIONS.

- 10.—(1) The Volunteer Acts 1914-17, the Militia Act 1917, the Army Act and the King's Regulations and Orders for the Army, shall, so far as not inconsistent herewith, apply to and form part of this Act.
- (2) Nothing in this Act contained shall be held to limit or affect the punishment provided by any Act or law for the offence of assisting the enemy or the powers of the Governor-in-Council under the War Measures Acts 1914-16.
- 11.—If in any prosecution under this Act any question shall arise in respect of the matters hereinafter mentioned, the burden of proof shall be upon the person charged to establish by satisfactory evidence:—
- (a) That he does not come within any specified class called out;
 - (b) That he has duly reported in accordance with section four;
 - (c) That he comes within any of the exceptions set out in the schedule hereto;
 - (d) That he has been duly exempted under section eight. And in the absence of such evidence the contrary shall be conclusively presumed.
- 12.—(1) Every man within the classes described in section three shall, after his class or sub-

class is required to report, as provided in section four, whenever required by a peace officer or by any person who has authority for the purpose, produce his certificate if he has one, and shall answer truthfully all enquiries bearing on the question of his compliance or non-compliance with any provisions of this Act.

- (2) Any such man who fails to comply with this section shall, in respect of each failure, be guilty of an offence, and liable on summary conviction to a penalty not exceeding one hundred dollars or to imprisonment for a term not exceeding one year.
- 13.—(1) Any person who comes within any of the classes set out in section three, and who contravenes any of the provisions of this Act or of regulations for which contravention no other penalty is herein provided, shall be guilty of an offence, and shall be liable upon summary conviction to a penalty of not less than ten dollars nor more than five hundred dollars, or to imprisonment for a term not exceeding twelve months, or to both fine and imprisonment.
- (2) Any person who by means of any written or printed communication, publication or article, or by any oral communication, or by any public speech or utterance:
 - (a) Advises or urges that men described in section three shall contravene this Act or regulations; or

- (b) Wilfully resists or impedes, or attempts wilfully to resist or impede, or persuades or induces or attempts to persuade or induce any person or class of persons to resist or impede the operation or enforcement of this Act; or
- (c) For the purpose of resisting or impeding the enforcement or operation of this Act, persuades or induces or attempts to persuade or induce any person or class of persons to refrain from making applications for Certificates of Exemption or submitting evidence in respect thereof; shall be guilty of an offence, and shall be liable upon indictment or upon summary conviction to imprisonment for a term not less than one year nor more than five years.
- (3) Any newspaper, book, periodical, pamphlet or printed publication containing matter prohibited by sub-section two of this section may, whether the printer or publisher thereof be previously convicted or not, be summarily suppressed and further printing or publication thereof and of any further issue of a newspaper or periodical which has contained such matter may be prohibited for any term not exceeding the duration of the present war. Provided no action shall be taken under this sub-section or under sub-section two of this section without the approval of the Minister.

- (4) No conviction in a court of criminal jurisdiction for an offence against this Act, or the regulations made thereunder, shall be had, unless the prosecution has been consented to or approved by the Minister.
- 14.—All expenditure under or for the purpose of this Act shall be paid out of such moneys as may be raised for the purposes of the war.

SCHEDULE.

EXCEPTIONS.

- 1.—Men who hold a certificate granted under this Act and in force.
- 2.—Members of His Majesty's regular, or reserve, or auxiliary forces, as defined by the Army Act.
- 3.—Members of the Military forces raised by the Governments of any of His Majesty's other Dominions, or by the Government of India.
- 4.—Men serving in ROYAL NAVY, or in the ROYAL MARINES, or in the NEWFOUND-LAND ROYAL NAVAL RESERVE, and members of the ROYAL NEWFOUNDLAND REGIMENT.
- 5.—Men who have, since August 4th, 1914, served in the military or naval forces of Great Britain or her Allies in any theatre of actual war and have been honourably discharged therefrom.

6.—Clergy, including members of any recognized order of an exclusively religious character, and ministers of all religious denominations existing in Newfoundland at the date of the passing of this Act.

The provision which you have made for the raising of a loan locally for war purposes, displays a confidence in the practical patriotism of our people which I am certain will be fully justified.

Mr. Speaker and Gentlemen of the Honourable House of Assembly:

I thank you for the liberal nature of the supplies which you have provided for the Public Service. The appropriations will be expended with due regard to obtaining the fullest returns to the public.

- Mr. Speaker and Gentlemen of the Honourable House of Assembly:

I sincerely trust that the fishery operations of our people, in which they are now about to engage, will be attended with the fullest measure of success, and that it will be found possible to arrange for the profitable marketing of the catch.

In taking leave of you I would express the hope that Divine Providence may bless and prosper you and our common country, and that the terrible struggle in which we, in common with the Mother Country and her Allies, are participating may be brought to an early and victorious conclusion.

It is His Excellency the Governor's Will and Pleasure that this General Assembly stand prorogaed until Monday, the 30th day of September next, then and here to be holden and this General Assembly stands prorogued accordingly.
