Journal and Proceedings

OF THE

SECOND SESSION

OF THE

Twenty-Third General Assembly of Newfoundland

Begun and holden at St. John's in the said Island on Wednesday, the Second day of September, Anno Domini Nineteen Hundred and Fourteen, being in the Fifth year of the reign of His Majesty Our Sovereign Lord George, by the Grace of God, of the United Kingdom of Great Britain and Ireland and of the British Dominions beyond the seas, King, Defender of the Faith, Emperor of India.

Wednesday, September 2nd, 1914.

The General Assembly having, by several Proclamations of His Excellency the Governor, which Proclamations are hereto prefixed, been prorogued until this day, the members thereof met in the Assembly Room.

At three of the clock in the afternoon a message from His Excellency the Governor was delivered by the Gentleman Usher of the Black Rod, commanding the immediate attention of Mr. Speaker and the House in the Council Chamber.

Then Mr. Speaker and the House attended His Excellency in the Council Chamber:

And, being returned to the Assembly Room, Mr. Speaker informed the House that, when in attendance on His Excellency in the Council Chamber, His Excellency had been pleased to make a speech to both branches of the Legislature, of which, for greater accuracy, he had procured a copy, which he read to the House.

Mr. President and Honourable Gentlemen of the Legislative Council:

Mr. Speaker and Gentlemen of the Honourable House of Assembly:

You are called together today under circumstances of an unparalleled character. The European war, in which the Mother Country found herself compelled to engage, has occasioned such conditions that all the Oversea Dominions have felt it a pride and a privilege to tender her their moral and material support. My Ministers promptly made undertakings on behalf of this Colony for which you will be invited to provide. Other measures designed to cope with exceptional circumstances, which may arise during the course of the war, will be submitted to your consideration.

Since last we met the Colony has suffered from an appalling catastrophe, whereby some two hundred and fifty of our people lost their lives the past spring at the seal fishery. The disaster, almost unexampled in our annals, brought sorrow and desolation to many a fishing hamlet and deprived scores of homes of their breadwinners. While deploring this tragic incident, we have, however, cause for gratitude. Thanks to the magnificent generosity of our own people and sympathetic friends abroad, the funds for the relief of the sufferers reached so substantial a figure as to assure all, for many years to come, of very liberal assistance.

My Ministers avail themselves of the opportunity afforded by this extraordinary Session to submit to you a measure providing for the creation of a tribunal to enquire into the circumstances surrounding this loss of life and to suggest such remedial measures as may be deemed desirable. A Bill will also be submitted to you requiring that every steamer prosecuting the seal fishery henceforth shall be provided with a sufficient equipment of wireless telegraphy.

Mr. Speaker and Gentlemen of the Honourable House of Assembly:

Proposals will be laid before you in relation to expenditures arising out of the undertakings already given to the Mother Country in respect to the present war.

Mr. President and Honourable Gentlemen of the Legislative Council:

Mr. Speaker and Gentlemen of the Honourable House of Assembly:

Britons in the Mother Country and Oversea Dominions must thrill with pride at the evidence of Imperial solidarity which this crisis has evoked. The world has seen no more magnificent spectacle

than that which is presented just now of the far-flung possessions of the Crown rallying to the support of the Mother Land in this emergency. It is a special pleasure to me, representing His Majesty the King in this, the oldest Colony, to know that in lovalry, patriotism and self-sacrifice Newfoundland is prepared to do its part, as shown by the ready response of our people to the call of the Mother Land.

In conclusion I would say that I trust Divine Providence may guide us all to wide measures in the interests of the country and the Empire, and I feel sure that in the time of trial and anxiety through which we have to pass, the people of this country will maintain that aspect of calmness and dignity which, in previous periods of tribulation, has characterized them. It is essentially a time when mutual forbearance on the one hand, and a generous spirit of co-operation on the other, will do very much to mitigate the difficulties which must incidentally follow from a prolonged continuance of hostilities, and to buoy us up with hope for better things when peace is again proclaimed.

When Mr. Speaker had finished reading the Speech, the members rose in their places and sang the National Anthem.

Devereaux, and seconded by Mr. Thomas LeFeuvre, that an Address of Thanks be presented to His Excellency the Governor in reply to the gracious speech with which he had been pleased to open the present Session of the Legislature, and that a Sleect Committee be appointed to draft such Address in Reply.

The following Committee was appointed to draft an Address in Reply to the Speech from the Throne, namely: Mr. Devereaux, Mr. LeFeuvre, Mr. Clift, Mr. Dwyer, Mr. Moore, Mr. M.J. Kennedy.

Rt. Hon. the Premier laid on the table a copy of the correspondence respecting the European crisis.

Rt. Hon. the Prime Minister laid on the table of the House a copy of certain correspondence between the Secretary of State for the Colonies, and His Excellency the Governor.

On motion of Rt. Hon. the Prime Minister, and by unanimous consent of the House, the Rules of the House were suspended for the present Session.

(1)—The Russians have smashed four Austrian Army Corps at Lemberg, in Austrian Galicia, and taken 150 guns.

(2)—The Russians are investing the fortress of Konigsberg in East Prussia.

(3)—Continuous fighting in Northern France, where the British cavalry has greatly distinguished itself and taken 10 guns.

(4)—The French continue to advance in Lorraine and are invading German soil.

I have replied in fitting terms and have said that the Newfoundland Regiment is now 800 strong and going under canvas. Contingent of 500 will be ready to start on the 1st October.

Mr. President and Honourable Gentlemen of the Legislative Council:






