Legislative Council of Newfoundland

Second Session of the Twenty-sixth General Assembly.

WEDNESDAY, February 18th, 1925.

This being the day appointed by Proclamation for the meeting of the Legislature.

The House met.

PRESENT:

The Hon. Sir Patrick McGrath rising in his place announced that a Commission under the Great Seal signed by His Excellency the Governor had been issued to him, appointing him to the Presidency of the Legislative Council in the room and place of the Hon. J. D. Ryan, resigned.

The Commission was then read by the Clerk and the President took the Chair of the House.

The President then informed the House that he had a communication from His Excellency the Governor informing him that he had appointed provisionally as Members of this House:

The Hon. the President announced that these gentlemen were in attendance waiting to take their seats, and they were accordingly introduced:

Hon. John Alexander Robinson, M.B.E., L.L.D., by the Hon. Mr. Morine and the Hon. Mr. Bishop.

Hon. Charles Pascoe Ayre, M.B.E., by the Hon. Mr. Morine and the Hon. Mr. Gibbs.

Hon. Frederick Charles Alderdice by the Hon. Mr. Morine and the Hon. Mr. Shea.

The Commissions appointing the Honourables John Alexander Robinson, M.B.E., L.L.D., Charles Pascoe Ayre, M.B.E., and Frederick Charles Alderdice were read by the Clerk, and the new Members were welcomed by the President and took their seats accordingly.

At three o'clock p.m. His Excellency the Governor, Sir William Lamond Allardyce, Knight Commander of the Most Distinguished Order of St. Michael and St. George, having arrived at the Council Chamber, and being seated on the Throne, commanded the Gentleman Usher of the Black Rod, through the Honourable the President of the Legislative Council to let the House of Assembly know:

"It is His Excellency the Governor's pleasure that they attend him immediately in this House."

Who being come thereto, with their Speaker, His Excellency was pleased to speak as follows:

Mr. President and Honourable Gentlemen of the Legislative Council:

Mr. Speaker and Gentlemen of the Honourable House of Assembly:

We meet under more prosperous and gratifying conditions than existed in this Colony when the Legislature was prorogued.

The Codfishery of last year was prosecuted successfully and the products disposed of at the best prices known in the history of the Colony (exclusive of the abnormal war years). Those who engaged in this staple industry of the

country reaped a reward which renewed their faith and interest in it.

The construction of great works upon the Humber has proceeded with remarkable speed and success, many men are now engaged in cutting wood for manufacture into pulp and paper, and it is confidently expected that early in the approaching Spring, manufacturing will begin. Negotiations are proceeding, it is understood, for the promotion of a pulp and paper industry on the Gander River, and hope is fully entertained, that construction will commence before we meet again in Session.

Conditions in the Mining industry at Bell Island have not been satisfactory. Disagreements have occurred between the Company and its workmen. Before they arose my Government had felt constrained to make concessions to the Company concerning its contractual obligations in order to procure increased employment for labourers. Arrangements have been made to proceed with work on former conditions, pending a conference between the Company, the miners, and the Government.

My Government recently sent a delegation to Canada to discuss suggestions regarding a settlement, by negotiation, of what is popularly known as the "Labrador Boundary Question." They met representatives of the Dominion of Canada and the Province of Quebec, and discussed with them the economic aspects of the matter, confidentially, frankly and fully, and without prejudice to either party, and the discussion has been continued by correspondence since the return of the delegates. No agreement

has been completed, and none may be, but until a tentative arrangement has been made, or the possibility of making one abandoned, it is not deemed expedient to inform you more fully of the proceedings. It is hardly necessary to add, I hope, that the Colony will not be committed by my Government to any settlement of this matter without the prior consent of the Legislature. The gratifying warmth of the reception given to the delegates in Canada testified to the extreme friendliness of Canadians to the people of this Colony.

Following upon the Hague Award, defining the liberty of the inhabitants of the United States to take fish on the Treaty Coast, so called, of Newfoundland, an agreement was made in 1910 for the settlement by arbitration of claims by the United States, based on alleged wrongful acts of the authorities of this Colony in respect of American fishing vessels. Statement and Answer were filed in 1914, but proceedings were interrupted by the Great War. A revised claim was filed on the first of August last, and a final Answer on the 31st January last. It is expected that a hearing by Arbitrators will take place in Washington this year.

A contract has been made for the construction of a steamer to ply on the Port-aux-Basques-North Sydney route. It was given to a Company incorporated in Holland, but partly owned and managed by British people. It would have been more agreeable if a contract could properly have been given for construction in a British shipyard, but the price asked, and the impossibility of getting guarantees for early completion, practically compelled the acceptance of the Contract which has been made.

Unemployment in the Colony has greatly decreased by comparison with all the years since the Great War ceased, and it is not now abnormal. There are many persons who for one reason or another are out of work and it has been suggested that public money should be expended to provide employment. Experience has shown that work at public expense cannot be productively engaged in at this season and my Government has decided therefore not to authorise it at present.

Very disturbing discoveries have been made by a Commission engaged in an enquiry concerning expenditures for charitable institutions and services. Laxness of administration, and imposition by the non-deserving, have been proven, and there is evidence that the homely virtues of self-reliance and self-respect have been diminishing. Public expenditure for the relief of the sick and afflicted is meant for the helpless poor, and the conduct of those who selfishly trade upon this charity is highly reprehensible. Stricter rules and closer observance must be insisted upon. Good results from the enquiry have already been observed.

The services of a Postal Service expert, with great experience in Canada, have been obtained, to aid in a reform in the Postal Service of the Colony, in which conditions have existed of a nature very injurious to public interests. The Service is over-manned and under-worked, and much greater efficiency must be obtained at less cost. It is not possible to reform a Service so demoralized in a short time, but drastic reforms have been proposed, and will be insisted on.

Agricultural interests are having the atten-

tion of my Government and it is hoped that a Committee of practical Farmers, now in conference with the Minister, may suggest some wise legislation for the promotion of this important industry.

Mr. Speaker and Gentlemen of the Honourable House of Assembly:

The finances of the Colony are in a highly satisfactory condition. Revenue has increased, and expenditure has decreased, and there will be a surplus of ordinary Revenue over Expenditure on current account in the financial year 1924-5. Tenders for a Loan of Four Million Dollars (\$4,000,000), part of what was authorized last year, have recently been received, and the rates quoted have been most satisfactory. Part of this Loan will be expended in Great Britain for the purchase of rails, and the Imperial Trade Facilities Board has undertaken to pay part of the interest for five years on the amount so expended, with the stipulation that the Loan be raised in England.

The expenditures for many years past have so exceeded the votes made for them as to show that great carelessness, at least, has been displayed by those who prepared the Estimates. The provision you will be asked to make for the coming year will be calculated with great care, and will in due course be laid before you.

Just prior to the coming into office of my present Government an irregular order was issued purporting to remove Customs duties from gasolene, flour, beef, pork and molasses. My present Government, prudently desiring to amply provide for the Colony's needs, did not feel able to legalize all the reductions which had been announced, but struck off the duty on gasolene and flour. It is pleasant, therefore, to be able now to announce that you will be asked to repeal the duties on beef and pork, and kerosene oil, a most timely reduction when the prices of these articles are increasing.

Owing to the increased cost of shipbuilding, the bounty offered by the Government has not induced the construction of many new vessels, and as a large proportion of our present fishing fleet are in need of repairs, a measure providing a bounty for the encouragement of such repairs will be submitted for your approval.

The taxation of Banks doing business in Newfoundland has been excessive and unfair. You will be asked to reduce it. The successful prosecution of the trade of the Colony depends very largely upon the continuance of adequate banking facilities and the splendid banking institutions in our midst must be fairly treated.

An examination of the Dry Dock in this Port, made by an expert engineer, has revealed the need of extensive repairs, and of partial rebuilding, and the cost will be large. Proposals will be made for your consideration.

War time demands led to the enactment of the Business Profits Tax, 1917, and the Income Tax Act, 1918; the former has been repealed, and the latter amended. Both laws worked great hardships, and have been unsatisfactory in practice. Income Tax returns have not been made by many, under pressure only by others, and payments of assessments have been evaded,

delayed or refused in so many cases that unfairness has resulted to the honest observers of the law. It is a form of taxation unsuited to this country. It restrains investment of capital in business, and though apparently paid by the so-called well-to-do, it is passed on to the consumer, when paid by those successful in business, while hampering severely, and sometimes destructively, those who have not prospered. Profits on the business of last year often come to be added to the losses of this. Simplicity of taxation is much to be desired in this Colony in order to get back as far as possible to the good old days of comfort for our people, and therefore a Bill to suspend Income Tax as and from the commencement of 1925 will be introduced. An endeavour will be made to meet the loss to the revenue by the practice of honesty and economy in public expenditure.

Mr. President and Honourable Gentlemen of the Legislative Council:

Mr. Speaker and Gentlemen of the Honourable House of Assembly:

There has been no Redistribution of seats in the Assembly for many years. The constituencies marked out in 1832, upon the grant of representative institutions, have undergone minor changes only. The Census of 1921 revealed inequalities and unfairness, the population of some electoral districts being shown to be half as many for two members as others had for one. A Redistribution Bill has therefore been prepared for your consideration and will be introduced at an early date, so that a measure may be enacted at this Session to go into effect upon the dissolution of this Assembly. It has been

very carefully prepared and will, I believe, be generally acceptable. It divides the Island into thirty four districts privileged to return one representative each, and three districts to return two men each, and so arranged as to maintain representation of the various interests as formerly. It would be difficult to exaggerate the good results which may be expected to flow from this measure.

You provided generously in your last Session for the construction of roads intended especially to promote tourist traffic and generally to develop the Colony, affording local accommodation incidentally. It was not possible to commence construction last year, but some surveying has been done, a plan for work this year has been made, and construction will be vigorously undertaken as soon as the weather will permit. A Bill will be introduced for the creation of a Highroads Commission, charged with the construction and maintenance of roads considered to be of first importance, designated from time to time for that purpose by the Government, and the Chairmanship of this Commission will be conferred on the Government Engineer, with the object that the methods adopted in roadbuilding will no longer be haphazard and inefficient.

It is obvious that if tourist traffic is to come to this country, revision in Motor Traffic laws is essential, bringing them into harmony with those of the United States and Canada, from which such traffic must come. The need of stricter and fuller laws in this relation has long been evident, and a Bill for this purpose, based upon the latest and completest laws of adjoining countries, will be introduced. It will

confer authority over the Motor Traffic upon the Highroads Commission, upon the ground that as that Commission is to control the construction and maintenance of highroads, it must necessarily control motor traffic over them.

It has been usual in newly discovered countries for Government to expand upwards, from Settlement, Village and Town, to State and national organization, and for the practice of the control of local affairs to train the people for participation in the management of matters. of concern. Here, it has been otherwise, participation in administration having been but slowly conceded by central authority, and a consequence has been that the general government of the Colony is expected to provide, control and pay for public services which should be instituted, managed and paid for locally. It is proposed, therefore, to ask your consideration of a wide general measure for the incorporation of municipalities, which can from time to time be made applicable to suitable areas by proclamation of the Governor in Council, and thus the feasibility of self government in such areas will be given a trial under favourable conditions. The residents of the incorporated places will thereby be able to vie with others in making their hometowns desirable and attractive.

I commend the duties of the Session to your assiduous care and pray that the guidance of Divine Providence may attend your deliberations.

The House of Assembly withdrew.

His Excellency was pleased to retire.

The Clerk read his Commission and the Hon. the President administered the oath of office.

After which His Excellency was pleased to speak as follows:

- Mr President and Honourable Gentlemen of the Legislative Council:
- Mr. Speaker and Gentlemen of the Honourable House of Assembly:

At the close of a busy and profitable Session, I am pleased to be able to relieve you of your Legislative duties, and more particularly so at a Season when your private affairs urgently demand your attention. The summoning of the

Legislature at an earlier date than usual has been clearly justified, so much so that it may be both expedient and convenient to convene you in future at an even earlier date.

The measure providing for the Redistribution of Seats in the House of Assembly is of supreme importance, and the unanimity with which it was considered attests to your conviction that it is not only fair in principle and correct in detail; but also is bound to have far reaching consequences.

Equal in importance is the enactment bestowing upon women of twenty five years and upwards the right to vote and be voted for, as representatives in the Assembly. The high standard of intelligence of the women of this Colony is adequate assurance that good will accrue to this endowment of equality.

The provision for the creation of a High-roads Commission, the enactment of the Motor Traffic Act, and the confirmation of the contract for the erection of a Hotel in St. John's are steps in a Tourist policy to capitalize the scenic and kindred attractions of this Colony, for the pleasure of the world at large, and for the profit of our people. If the prosperity of Newfoundland is to be increased it is essential that the means for easy and rapid transportation be provided.

In August last, at the close of the midsummer Session of this Assembly, I expressed the hope that our finances would shortly return to the normal. Progress in that respect has been slower than was hoped for. Debts and obligations inherited by my Government have had to be discharged, and the abnormal conditions of past years have proved exceedingly difficult to adjust. The old Custom Tariff required drastic reformation because the classification was antiquated and unscientific. Additional confusion was caused by taxation having been imposed by various amendments which have proved to be unsuitable to present conditions. A new classification has now been adopted based on the report of a Tari ff Commission appointed by a preceding Government. Its operation will be carefully watched, and as the result of experience gained you will be invited to correct any anomalies that may be shown to exist.

Last year, as you will remember, my Government placed flour and gasolene on the free list, and you have now abolished the duties on beef, pork and kerosene oil, and reduced the sales tax by half. The Income Tax has also been repealed. Its incidence, although ostensibly paid on profits, was found to be harmful to trade and enterprise, and therefore injurious to fishermen, labourers, and other wage earners who depend on the free exploitation of capital for employment.

The Dry Dock in St. John's was shown on examination to require far more extensive repairs and alterations than had been anticipated, and on expert Canadian advice it has been decided to rebuild and extend it. The work will shortly be begun, but its completion and final equipment will be a matter of many months. Additional public works include the re-railing of the Southern end of the Railway from St. John's to Clarenville, the construction and reconditioning of certain important roads, and in addition the projected erection of the Hotel and a Flour Mill in St. John's.

The outlook for the steady employment of labour is further enhanced by the commencement at an early date of the manufacture of paper at the large Mills on the Humber, and by the increase and output at the Anglo Newfoundland Development Company's works at Grand Falls. It is hoped that the need for able bodied relief will disappear entirely. These various activities should result in the return to Newfoundland of many of her sons who have been compelled through the stringencies of recent years to seek employment far away from their native land.

By the Act for the Encouragement of Shipbuilding and Rebuilding, my Government has recognized the special needs of the fisherman. During the war years the fishing fleet fell into considerable disrepair; later the great cost of material and labour coupled with the poor prices obtained for fish in the seasons previous to last year, discouraged the fishermen to such an extent that many abandoned the industry. The promise that a bounty would be provided stimulated rebuilding last Winter, and the measure fulfilling that promise has now become law. More vessels are about to prosecute the main industry of the Colony than have sailed for some time past. The safety of those who travel by sea has been immeasurably increased by your enactment for the annual survey of sealing steamers and all manner of passenger carrying vessels.

Mr. Speaker and Gentlemen of the Honourable House of Assembly:

I thank you for the liberal supplies which you have granted. It has been, and will be the

constant effort of my Government to reduce expenditure to the lowest possible point at which the efficiency of the Administration can be maintained.

Mr. President and Honourable Gentlemen of the Legislative Council:

Mr. Speaker and Gentlemen of the Honourable House of Assembly:

I desire both to thank you for your labours, and to congratulate you upon the many important measures to which this Session has given birth. I can but wish you, in return, abundant success and prosperity in your personal affairs.

When we review the events which go to make up the history of Newfoundland for this year, we see before us the signs of re-awakening prosperity and we can but feel strengthened in our faith in the recuperative powers of the Empire's Oldest Colony.

The Honourable President then said:

It is His Excellency the Governor's Will and Pleasure that this General Assembly stand prorogued until Thursday, the 18th day of June next, then and here to be holden, and this General Assembly stands prorogued accordingly.
