## Legislative Council of Newfoundland

Third Session of the Twenty-Sixth General Assembly.

WEDNESDAY, March 3rd, 1926.

This being the day appointed by Proclamation for the meeting of the Legislature.

Order of St. Michael and St. George, having arrived at the Council Chamber, and being seated on the Throne, commanded the Gentleman Usher of the Black Rod, through the Honourable the President of the Legislative Council to let the House of Assembly know:

"It is His Excellency the Governor's pleasure that they attend him immediately in this House."

Who being come thereto, with their Speaker, His Excellency was pleased to speak as follows:

- Mr. President and Honourable Gentlemen of the Legislative Council:
- Mr. Speaker and Gentlemen of the Honourable House of Assembly:

Since last we met there has been universal sorrow throughout our Empire at the death of Her late Majesty Queen Alexandra. The Queen Mother, by her exceptional qualities, her kindness of heart, and her untiring efforts for the alleviation of suffering, won the love and affection of all classes of the community both at Home and Overseas. The sincere sympathy of the people of Newfoundland went out to their Majesties the King and Queen, and to all the Members of the Royal Family.

The continued prosperity of the Colony since you were last in Session has been well maintained, and I congratulate you accordingly. Not since the Great War commenced have conditions generally been so satisfactory as they are at present, and have been during the last twelve months.

The Sealing and Cod-fishery industries in

1925 were more productive than in the previous year. Stimulated by the bounty for repairs a larger number of vessels engaged in cod-fishing on the Labrador, and the catch obtained was above the average. Good prices were paid locally for fish, and although foreign market conditions are not now good, exporters will probably realize their stocks without material loss. Improvement in the cure is essential if the Colony is to maintain its position in foreign markets.

The development of the Colony's forest resources during the last twenty years, and the growth of the pulp industry, have changed and improved the conditions of a large section of the working classes. There is reason to hope for a further early expansion of this industry, as well as that of mining, with a proportionately increased demand for labourers.

The construction of the Hotel in St. John's, legislation in connection with which was enacted last year, has proceeded apace, and there is no reason to doubt that the Hotel will be ready for occupation at the opening of the approaching tourist season. During last Summer the Highroads Commission constructed and reconditioned a considerable mileage of important roads. The quality of the work done was excellent, and the cost per mile was not excessive when fair allowance is made for the initial cost and local conditions.

The reconstruction, extension and improvement of the St. John's Dry Dock have proceeded rapidly, and the erection of a capacious fire-proof warehouse in connection therewith has been commenced recently. The utmost satisfaction is felt with the manner in which the

work has been done, and with the results that have been obtained.

The re-railing of a portion of the railway between St. John's and Clarenville has materially improved the road-bed, has afforded increased comfort to passengers, and has facilitated traffic. Ordinary depreciation in rolling stock and road-bed has been more than met by increased ballasting and other improvements, and, as a whole ,the standard of the railway has been heightened.

In the month of August last certain Members of the Imperial Parliamentary Association came to Newfoundland and were the guests of the Government. This was the first occasion that any such delegation had visited the Colony and the Legislature and the Public were gratified to have the opportunity of meeting them. The exchange of views between the Parliamentarians of this country and those from the United Kingdom were alike helpful and profitable, and it is anticipated that much good will result.

In October last the S.S. "Caribou" took up the conveyance of mails and passengers between Port aux Basques and North Sydney, and has proved to be a most suitable boat for the service. With a large up-to-date Hotel in St. John's, improved and extended roads, a smoother rail-way road-bed, and a new, commodious and well-equipped steamer to connect with the adjoining Dominion, the Colony is rapidly being made ready for the increased tourist traffic which is confidently hoped for and expected. In this connection it is pleasant to note that three large new passenger steamers will this year be plying to and from St. John's, and that an excellent

steamship has been built for the trade between Montreal and Bay of Islands.

The award of the Pecuniary Claims Tribunal at Washington in November last, on claims by the United States of America arising out of the traffic in herring on the West Coast by American vessels, was in Newfoundland's favour. The principle on which the decision was based establishes the Colony's right to control traffic between its people and American vessels resorting to that coast to procure herring cargoes. The final pleadings in the Labrador Boundary case will be filed at the end of this month, and it is proposed to have a date in October of this year set for the hearing in London by the Judicial Committee of His Majesty's Privy Council.

The geological surveys of the Colony which have been made in the past were carried out before the interior was opened up by the railway. It is not unreasonable to hope, and even to believe, that great mineral resources exist, and an effort ought to be made to discover them for development purposes. A proposal, therefore, will be laid before you for the employment of a competent and experienced geologist, with adequate provision for surveys.

# Mr. Speaker and Gentlemen of the Honourable House of Assembly:

The financial year 1924-25 resulted in a substantial surplus of ordinary Revenue over ordinary Expenditure, but the loss on the operations of the railway absorbed that surplus. Railway receipts did not equal those of the previous year owing chiefly to the decrease in the volume of freight, while railway expenditure during the year included the cost of improving the railway

road-bed and rolling stock beyond the wear and tear of the year. The Revenue and Expenditure of the Colony for the expired portion of 1925-26 conform closely to the estimate. It is not expected that a substantial surplus will be achieved on the year's operations as demands for increased expenditure continually arise, some of them automatically by reason of long standing legislation, such, for instance, as the Teachers' Augmentation Fund. The estimates for 1926-27 will be placed before you in due course.

# Mr. President and Honourable Gentlemen of the Legislative Council:

# Mr. Speaker and Gentlemen of the Honourable House of Assembly:

The development of the industries of the Colony within recent years and the increasing number of our people engaged therein, make it desirable to provide the best possible protection to workmen and their dependents in case of accident. The amount of compensation to which workmen, in case of injury, and their dependents in case of death, are entitled under the existing law is not sufficient. Your consideration of this matter is invited for such action as may seem to you best calculated to safeguard the interests of workmen and industries alike.

Although self-government in purely local affairs seems to be desirable and practicable in certain localities, either by single or associated settlements, the powers and responsibilities of Municipal Government ought to be sought by the electors of progressive areas rather than imposed upon them by authority. A measure was drafted last Session which was general in its terms as to the election and powers of Councils in incorporated areas, with provision for its

adoption where suitable on the petition of electors and subject to the approval of the Governor-in-Council. That draft was deferred for more mature consideration and a Bill will be presented to you during the present Session.

The status of Civil Servants is undefined by law both as to their appointment and retirement. Salaries are seldom large enough to permit of saving for old age or infirmity, or for the protection of dependents, and, consequently, some officials have remained in office when their efficiency has ceased, while the death of others has reduced their dependents to want and entailed upon the Colony at times almost irresistible claims for gratuities. A Bill will therefore be introduced regulating superannuation or retiring allowances, and for other purposes.

The legal position of the railway and its operations; the method of collecting its revenue and disbursing its expenditure; the making of its contracts, and its responsibility for accidents are susceptible of improvement, and a tentative measure will be introduced not in order to make any drastic alteration in present conditions and practices, but to legalize the control and operation in the manner followed since the railway was taken over from the contractors.

When the Board of Liquor Control came into power in the early part of last year, the conditions it had to deal with were chaotic. Under its administration, however, smuggling and moonshining have decreased, and there has been a gratifying diminution of offences, many of which were the outcome of breaches of the Prohibition Act. The pecuniary results have exceeded the estimate. Conditions under the existing law have not however been free from

objection, ascribable, in some degree, to the open practice of bad habits previously pursued with greater secrecy and partly from the greater circulation of money through increased employment. It is confidently anticipated that there will be a continuous improvement in results. Some amendments in the Liquor Act, to facilitate its enforcement, seem desirable, and, incidentally, the fines for certain offences will be reduced, so as to make them more suitable for conditions here, but no radical change in methods will be proposed. A Bill for these purposes will be placed before you.

The statute permitting the landing and transhipment of spirituous liquors hampers the enforcement of the law in adjoining countries, and thus, possibly, tends to create international friction. Both good conscience and prudence alike suggest its repeal, and a Bill for that purpose will be introduced.

A new contract, subject to your confirmation, has been made between the Government and the Companies operating at Bell Island. Working conditions on the Island call for improvement. The creating of a market for ore within the British Empire is almost essential. The contract has been made, therefore, for a long term, and contains a provision as to export duty designed to give a preference to consumption within the Empire. The contract provides for improved housing conditions and limits the price of coal for household consumption both to workmen and others within the Colony. A safeguard is instituted against any reasonably avoidable closing of the mines at any time. I invite your serious consideration to the terms of this important contract.

Proposals will be laid before you for the better control of the harbour of St. John's by the institution of a Port Authority. The opening of the new Dry Dock, and the increase of shipping which it is anticipated will result, make such a measure necessary.

The agreement entered into by the Government with the Montreal Trust Company in relation to an issue of bonds for the Hotel now under construction in St. John's will be submitted to you for confirmation.

I invoke the Divine blessing on your labours, and leave you to your deliberations with confidence that they will be inspired by the desire to serve your country well.

Then the House of Assembly withdrew.

After which His Excellency was pleased to speak as follows:

- Mr. President and Honourable Gentlemen of the Legislative Council:
- Mr. Speaker and Gentlemen of the Honourable House of Assembly:

You will be pleased to be relieved of your duties as Legislators, to engage actively in the other avocations which demand your attention.

A large amount of useful legislation has received your consideration, and your labours in this respect have been for the public benefit. The Civil Service Act establishes clearly and firmly the basis upon which public officials shall be pensioned, a matter concerning which practice has been unsettled and unsatisfactory. The Newspaper Act grapples with a condition long discreditable to our Colony. The Railway Commission Act gives legality to an operation of the Newfoundland Railway which has hitherto been conducted without statutory authority.

The Act amending the contract made in 1923 for exportation of pulp wood from areas in White Bay has resulted in a sale of the Hampden Areas to the International Paper Company, which has already commenced its operations connected therewith, and increased employment will be given there.

The Dry Dock at St. John's has been completed though the construction of storage and other facilities in conjunction with it will continue for some time. A large foreign ship is even now being repaired in this new Dock.

The Hotel in this City, in relation to which a guarantee has been given by the Colony, is not yet wholly completed, but will open for the reception of guests this month, early enough to offer a welcome to the Tourists who will soon be coming to our shores. In this connection it is pleasant to note that three fine new passenger steamers have been provided to meet the Colony's growing traffic.

Gratification is felt at the manner in which the Highways constructed last year by the Highroads Commission withstood the trying winter season, illustrating the fact that work well done is after all the most economical. The roads commenced last year will be completed at an early date, and new work undertaken in due course. The loan authorised this year will permit certain pioneer roads to be undertaken in localities which do not at present need motor roads, but will repay development, and call for increased facilities.

Comfort, convenience and economical operation have all been served by the partial re-railing of the Railway which took place last year. The additional re-railing this year for which you have provided will give increased beneficial results.

Our people can best be helped by increased wage earning facilities. It is, therefore, gratifying to note indications of increased development of natural resources, such as mining and manufacturing offer. The great works of the Newfoundland Power and Paper Company, Limited, on the Humber are satisfactorily operating. The Anglo-Newfoundland Development Company, Limited, are extending their operations. Certain mining operations are soon to be undertaken by the latter Company, and there are hopes for important promotions in connection with the fisheries.

The Joint Committee of both Houses appointed recently to enquire into fishery matters, will be appointed a Commission under the Public Enquiries Act, to enable it to carry on its work out of Session. This is a most important matter, and that its deliberations will be attended by great good I do not doubt.

# Mr. Speaker and Gentlemen of the Honourable House of Assembly:

The liberal supplies you have voted will be used for the public benefit.

A Commission will be appointed during the recess to study and report upon the expenditure of the Colony, with a view to reduction where possible, and upon the Colony's source of revenue, with a view to more equitable and satisfactory imposition.

- Mr. President and Honourable Gentlemen of the Legislative Council:
- Mr. Speaker and Gentlemen of the Honourable House of Assembly:

The successful result of the Seal Fishery is a source of much satisfaction not alone for the employment it afforded those engaged in its prosecutions but also for the stimulating effect it will undoubtedly have upon other industries of the country.

In relieving you from your Legislative duties I join with you in the confident hope that the objects aimed at by your Honourable Houses in your endeavour for the public welfare may be achieved and I now take leave to wish you severally prosperity and happiness during the recess.

The Hon. the President then said:

It is His Excellency's Will and Pleasure that this General Assembly stand prorogued until Wednesday, the 21st day of July next, then and here to be holden, and this General Assembly stands prorogued accordingly.
