The House met at three of the clock in the afternoon, pursuant to adjournment.

At three of the clock the Sergeant-at-Arms notified Mr. Speaker that His Honour, the Lieutenant Governor, Honourable Campbell MacPherson, O.B.E., had arrived; whereupon Mr. Speaker vacated the Chair.

The Sergeant-at-Arms preceded His Honour, the Lieutenant Governor, to the Chair.

Whereupon, the Lieutenant Governor, having taken his seat, Honourable the Premier addressed His Honour as follows:

> May it please Your Honour, The House of Assembly agreeable to Your Honour's Command, have proceeded to the choice of a Speaker, and have elected John R. Courage, Esquire, Member for the District of Fortune Bay and Hermitage, to that office, and by their direction, I present him for the approbation of Your Honour.

His Honour then pleased to reply:

On behalf of Her Majesty I assure you of my sense of your efficiency and I do most fully approve and confirm you as the Speaker.

Whereupon Mr. Speaker addressed His Honour as follows:

Your Honour's ready approval of the choice with which I have been honoured by the House having constituted me in due form the Speaker of the House of Assembly, it has now become my duty in the name of the representatives of Her Majesty's loyal subjects, the people of this Province, and respectfully to claim of Your Honour their accustomed rights and privileges and that they shall have freedom of speech in their debates, that they may be free from arrest during their attendance in Parliament and that I, as Speaker, may have full access to Your Honour's presence, and that they have confirmed to them all their ancient rights and privileges which have been confirmed to them by Your Honour's predecessors.

His Honour was pleased to reply:

On behalf of Her Majesty I do confirm this House in the enjoyment of all its ancient and undoubted rights and privileges. His Honour was then pleased to open the Session with a Speech from the Throne as follows:

Mr. Speaker and Members of the Monourable House of Assembly:

The people of Newfoundland rejoice in the birth of the young Prince Andrew to Our Gracious Queen, and welcome with deep satisfaction the announcement of the forthcoming marriage of the sister of our beloved Queen, The Princess Margaret. It is, I an sure, the universal wish of Newfoundlanders that the Princess will enjoy a long life of happy marriage.

I think that we all of us, as Newfoundlanders, may feel proud of the beautiful new Chamber in which the present session, and all future sessions of your House, will be held.

This is an historic occasion and it gives me personally the greatest pleasure and pride that it has fallen to my lot to be the first representative of Her Majesty in this Province to open a session of this Honourable House in its new surroundings.

My Ministers were anxious that you should have a Chamber which would in every way be worthy of the great principles and practices of British parliamentary government, and the centuries' old traditions of our Island home. I think you will agree that the architects and builders have succeeded in creating a room which, with its auxiliary offices for Hembers and their staff, should provide convenience and efficiency that the old Colonial Building is no longer dapable of providing. Your Chamber is the point of highest interest in a noble edifice erected to celebrate the first ten years of the greatest blessing, under Heaven, that our people have ever enjoyed. I refer, of course, to the union of Canada and Newfoundland into one country.

Ir. Speaker, when I delivered the Speech from the Throne with which I closed the final session of the Thirty-First General Assembly I declared that it was the intention of my Ministers, at this present session, to ask you to enact certain modifications to the labour legislation adopted in the last General Assembly. These modifications will be laid before you for your consideration in the ensuing weeks.

In My Ministers have given careful consideration to the need for new legislation aimed at protecting the interests of those of our people who labour in the pulpwoods and lumber industry. They feel that the existing legislation, which was so useful when originally enacted, has become anticuated and inadeguate. New legislation will be laid before you in the present session.

Important as la our legislation is, however, for the purpose of protecting the interests of those engaged in industry, it is even more important to the general well-being of the Province that there should be industry in which our poople may engage. My Government are happy to note that success is attending the efforts they have put forth in recent years to bring about industrial and natural resources development in the great territory of Labrador and on the Island of Newfoundland itself. In Labrador, there the British Newfoundland Corporation has been given exclusive rights to the development of the great potential hydro electric power, work has already commenced on the first phase of what we all hope will become one of the great hydro developments of North America. This first phase calls for the production of 120,000 horsepower of hydro electricity to serve another great industrial development rapidly taking shape in the heart of Labrador. I refer to the new iron ore field at Uabush Lake and Carol Lake, My Ministers take great pride in the part they have played in these developments. They have never concealed their deep faith in the industrial possibilities of Labrador, and it is gratifying indeed to find such early justification of this confidence.

Here on the Island of Newfoundland itskef important mineral developments are rapidly taking place. The new copper mine at Tilt Cove is working with expanding success, and at Little Bay another copper mine is about to commence production. At Bair Verte and in that general area, my Hinisters have good reason to believe that construction of a very important new asbestos mine, mill and town will commence in the not distant future. The Government are negotiating for the opening of yet another copper mine in that general section of Newfoundland.

Construction of the large new salt and fresh fish plant at LaScie has been completed, and my Ministers have entered into an agreement with a large and reputable New oundland concern for its operation in the immediate future. I am sure that all Newfoundlanders will wish Godspeed to this firm in their great undertaking, and that our people will watch with increasing interest the outcome of these operations. That outcome may very well determine the future of the fishing industry along that part of our far-flung coast. The plant is probably the most thoroughly modern and efficient to be found anywhere in North America at the present time. Marm cooperation between fishermen and management, together with a bountiful supply of fish, should result in the success for which we all hope.

The Government are pressing forward with their programme of fishery development along the southwest coast of the Province. Two of the fleet of long-liners to be built for that purgeseme have already been launched, and other phases of the project are proceeding without delay. The frozen fish industry in general appears to be in fairly healthy condition, and our devout hope is that this condition will continue into the future.

Mr. Speaker, I am sure that all the Members of your Monourable Mouse, and the great majority of our Mewfoundland people, will be pleased to know that last year, 1959, witnessed the greatest accomplishment Mewfoundland has ever experienced in the building, improving and paving of our roads. Close to \$22 million was expended on these projects during the year and although these efforts fell far short of filling the needs of the people under this heading, the fact remains that a great step was taken forward that end.

Mr. Speaker, there has been much sadness amongst our people over the decision of the United States of America to withdraw the United States Air Force from Pepperrell Air Force Base. The warmest feelings of friendship have existed between the men of this Force and our citizens, and even more than the loss of business done in St. John's our people will feel the loss of many friendships made throughout the years. My Ministers are desirous that there should be recorded their appreciation of the sympathetic understanding displayed in this situation by the chief representative in Newfoundland of the Government of the United States.

There will be laid before you early in the present sesssion copies of the voluminous and comprehensive Report of the Royal Commission which considered the question of Civil Service pensions in this Province. The Report, which was submitted to the Government within the past fortnight, makes a series of recommendations. My Ministers expect to lay certain legislation on these matters before you in the present session.

My Ministers any lay before you, also, proposals for the establishment of a contributory pensions plan for Members of the House of Assembly who have given long service in the Legislature. Newfoundland is one of the few remaining Provinces of Canada without such a pensions plan.

You will be asked in this session to authorize my Government to proceed with the erection of a large new hospital in the city of Grand Falls. In that important industrial community the citizens and the principle industrial company have been joined by citizens in many nearby towns in making contributions to a fund raised for the purpose of assisting the Government to provide Central Newfoundland with a large new hospital. It is the hope of my Ministers that funds to be provided by you and by the people of Central Newfoundland will be used together with contributions from the Government of Canada under the National Health Grants plan to give the people in that part of Newfoundland the thomoughly modern hospital facilities so badly needed.

Construction of our splendid new buildings for the Memorial University of Newfoundland is proceeding rapidly, and there is every expectation that the University will enter the new buildings before the expiration of next year. Just as the existinge of this noble Confederation Building has given pride to so many of our people, so also, I feel, will the completion of this magnificent group of buildings being erected just to the westward of us for our University. My Ministers are deeply pleased that the University has succeeded in enlisting a distinguished gentleman in England for the purpose of organizing and leading an extention department, for which nothing but good will is felt.

Ny linisters have become deeply impressed by the need for mother departure in the rapidly expending field of education. They feel that there can be postponed no longer the commencement of construction of a large new College for Trade and Technical This would be aniinstitution in which high school Training. graduates and other students and apprentices would study trade and technical subjects with a view to gualifying themselves for technical positions in industry. It is my Government's intention, when the University removes from its present buildings on the Parade Grounds into the new buildings, to have the present university buildings used for a Vocational High School, which will be the principal one of a number of such schools throughout the Province. In these schools students taking the last three or four grades up to and uncluding Grade X1 would come from the surrounding ordinary schools and nearby for vocational training that would give them the basis for a course of instruction in the new College of Trade and Technical Training. The two institutions would thus be com-plementary to each other, and would open altogether new opportunities for young men who had no desire to go on to university to become teachers, professional men or graduates in other university fields. My Government's plan is to have this new College of Trade and Technical Training erected somewhere between Confederation Building and the group of university buildings, and their hope is that they may also, in the not distant future, be able to erect still anothe. building in that same general area. This would be a building to house the public library, the Newfoundland Huseum, a new Art Gallery to be created, and a modern concert hall to serve the community of Newfoundland in general. This group of buildings, consisting of Confederation Building at one end and the University buildings at the other, with the College of Trade and Technical Training and the new arts and culture centre situated between the two, would surely constitute one of the noblest groups of buildings that would be found anywhere in this great country of Canada.

Ir. Speaker, my Ministers would not wish this session to open without some reference to the grave problem of Term 29. All of Newfoundland's special rights as they are provided in Term 29 of the Terms of Union by which Canada and Newfoundland united into one country, have, by Act of Parliament, been specifically limited to the year 1962. This means that in another two years or so Newfoundland's constitutional rights, as she understood them, come to an end. His Honour the Lieutenant Governor took the Chair.

May it please Your Honour, the General Ascembly of the Province has at its Present Session Passed Certain Bills, to which, in the name and on behalf of the General Assembly, I respectfully request Your Honour's assent.

His Honour then said "In Her Majesty's Name I assent to these Bills"!

Mr. Speaker addressed His Honour as follows:

It is my agreeable duty on behalf of Her Majesty's dutiful and loyal subjects, Her Faithful Commons in Newfoundland, to present to Your Honour Certain Bills for the appropriation of Supply granted in the Present Session.

Whereupon the Clerk read the following Bills, entitled:

- **A** Bill "An Act for Granting to Her Majesty Certain Sums of Money for Defraying Certain Expenses of the Public Service for the Financial Year Ending the Thirty-First Day of March One Thousand Nine Hundred and Sixty-One and for Other Purposes Relating to the Public Service."
- A Eill "An Act for Granting to Her Majesty Certain Sums of Money for Defraying Certain Expenses of the Public Service for the Financial Year Ended the Thirty-First Day of March
 One Thousand Nine Hundred and Sixty and for Other Purposes Relating to the Public Service."

His Honour then said "In Her Majesty's Name, I thank Her Loyal Subjects, I accept their benevolence, and assent to these Bills." His Honour was then pleased to make the following Speech:

Mr. Speaker and Members of the Honourable House of Assembly:

Your first Session in the new Confederation Building has been characterized by a great variety of important legislation, and this has made it one of the most fruitful sessions since the advent of Representative Government to our shores.

Among the matters which have occupied your attention, the revision of labour, logging and mining legislation has taken a prominent place. It is equally gratifying that the many amendments and improvements in our educational structure have been consolidated in a new Education Act, the first since 1927.

Important Bills designed to expedite the further industrial development of our Province have been given your most careful study, scrutiny and deliberation. As a result of the agreements contained in some of the Acts, a modern oil refinery is being constructed in Conception Bay by Golden Eagle Refining Company of Canada, Limited; our gypsum plant and gypsum deposits have been taken over by the large and reputable firm of The Flintkote Company whose plans for expansion will undoubtedly create greater employment on the vest coast of our Island; the promising Rambler area of the Baie Verte Peninsula has been made available to one of Canada's leading mining promoters, Mr. M. J. Boylen, whose efforts have already created a prosperous mine at Tilt Cove and have given us encouraging prospects of imminent development of the asbestos deposits at Baie Verte by the world-famous Johns-Manuille Corporation and of the copper deposits at Little Bay Atlantic Coast Copper Corporation Ltd.

My Ministers' efforts to bring about a third pulp and paper industry in Newfoundland have not so far been attended by the success for which we all hope. It is most gratifying, however, to note that still another corporation has made an agreement with the Government with the hope of creating a third paper mill based on the utilization of Labrador wood. Your authorization of an agreement with the Newfoundland Pulp & Chemical Co. Ltd. increases the possibility that eventually my Ministers' hopes will become a reality.

In the general field of social development your have favourably received my Ministers' proposals to erect a modern trade and technical college designed to train young Newfoundlanders from all parts of the Province. You have also supported and passed the necessary Bill to bring about the immediate building of a large general hospital at Grand Falls to serve the people of central Newfoundland. Provision has also been made for the erection of a hospital at Stephenville and lecislation has been enacted providing for the crection in St. John's of a modern nurses' training centre. Never before has there been such need for serviced land in and near St. John's as there is today; but notwithstanding that fact, the Government of Canada is not prepared to enter into an agreement with the Government of Newfoundland. It has been suggested that the Government of Canada might be willing to make an agreement with the City of St. John's. While my Ministers' feel that under existing federal legislation such an agreement cannot be made, nevertheless, legislation has been enacted enabling the St. John's Municipal Council to enter into such an agreement.

Mr. Speaker, I thank you for the provision you have made for all essential services, a provision which is the largest in the history of our Province. This will enable my Ministers to proceed with their plans for expansion, particularly in the fisheries, in road construction, in education and in the extension of rural electrification.

It is expected that during 1960 and 1961 three additional fishing plants, including the great LaScie project, will be coming into operation. In addition to extensive paving of the Trans-Ganada and other highways, my Ministers will continue to accelerate their programme of destroying the isolation which is still the lot of so many of our communities. In keeping with the ever increasing number of regional and central high schools, my Ministers' plans for a modern University are already in course of becoming a reality. The programme of rural electrification will mean that many more communities in our Province will be able to enjoy the amenties that are associated with this utility.

Your generosity will also have the effect of improving the financial remuneration of large numbers of the lower paid employees in the Civil Service.

Mr. Speaker, this Session is unique and specially significant in that you have terminated your association with the historic edifice which had served you and your predecessors for over a century. My Minsters are determined that the Colonial Building will always remain a hallowed monument to our constitutional and political history.

Your new Assembly Chamber is worthy of the great building in which it finds its home. You are honoured today by a visit from a great Canadian Statesman, one whose presence here is particularly appropriate in th t it was during his Prime-Ministership that the Union between Canada and Newfoundland was consummated.

In releasing you from your dutics, I express the hope that Divine Providence will continue to guide you and that His blessing will be on all of our people as they pursue their occupations on the sea, in the forests, in the mines, in industry and in every field of their labours. His Honour the Lieutenant Governor left the Assembly Chamber. Mr. Speaker then said:

> It is the will and pleasure of His Honour the Lieutenant Governor that this General Assembly be prorogued until Wednesday the nineth day of August next, and this Assembly is prorogued accordingly.
