BEGUN and holden at St. John's in the Province of Newfoundland on Monday, the 4th day of December, Anno Domini, Nineteen Hundred and Sixty-One, being in the Tenth year of the reign of Her Majesty our Sovereign Lady Elizabeth the Second, by the Grade of God, of the United Kingdom, Canada and Her other Realsm and Territories QUEEN, Head of the Commonwealth, Defender of the Faith.

Monday, December 4th., 1961.

His Honour the Lieutenant Governor having fixed the hour at which he proposed to open the present Session of the Legislature at three of the clock in the afternoon of this Monday, the 4th day of December, the Members of the House of Assembly met in the Assembly Chamber at three of the clock in the afternoon, when Mr. Speaker took the Chair.

At three of the clock the Sergeant-at-Arms announced that His Honour the Lieutenant Governor had arrived.

His Honour entered the Assembly Chamber preceded by the Sergeant-at-Arms.

Mr. Speaker left the Chair.

His Honour the Lieutenant Governor took the Chair.

His Honour was then pleased to open the Session with a Speech from the Throne as follows:

MR. SPEAKER AND MEMBERS OF THE HONOURABLE HOUSE OF ASSEMBLY:

2.

Since you last met Newfoundland has won for herself a great position in the University world of Canada, the United States of America and Great Britain. More than two score of the Universities of these countries were represented at the opening of the new Campus of the Memorial University by their Presidents, while many other distinguished persons were present on the great occasion. I am sure that the people of the Province were deeply pleased over the presence of Mrs. Roosevelt and that of the Prime Minister of our great country. They were equally pleased to see the United Kingdom represented by the Duke of Devonshire, a member of the Ministry in England.

The ceremonies were conducted with great spirit and I believe you will agree that all of our people derived the liveliest satisfaction from the whole affair. Newfoundland now finds herself the owner of a magnificent University to which we all look for inspiration and guidance to the young men and women of the land. I am confident that I bespeak your thoughts when I say that we wish abendant success to this great memorial erected in honour of our gallant dead of two world wars.

Under the Terms of Canfederation the Government of Canada undertook to make an offer to Newfoundland to enter into a Tax Agreement. This Agreement would provide for the rental to the Government of Canada of the income, corporation income and corporation tax fields and the succession duties tax field. An offer made under this Term, similar to the offers made to the other Provinces was accepted by my Ministers under authority given to them by this Honourable House of Assembly. Similar Agreements were entered into in 1952 and again in 1957, but the Government of Canada have now notified my Ministers that the present or any Agreement respecting income, corporation income and corporation tax rental will not be continued after the expiration of the present Agreement on the 31st day of March, 1962.

In substitution for Tax Rental Agreements that have been in existance since 1949 the Parliament of Canada has reduced federal income, corporation income and corporation Taxes by a percentage equivalent to payments formerly made to the provinces under Tax Rental Agreements thereby enabling the provinces to re-enter these partially vacated fields of taxation by the imposition of similar taxes of their own, which taxes, however, the Government of Canada have undertaken to collect. My Ministers feel that they have no alternative but to ask you to pass legislation providing for such taxation.

An amendment to The Mining Tax Act will also be placed before you.

As both of these proposals, if approved, will become effective on the first day of January next, my Ministers feel that they should properly come before this House for deliberation and, if approved, receive Royal Assent before that date.

A minor amendment to the Expropriation Act which will enable my Ministers to clear title to certain land required for the purpose of encouraging the tourist trade will also be submitted for your approval.

An amendment to The Education Act, submitted at the request of the United Church of Canada, will enable their United Church College Board of Governors and their St. John's School Board to be reorganized as one body.

By Ministers hope to be able to lay before you for such action as may be deemed necessary a draft of the proposed amendments to The British North America Act which will enable future amendments to this Act to be made in Canada. These amendments prepared under the supervision of the Attorney General of Canada and the Attorneys General of the Provinces in the opinion of my Ministers fully protect the peculiar position of the Province of Newfoundland.

I ask God's blessing on your deliberations.

His Honour left the Assembly Chamber.

Mr. Speaker resumed the Chair.

It was moved by Mr. Winsor and seconded by Mr. Jones that an Address of Thanks be presented to His Honour in reply to the gracious Speech with which he had been pleased to open the present Session of the Legislature and that a Select Committee be appointed to draft such Address in Reply.

It was ordered accordingly and the following Members were appointed to said Committee:

"BE IT RESOLVED that this House place on record its deep appreciation of the great services performed by Captain George Whiteley, one time Member of this House;

BE IT FURTHER RESOLVED that a copy of this Resolution be forwarded by the Clerk to the son and daughter of the deceased together with an expression of our deep sympathy with them at this time."

"BE IT RESOLVED that this House desires to record the expression of its deep regret at the death of Walter Skanes, one time Member of this House:

BE IT FURTHER RESOLVED that a copy of this Resolution be forwarded by the Clerk to the family of the deceased with an expression of our deep sympathy with them at this time."

The said Resolutions were seconded by Honourable the Leader of the Opposition, supported by Honourable the Leader of the United Newfoundland Party and Honourable the Member for Labrador North.

May it please Your Honour, the General Assembly of the Province has at its Present Session passed Certain Bills, to which, in the name and on behalf of the General Assembly, I respectfully request Your Honour's assent.

Whereupon the Clerk read the following Bills:

A Bill "An Act Further To Amend The Mining Tax Act.

A Bill "An Act Further To Amend The Expropriation Act, 1957."

A Bill "An Act Respecting Income Tax."

A Bill "An Act Further To Amend The Education Act, 1960."

His Honour then said: "In the name of Her Majesty the Queen, I assent to these Bills."

His Honour the Lieutenant Governor was then pleased to make the following Speech:

Mr. Speaker and Members of the Honourable House of Assembly:

I would like at this time to thank you for your attendance at this special session to which I called you early in the present month and for the prompt and careful consideration you have given to the several matters which were then referred to and which have since been submitted to you in greater detail by my Ministers. Your acceptance of the income tax proposals made necessary by policy changes of the Federal Government will make it possible for this legislation to become effective as at the beginning of the next calendar year, and I am sure it will be generally agreed that all taxpayers should know at the beginning of the year just what the tax structure for that year will be.

I thank you for the consideration that you have given to the various maker matters submitted to you.

Mr. Speaker and Members of the Honourable House of Assembly:

In releasing you from your duties at this time I would

like to extend to you the season's greetings. It is my hope that you and all our people may be able in the week approaching to cast the year's cares and worries aside and to celebrate the Yuletide season in the proper spirit; not forgetting in our celebration of this blessed event those in our midst who are less furturate than others and assisting them, and particularly the younger generation, to share with their more furturate neighbours the joy of Christmas.

A Merry Christmas and a Happy New Year to you all.

His Honour the Lieutenant Governor left the Assembly Chamber.

Mr. Speaker then said:

It is the will and pleasure of His Honour the Lieutenant Governor that this General Assembly be prorogued until Monday the fifteenth day of January next, and this Assembly is prorogued accordingly.
