S. Furlong, M.B.E., Honourable A.S. Mifflin, Honourable N.S. Noel, Honourable H.B. Morgan, Honourable J. W. Mahoney, Honourable N.H. Goodridge, Honourable J. R. Gushue and Honourable R. E. Fagan or any of you, are hereby authorized and directed to signify to the Members of the said House of Assembly on the twelfth day of July, 1979, that it is my pleasure that they should proceed to the choice of some person to be their Speaker and present such person on the same day for my approbation.

The Honourable Robert Stafford Furlong, Chief Justice of Newfoundland, one of the said Commissioners, then said:

Members of the House of Assembly,

We have it in command from His Honour the Lieutenant-Governor to acquaint you that His Honour will, as soon as the Members of this House shall be sworn; declare that causes of his calling this Assembly, and, it being necessary that a Speaker fo this House should be first chosen, it is His pleasure that you do proceed to the appointment of some proper person to be your Speaker; and that you present such person whom you shall so choose here today at three of the clock for His Honour's approbation.

And the Judges having left the Assembly Chamber, the Monourable the Premier then addressed himself to the Clerk, who, standing up, pointed to him and then sat down; moved, that Leonard Simms, Esquire, Member for the District of Grand Falls, do take the Chair of the House as Speaker", which motion was seconded by the Honourable the Leader of the Opposition, Donald Jamieson, Esquire, Member elected for the District of Bellevue.

No other person being proposed as Speaker, Mr. Simms was unanimously called by the House to the Chair, and was conducted to the Chair by the Members who proposed and seconded him.

The Honourable the Premier moved, "That John Butt, Esquire, Member for the District of Conception Bay South, do take the Chair as Chairman of Committees and Deputy Speaker of the House," which motion was seconded by the Honourable the Leader of the Opposition, Donald Jamieson, Esquire, Member elected for the District of Bellevue.

No other person being proposed as Chairman of Committees and Deputy Speaker of the House, Mr. Butt was unanimously elected as Chairman of Committees and Deputy Speaker.

The House then adjourned until three of the clock.

Be it known that at 2:30 p.m. there appeared before the Honourable R. S. Furlong, Chief Justice of the Supreme Court of Newfoundland, Honourable Herbert B. Morgan, Honourable John W. Mahoney, Honourable James R. Gushue and Honourable Ralph E. Fagan, Judges of the Supreme Court, Leo Barry, Member returned for the District of Mount Scio, who took and subscribed the Oath of Allegiance in the presence of the Law Clerk of the House of Assembly.

Ronald G. Penney Law Clerk The House met at three of the clock pursuant to adjournment.

At three of the clock the Sergeant-at-Arms notified Mr, Speaker that His Honour the Lieutenant-Governor, Honourable Gordon Arnaud Winter, had arrived, whereupon Mr. Speaker vacated the Chair.

The Sergeant-at-Arms preceded His Honour the Lieutenant-Governor to the Chair.

Whereupon the Lieutenant-Governor, having taken his seat, the Honourable the Premier addressed His Honour as follows:

"May it please Your Honour, the House of Assembly, agreeable to Your Honour's Command, have proceeded to the choice of a Speaker, and have elected Leonard Simms, Esquire, Member for the District of Grand Falls, to that office, and by their direction, I present him for the approbation of Your Honour."

His Honour was then pleased to reply:

"On behalf of Her Majesty, I assure you of my sense of your efficiency and I do most fully approve and confirm you as the Speaker."

Whereupon Mr. Speaker addressed His Honour as follows:

"Your Honour having approved the choice of this House in constituting me its Speaker, it now becomes my duty in the name of the representatives of Her Majesty's Loyal subjects, the people of this Province, to claim respectfully of Your Honour their accustomed rights and privileges, especially that they shall have freedom from arrest during their attendance in Parliament and that I, as Speaker, may have full access to Your Honour's presence at all reasonable times, and that they have confirmed to them all their ancient rights and privileges which have been confirmed to them by Your Honour's Predecessors."

His Honour was pleased to reply:

"On behalf of Her Majesty I do confirm this House in the enjoyment of all its ancient and undoubted rights and privileges."

His Honour was then pleased to open the Session with a Speech From The Throne.

His Honour then left the Assembly Chamber.

Mr. Speaker resumed the Chair.

the Honourable the President of the Council asked leave to introduce a Bill entitled, "An Act To Reform The Law Respecting The Property Of Married Persons."

On motion of the Honourable the President of the Council and by leave of the House, the said Bill was introduced and read a first time.

On motion it was ordered the said Bill be read a second time on tomorrow.

Mr. Speaker announced that His Honour the Lieutenant-Governor had been pleased to make a Speech to the Members met in the General Assembly and that for greater accuracy he had obtained a copy.

It was unanimously agreed that the Speech should be taken as read.

It was moved by the Honourable the Member for Menihek and seconded by the Honourable the Member for Port de Grave that an Address of Thanks be presented to His Honour in reply to the gracious Speech with which he had been pleased to open the present Session of the Legislature and that a Select Committee be appointed to draft such Address In Reply.

It was ordered accordingly and the following Members were appointed to the said Committee:

The Honourable the Member for LaPoile gave notice that he would on tomorrow move the following Resolution:

BE IT RESOLVED that a Special Committee of the House of Assembly be appointed immediately to lay down guidelines for the setting up of a Provincial Fair Prices Review Council with backup legislation to allow the Council to handle grievances and complaints from consumer groups and individuals who feel they have been the victims of unfair pricing, price gouging, profiteering, unethical procedures and practices by

wholesalers and retailers, false advertising, questionable procedures in stocking shelves by the big supermarket chains, and unfair competition in price fixing in connection with the pricing of gasoline by both distributors and at the gas pumps, and increases in prices of heating fuel and electricity rates.

The Honourable the Member for St. John's North gave notice that he would on tomorrow move the following Resolution:

WHEREAS it is vital that our children by fully aware of their cultural and historic heritage; and

WHEREAS the education materials approved for use in the curriculum of our schools often bear no relationship to the culture, heritage and experience of the people of this Province; and

WHEREAS the relevance of our educational system must always be kept in view;

BE IT THEREFORE RESOLVED that this Government be encouraged to review the materials presently used in our schools with a view to ensuring that such educational materials adequately reflect the culture, history and experience of the people of the Province.

The Honourable the Member for Trinity-Bay de Verde gave notice that he would on tomorrow move the following Resolution:

WHEREAS the fishing industry is of paramount importance to the economy of the Province of Newfoundland and Labrador'

AND WHEREAS the Nation of Canada does not own or process jurisdiction in respect of the total fishery resource of the seabed in the area extending to the edge of the Continental shelf and margin adjacent to Newfoundland and Labrador, the Hamilton Banks, the entire Grand Banks or to a limit extending 200 miles from the inner limit of the Canadian territorial Sea, whichever is greater;

AND WHEREAS a development program for the Newfoundland and Labrador Fishing Industry to 1985 has been proposed by the Government without benefit of debate in the House of Assembly;

AND WHEREAS the harvesting, fleet development, processing and marketing of our fish have not been clearly defined;

AND WHEREAS the development of the fishery will have an impact upon the social milieu of the communities of Newfoundland and Labrador;

AND WHEREAS the financing of a fishery development program has to come from Government sources and/or the private sector;

THEREFORE BE IT RESOLVED that this House fully debate all aspects of the fishery in order that the Government may be directed to develop a strategy for the fishery in the Province of Newfoundland and Labrador which would be in the best interest of all involved with the fishery and in the best interest of the Province as a whole.

The Honourable the Member for Bay of Islands gave notice the he would on tomorrow move the following Resolution:

WHEREAS the actions of the Organization of Petroleum Exporting countries have given rise to great increases in the price of imported oil coming into Canada;

AND WHEREAS the world is facing the distinct possibility of severe shortages in the supply of oil in the near future;

AND WHEREAS our energy resources should be conserved for the use of future generations;

BE IT THEREFORE RESOLVED that the Governments of Canada and of the Province be commended for their efforts taken to date in the area of energy conservation particularly in the recent signing of a DREE subsidiary agreement on renewable energy sources;

AND BE IT FURTHER RESOLVED that both Governments be encouraged to devote even more attention to this critical problem so that consumers of energy in the Province will be assured of stable and low-cost sources of energy in the future.

The Honourable the Member for BaieVerte-White Bay gave notice that he would on tomorrow move the following Resolution:

BR IT RESOLVED that a Select Committee be appointed to investigate, consider and report upon the feasibility and the desirability of the several proposals to develop the water power resources of this Province, including in particular those of the Churchill River and other waters in Labrador, and to investigate, consider and report upon the prospects therefore;

AND BE IT THEREFORE RESOLVED that the Committee have power to sit in and out of Session, to send for papers and other documents, and generally to exercise the powers which may be conferred upon Commissioners under the Public Enquiries Act, Chapter 314 of the Revised Statutes of Newfoundland, 1970;

AND BE IT FURTHER RESOLVED that the Committee be authorized to sit from place to place throughout Newfoundland and Labrador.

The Honourable the Member for St. Georges gave notice that he would on tomorrow move the following Resolution:

WHEREAS the people in rural parts of the Province have a right to live and raise their families in their own communities;

AND WHEREAS maintenance of this pattern of population is essential to the preservation of our culture and heritage;

AND WHEREAS the success of the programs evolved over the last number of years through agencies such as the Department of Rural Development indicate the potential economic strength of the rural parts of our Province;

BE IT THEREFORE RESOLVED that this Government be encouraged to continue to expand it sprograms of assisting the rural parts of the Province both with regard to increased economic opportunity and through the provision of improved public services.

The Honourable the Member for Burgeo-Bay d'Espoir gave notice that he would on tomorrow move the following Resolution:

BE IT RESOLVED that this House supports a renegotation of the financial provisions of Term 29 of the Terms of Union between Newfoundland and Canada with a view to having the annual \$8 million dollar payment translated into 1979 dollar value.

The Honourable the Member for Fortune-Hermitage gave notice that he would on tomorrow move the following Resolution:

WHEREAS the caplin is anessential food-fish for the cod and other ground fish species on which our commercial fisheries depend;

AND WHEREAS in the last number of years the numbers of caplin reaching the inshore waters of this Province have radically declined;

BE IT THEREFORE RESOLVED that this House urge the Government of Canada to take a very conservative approach with regard to the management of this Province's caplin stocks particularly with regard to the establishment of quotas so as to ensure that the health of our cod and other commercial species is fully protected.

The Honourable the Member for Windsor-Buchans gave notice that he would on tomorrow move the following Resolution:

WHEREAS the senior citizens of this Porvince have throughout their working years contributed to and have indeed assured the growth, development and future propserity of our Province;

AND WHEREAS a great majority of our senior citizens have fixed incomes;

AND WHEREAS inflation and the ever increasing cost of living continually erode the ability of our senior citizens to maintain an adequate, even decent standard of living;

AND WHEREAS our senior citizens have earned the right and are entitled to share in the propserity that they themselves created;

NOT BE IT THEREFORE RESOLVED that this House urge the Government to bring in legislation this Session to exempt senior citizens from school and municipal taxation;

AND BE IT FURTHER RESOLVED that the Province reimburse taxing authorities for loss of revenue for such exemptions.

The Honourable the Member for Placentia gave notice that he would on tomorrow move the following Resolution:

WHEREAS the present ferry service from North Sydney to Argentia is strictly on a seasonal basis;

AND WHEREAS if a ferry service were to operate on a yearly basis, traffic congestion would be substantially reduced on the Trans Canada Highway, thereby improving driving conditions on our major provincial road link;

AND WHEREAS 60% of goods coming to Newfoundland are destined for centres East of Gander;

AND WHEREAS the port of Argentia is ideally and strategically located for efficient handling and distribution of goods and is capable of receiving vessels in a 17 hour time frame from North Sydney;

AND WHEREAS in thsi energy conscious worlk it is recognized that goods can be moved more economically by means of water transportation;

BE IT THEREFORE RESOLVED that this Honourable House request Canadian National (Marine) to make application to the Federal Government for a year-round ferry service to operate between North Sydney and Argentia.

The Honourable the Member for Torngat Mountains gave notice that he would on tomorrow move the following Resolution:

WHEREAS presently many medical occurences in Labrador, because of a lack of specialized medical expertise, require transfer to a medical facility on the Island portion of our Province and is only accessible by air which is;

- (a) extremely costly
- (b) subject to weather conditions

BE IT THEREFORE RESOLVED that the Government of Newfoundland and Labrador make available ambulance services for patients in Labrador comparable to the Island portion of the Province.

The Honourable the Member for Menihek gave notice that he would on tomorrow move the following Resolution:

WHEREAS the hydro from the Upper Churchill Development is presently being exported to the Province of Quebec under a 60 year contract which is grossly unfair as to its terms;

AND WHEREAS the people of this Province have a basic right under the Constitution of Canada to receive a fair price for the development of their natural resources;

BE IT THEREFORE RESOLVED that the Government of the Province be encouraged to undertake all legal means possible to have the Upper Churchill contract revised as to its pricing provisions as as to ensure that a fair return is paid to the treasury of this Province.

The Honourable the Member for Grand Bank gave notice that he would on tomorrow move the following Resolution:

THAT this House set up a Select Committee to investigate the causes of increasing vandalism in Newfoundland and Labrador and recommend ways and means of curbing same.

The Honourable the Member for Humber West gave notice that he would on tomorrow move the following Resolution:

WHEREAS it is essential that balanced industrial growth take place throughout all areas of the Province;

AND WHEREAS the recently signed Industrial Development Agreement for Western Newfoundland indicates that the Government of Canada is willing to assist financially in the establishment of industrial infrastructure in this Province;

BE IT THEREFORE RESOLVED that this House urge the Government of Canada to expand this program to assist in the development of additional industrial parks in all regions of the province.

On motion it was ordered that when the House rises it adjourn until tomorrow, Monday, July 16th at three of the clock.

On motion the House then adjourned accordingly.

The Honourable the Minister of Justice gave notice that he would on tomorrow ask leave to introduce a Bill entitled, "An Act To Amend The Unified Family Court."

The Sergeant-at-Arms announced the arrival of His Honour the Lieutenant-Governor.

Mr. Speaker addressed His Honour as follows:

"May it please Your Honour, the General Assembly of the Province has at its present Session passed certain Bills to which, in the name and on behalf of the General Assembly, I respectfully request Your Honour's Assent".

The Honourable the President of the Council moved "That when this House adjourns today it will stand adjourned until Wednesday, February 27 at 3:00 p.m. provided always that if it appears to the satisfaction of Mr. Speaker or in the case of his absence from the Province, the Chairman of Committees, after consultation with Her Majesty's Government, that the House should meet at an earlier time than the adjournment, the Speaker, or in his absence, the Chairman of Committees may give notice that he is so satisfied and thereupon the House shall meet at the time stated by such notice and shall transact its business as if it had been duly adjourned to that time."•

On motion the House then adjourned accordingly.

The Sergeant at-Arms announced the arrival of His Honour the Lieutenant-Governor.

Mr. Speaker left the Chair.

His Monour the Lieutenant-Covernor took the Chair and delivered a Speech From The Throne as follows:

MR. SPEAKER AND MEMBERS OF THE HONOURABLE HOUSE OF ASSEMBLY:

The First Session of the Thirty-Eighth General Assembly of this Honour ble House of Assembly is about to be prorogued, but before releasing you from your duties I wish to convey to you my appreciation for the careful and sympathetic attention you have given to the important matters brought before you by my Ministers.

Forty-two pieces of legislation were enacted during this Session of the Honourable House of Assembly. Major legislative iniatives were taken in the areas of matrimonial property law, the administration of justice, municipal law, health, education and pensions.

The Matrimonial Property Act was passed with the purpose of reforming the law with respect to the property of married persons. Among the important provisions contained in this Act are the principles that each spouse has a one-half interest in the matrimonial home and that matrimonial assets acquired during a marria, are to be divided equally. The Act gives jurisdiction to the court to vary a division of assets if an equal division would be grossly unjust or unconscionable. The Act also provides that persons may enter into marriage contracts to deal with their relationship and such contracts would take them outside the Act. This Act is an important step forward in reforming the existing law.

MR. SPEAKER AND MEMBERS OF THE HONOURABLE HOUSE OF ASSEMBLY:

This Session has seen advances in the area of the administration of justice. The Small Claims Act was enacted providing the framework within which practice and procedure rules may be designed specifically for small claims. The jurisdiction of Provincial Court judges is limited under that Act to one thousand dollars. As well during this Session, a new Summary Proceedings Act was passed. This Act deals with provincial offences and provincial court inquiries. Both of these Acts repeal, replace and modernize the provisions of The Summary Jurisdiction Act. Also in this Session, The Provincial Court Act was amended to change the reference of Magistrates to Provincial Court judges.

Several existing pieces of legislation were also amended in this Session by The Human Rights Anti-Discrimination Act, 1979. This Act was passed to remove anomalies in provincial legislation that may be construed as discriminatory.

MR. SPEAKER AND MEMBERS OF THE HONOURABLE HOUSE OF ASSEMBLY:

Substantial progress was made in the area of municipal government. The Municipalities Act was passed to amend, revise and consolidate the law relating to the establishment and administration of municipal government in the province.

Also in this Session, The Lower Churchill Development Act was passed to facilitate the development of the hydro-electric power potential of the Lower Churchill River.

A new Provincial Anthem Act was enacted in this Session, providing legislative recognition of the words and the music of the provincial anthem, the "Ode to Newfoundland".

MR. SPEAKER AND MEMBERS OF THE HONOURABLE HOUSE OF ASSEMBLY:

This Session has seen another advance in the area of health. The Generac Drugs Act was passed to provide for the substituting of prescribed drugs by their lowest cost generic equivalent, unless otherwise specifically directed by a doctor. The Pharmaceutical Association Act was amended to remove the requirement that the governing body of the association have at least eight councillors from St. John's and also to provide for regional representation on the council. The Medical Act was amended to provide that the Registrar of the Newfoundland Medical Board could be a medical practitioner who is not a member of the Board.

In the area of education there were amendments in this Session® to The Schools Act requiring School Boards to organize special classes for handicapped children within their school systems or by arrangements with extra-provincial educational authorities. Amendments to that Act also provided that capital expenditure for native education, which is shared by Canada and the province, would be excluded from the traditional arrangement that apportions capital grants on a per capita basis.

In this Session amendments were made to The Workers' Compensation Act that removed the limitation on compensation payable to a Newfoundland worker who is employed outside the province for a period in excess of eight months. The amendments also permit my Government to increase compensation by Order in Council. Amendments were made to The Occupational Health and Safety Act enabling the making of electrical regulations, adopting electrical codes or standards and providing for the appointment of advisory committees on technical matters.

Important seemdments were made to the Public Service (Pensions)
Act. These amendements comble the Pension Plan to be fonded and provide
It with the authority to absorb existing pension funds of employees
who are thought into the Pension Plan by regulation. The Increase
of Pensions Act, 1979 provides increases in pensions to public
servants.

MR. SPEAKER AND MEMBERS OF THE HONOURABLE HOUSE OF ASSEMBLY:

I thank you for the large measure of supply you have granted. I assure you that the appropriations that you have granted will be expended by my Ministers with care and efficiency.

It is my pleasure that the First Session of this Thirty-Eighth General Assembly now be prorogued and it is prorogued accordingly.
