and holden at St. John's in the Province of Newfoundland on Wednesday, the twenty-fifth day of February, Anno Domini, Nineteen Hundred and Eighty-one, being the twenty-ninth year of the reign of Her Majesty, our Sovereign Lady, Elizabeth the Second, by the Grace of God of the United Kingdom, Canada and Her other Realms and Territories, QUEEN, Head of the Commonwealth, Defender of the Faith.

His Honour the Lieutenant-Governor having fixed the hour at which he proposed to open the present Session of the Legislature at three of the clock in the afternoon of this Wednesday, the twenty-fifth day of February, the Members of the House of Assembly met in the Assembly Chamber at three of the clock in the afternoon when Mr. Speaker took the Chair.

At three of the clock the Sergeant-at-Arms announced that His Honour the Lieutenant-Governor had arrived.

His Honour entered the Assembly Chamber preceded by the Sergeant-at-Arms.

Mr. Speaker left the Chair.

His Honour the Lieutenant-Governor took the Chair.

His Honour was then pleased to open the Session with a Speech From The Throne.

His Honour the Lieutenant-Governor then left the Assembly Chamber.

Mr. Speaker resumed the Chair.

On motion of the Honourable the President of the Council and by leave of the House, a Bill entitled, "An Act To Provide For The Protection Of The Forests Of The Province From Insects And Disease," was introduced and read a first time.

On motion it was ordered the said Bill be read a second time on tomorrow.

Mr. Speaker announced that His Honour the Lieutenant-Governor had been pleased to make a Speech to the Members met in the General Assembly and that for greater accuracy he had obtained a copy.

It was unanimously agreed that the Speech From The Throne should be taken as read.

It was moved by the Honourable the Member for Burgeo-Bay d'Espoir and seconded by the Honourable the Member for Baie Verte - White Bay that an Address of Thanks be presented to His Honour in reply to the Gracious Speech with which he had been pleased to open the present Session of the Legislature and that a Select Committee be appointed to draft such Address In Reply.

It was ordered accordingly and the following Members were appointed to the said Committee:

The Honourable the Member for LaPoile gave notice that he would on tomorrow move the following Resolution:

WHEREAS the cost of living in Newfoundland and Labrador is the highest in Canada and continues to rise;

AND WHEREAS inflation and the ever increasing cost of living is causing great torment, frustration and mental and physical strain on the citizens of Newfoundland and Labrador;

AND WHEREAS most of the factors involved in determining the cost of living fall under Provincial jurisdiction;

BE IT RESOLVED that this House set up a Select Committee to examine into all aspects of inflation and prepare recommendations as to how the Government should proceed to cope with these matters.

The Honourable the Member for Menihek gave notice that he would on tomorrow move the following Resolution:

WHEREAS the people of Labrador should enjoy the same standard of services as Island residents of the Province;

AND WHEREAS better transportation and community services are necessary for the development of a vibrant Labrador society;

AND WHEREAS the Government of the Province has a proposal before the Federal Government on a coastal Labrador DREE Agreement;

AND WHEREAS the Government of the Province has a proposal before the Federal Government for a start on the Trans Labrador Highway;

AND WHEREAS the Province is ready to move on both of these matters now;

THEREFORE BE IT RESOLVED that this Honourable House

urge the Federal Government to live up to its responsibilities and sign these agreements at the earliest possible opportunity.

The Honourable the Member for St. Mary's - the Capes gave notice that he would on tomorrow move the following Resolution:

WHEREAS the Province of Newfoundland and Labrador has the highest unemployment record in Canada;

AND WHEREAS there are a number of areas in the Province where the unemployment figures are far beyond the Provincial average;

AND WHEREAS many areas of the Province depend on a single resource;

AND WHEREAS the resources already known and available to our Province could, if properly developed, provide full and permanent employment to everyone in the growing Newfoundland and Labrador labour force;

BE IT THEREFORE RESOLVED that this House fully debate all aspects of Resource Development in the Province of Newfoundland and Labrador;

AND BE IT FURTHER RESOLVED that the Government target areas of high unemployment with a view to producing a plan for joint Federal/Provincial co-operation aimed at improving the economy of those areas and to creating long term jobs for unemployed residents of this Province.

The Honourable the Member for Baie Verte-White Bay gave notice that he would on tomorrow move the following Resolution:

WHEREAS the Province of Newfoundland and Labrador has a moral and legal claim to the minerals on the Continental Shelf;

AND WHEREAS the Federal Government does not recognize our claim:

AND WHEREAS the Province has the regulations and expertise necessary for the wise development of such offshore minerals;

AND WHEREAS the Hibernia oil and gas field can have significant

negative impact on our society and our environment;

AND WHEREAS the Province needs revenues and jobs from offshore oil and gas to better our society;

AND WHEREAS the Government of the Province has shown that oil and gas development under our regulations with oil at world prices would only make us a "have" Province for three years of a twenty-year development;

AND WHEREAS under our regulations, 25 percent of each dollar earned is shared with the Federal Government and 35 percent goes to the companies developing the resource;

AND WHEREAS this percentage is reasonable and consistent with revenue sharing currently being enjoyed by other producing Provinces;

NOW THEREFORE BE IT RESOLVED that this Honourable House urge the Federal Government to reconsider its position on offshore minerals and recognize the Province's legitimate right to ownership and control of them.

The Honourable the Member for Windsor-Buchans gave notice that he would on tomorrow move the following Resolution:

WHEREAS the Province of Newfoundland and Labrador will experience a serious electrical power shortage by the year 1985, and that such shortages will increase significantly each year thereafter;

WHEREAS the only on-island source of available electrical energy to offset these shortages is by adding oil-fired generating capacity to the Holyrood Generating Station, thereby subjecting our people and industries to unbearable electrical energy costs;

WHEREAS the development of the Muskrat Falls power site would for the foreseeable future provide Newfoundland and Labrador with a stable, long-term supply of relatively low-cost electrical energy;

WHEREAS in June, 1980, the Lower Churchill Development Corporation recommended to the Government that an immediate start be made on the development of the Muskrat Falls power site, assuring Government in its report and recommendation that the project is economically and technically feasible; that there is no dependence on the exportation of surplus power; and that an intertie with the Island part of the Province is feasible by a sub-sea cable crossing;

THEREFORE BE IT RESOLVED that Government accept the recommendations of the Lower Churchill Development Corporation and make an immediate start on the Muskrat Falls project, the short-term benefit being the jobs and general boost to the economy of Newfoundland and Labrador, and the long-term benefit being a stable, relatively low-cost source of electrical power for this Province.

The Honourable the Member for Stephenville gave notice that he would on tomorrow move the following Resolution:

WHEREAS the Federal Government has acted unilaterally to change the Canadian Constitution in spite of opposition from eight provincial governments and contrary to the principle of consensus;

AND WHEREAS the Federal Government's constitutional proposals threaten the powers of the provinces and, in the case of Newfoundland, remove existing protection from the sacred rights enshrined in our Terms of Union;

AND WHEREAS the Federal Government's unilateral actions are divisive and contrary to the concept of federalism as historically recognized in Canada;

THEREFORE BE IT RESOLVED that this House endorses the position of the Government as set forth in its white paper : "Towards the Twenty First Century - Together."

The Honourable the Member for St. Barbe gave notice that he would on tomorrow move the following Resolution:

WHEREAS the high cost of living in this Province has placed an unbearable burden on those who are dependent on Government assistance;

WHEREAS we profess to live in a society based on equal rights and opportunity for all;

BE IT RESOLVED that this House urge the Government to take

measures to make adequate provision for those for whom society is responsible.

The Honourable the Member for Harbour Main-Bell Island gave notice that he would on tomorrow move the following Resolution:

WHEREAS our present sources of electricity will not be sufficient to meet our power demands by 1984-85;

AND WHEREAS a Province with such great hydro potential ought not to be dependent on foreign oil supplies for any of its electricity needs;

AND WHEREAS this Province has been frustrated in its efforts to develop its vast hydro resources for the economic and social benefits of its people;

AND WHEREAS development of Gull Island power can give new economic life to the depressed Happy Valley-Goose Bay area;

AND WHEREAS it is the responsibility of the Federal Government to ensure Newfoundland's right to transmit its hydro power through neighbouring provinces in the same way other provinces are permitted to transmit their oil and gas;

AND WHEREAS alternative routes for the transmission and sale of our surplus power will prove more expensive;

THEREFORE BE IT RESOLVED that this House urge the Government of Canada to uphold this Province's right to fair and equal treatment in the transmission of its energy resources;

The Honourable the Member for Burin-Placentia gave notice that he would on tomorrow move the following Resolution:

WHEREAS there is an obvious lack of Provincial planning and knowledge in Newfoundland and Labrador's fishery;

AND WHEREAS the Fishermen's Union, the Industry, the fishermen and the Federal Department of Fisheries and Oceans appear to be drifting in different directions;

BE IT RESOLVED that the Government immediately set as its priority a comprehensive long term strategy for our fishery and a

Select Committee be appointed to insure that this becomes a reality.

The Honourable the Member for Conception Bay South gave notice that he would on tomorrow move the following Resolution:

WHEREAS an up to standard Trans Canada Highway is essential to the social and economic development of the Province;

AND WHEREAS our present Trans Canada Highway is not up to Canadian standards and is currently in bad repair;

AND WHEREAS this Province should be treated fairly in relation to other provinces;

AND WHEREAS the Provincial Government has a porposal before the Federal Government for the continued upgrading of the Trans Canada Highway;

AND WHEREAS the Provincial Government is ready now with its normal share of the cost of this project;

THEREFORE BE IT RESOLVED that this Honourable House go on record as urging the Federal Government to live up to its responsibilities for the Trans Canada Highway, and sign an agreement with the Province on this matter as soon as possible.

The Honourable the Member for Port au Port gave notice that he would on tomorrow move the following Resolution:

WHEREAS there is still a large proportion of the secondary roads of this Province which are unpaved and generally in deplorable condition:

AND WHEREAS there is much natural resource potential in the areas concerned especially fisheries, forestry, agriculture and tourism;

AND WHEREAS the maximum development of these resources requires an effective transportation system;

AND WHEREAS the people of these areas are subjected to physical discomforts and extremely higher operating and maintenance costs;

BE IT RESOLVED that the Government of Newfoundland and

Labrador escalate their road construction and paving programme;

AND BE IT FURTHER RESOLVED that a programme of action be announced during this Session of the House of Assembly.

The Honourable the Member for St. John's West gave notice that he would on tomorrow move the following Resolution:

WHEREAS the Port of St. John's has no effective means of fire protection for shipping using the port, and for certain waterfront facilities:

AND WHEREAS this protection can only be provided by means of a properly outfitted and manned fire tug;

AND WHEREAS the activities surrounding the Port of St. John's are increasing at a rapid rate, relative to the use and handling of explosives, petroleum products, and other highly inflammable materials;

AND WHEREAS it is absolutely essential for the safe and effective operation of the Port of St. John's that an adequate fire protection system be provided;

NOW THEREFORE BE IT RESOLVED that this Honourable House urge the St. John's Port Authority and the National Harbours Board to undertake its full responsibility to initiate the providing of this fire tug and protection service.

The Honourable the Member for Terra Nova gave notice that he would on tomorrow move the following Resolution:

WHEREAS unemployment in this Province is still the highest in Canada and is reaching record proportions among young people between the ages of 16 to 25 years old;

AND WHEREAS students from the Province's high schools and post-secondary institutions will shortly be pouring out of these educational institutions in pursuit of jobs;

AND WHEREAS the outlook for this construction season is very bleak;

AND WHEREAS job opportunities for these young people in every

economic sector of the Province appear to be extremely minimal;

BE IT RESOLVED that the Provincial Government present before this House immediately specific plans and details for the short term and long term resolution to this urgent and pressing problem.

The Honourable the Member for Kilbride gave notice that he would on tomorrow move the following Resolution:

WHEREAS it is obviously desirable for this Province to expand its role in marine related activity;

AND WHEREAS the St. John's Dockyard is in need of upgrading;

AND WHEREAS the provision of a synchrolift facility is essential in this regard;

AND WHEREAS the Province is willing to shoulder the Federal Government's responsibility to see that this project gets financing;

THEREFORE BE IT RESOLVED that this Honourable House go on record as commending the Provincial Government's efforts to get this project going at the earliest possible date.

The Honourable the Member for Trinity-Bay de Verde gave notice that he would on tomorrow move the following Resolution:

WHEREAS Newfoundland and Labrador's society may be dramatically changed because of the present offshore gas and oil exploration;

AND WHEREAS our society may undergo even more dramatic changes with the impending development and production stages of offshore oil and gas;

THEREFORE BE IT RESOLVED that this House urge the Government to insure that the Department of Education will take all necessary steps to modify the functioning of our educational system to meet the needs of our new society whilst preserving the good traditions of our past and present society, and thereby more adequately prepare our people for present and future job opportunities.

The Honourable the Member for Bay of Islands gave notice that he would on tomorrow move the following Resolution: WHEREAS THE Gros Morne National Park has been recognized as one of the most attractive areas of Canada;

AND WHEREAS the Humber Valley has long been a site for recreation and sightseeing;

AND WHEREAS the Marble Mountain ski facility is rapidly becoming one of the most popular ski centres in eastern Canada;

AND WHEREAS the Bay of Islands offers great attractions for marine oriented recreation;

AND WHEREAS there exists additional potential for development of tourist attractions in the Western region;

AND WHEREAS the tourist industry offers great opportunity for year round employment;

THEREFORE BE IT RESOLVED that the Government of Newfoundland and Labrador encourage the further development of these attractions and of additional attractions and that every effort be made to promote this area as a major recreational centre.

The Honourable the Member for Lewisporte gave notice that he would on tomorrow move the following Resolution:

WHEREAS Legislative Assemblies of most Canadian provinces and the House of Commons now permit live coverage of debates on television and radio;

AND WHEREAS Legislatures of other Assemblies throughout the democratic world also permit television and radio coverage of their Parliaments;

AND WHEREAS important matters concerning the people of this Province will be brought up for debate in this coming Assembly, perhaps matters more important than ever before debated in this House;

BE IT THEREFORE RESOLVED that this House approves the principle of live coverage of all House of Assembly debates and live coverage of all Committees of this House of Assembly;

AND BE IT FURTHER RESOLVED that a Committee be struck

comprising Members of this House to negotiate with radio and television networks to provide for coverage of this House;

AND BE IT FURTHER RESOLVED that a simple majority of this House or a Committee of this House decide whether or not television and radio be permitted to carry live coverage of debates in this House and in Committees of this House.

The Honourable the Member for St. John's Centre gave notice that he would on tomorrow move the following Resolution:

WHEREAS 1981 is the International Year of the Disabled;

AND WHEREAS this Government recognizes the equal right of its disabled citizens to participate fully in all factions of our society;

AND WHEREAS this Government believes that obstacles can be overcome;

AND WHEREAS this Government has determined to improve educational facilities for the deaf and the blind;

AND WHEREAS this Government has announced its intention to develop a programme of employment incentives for the disabled;

AND WHEREAS Government will recognize the outstanding achievements of disabled persons by awarding medals for their accomplishments;

THEREFORE BE IT RESOLVED that this Honourable House go on record as commending Government for being aware of the special needs of disabled persons in this Province and of the necessity of working with them in order to achieve their aims and objectives.

The Honourable the Member for Torngat Mountains gave notice that he would on tomorrow move the following Resolution:

WHEREAS there are no banking facilities along the Labrador Coast;

AND WHEREAS the nearest banking facilities are situated in

Happy Valley-Goose Bay, many miles away with the only means of travel from the coast being by plane and boat;

AND WHEREAS now residents have to depend upon an irregular mail service to carry on their banking business;

BE IT THEREFORE RESOLVED that the Government of this Province use their influence to encourage banks to offer services to remote areas of this Province.

The Honourable the Member for Humber West gave notice that he would on tomorrow move the following Resolution:

WHEREAS the need for additional harbour facilities for the Port of Corner Brook have long been identified;

AND WHEREAS progress had been made on the provision of serviced industrial land and on certain transportation facilities;

AND WHEREAS improvements to harbour front facilities are urgently needed;

AND WHEREAS the Waterfront Drive and the Harbour Arterial Road must be extended to accommodate increased activities and to connect the port facilities with the new industrial park;

THEREFORE BE IT RESOLVED that the Department of Regional Economic Expansion be urged to provide the necessary funding to construct these facilities at an early date.

The Honourable the Member for Fogo gave notice that he would on tomorrow move the following Resolution:

WHEREAS the sawmilling industry historically has been one of the cornerstones of Newfoundland's rural economy;

AND WHEREAS there has been significant public financing of Newfoundland's sawmilling industry in the past several decades;

AND WHEREAS the sawmilling industry has in recent years been experiencing serious difficulties;

AND WHEREAS the 1973 Federal/Provincial Task Force recommended the establishment of larger mills in selected areas of

the Province;

AND WHEREAS the Royal Commission on Forest Protection and Management (1981) states that the sawmilling industry may indeed fall below its present production level;

THEREFORE BE IT RESOLVED that this House establish a Select Committee to look into all aspects of the sawmilling industry and make recommendations to the House at the earliest possible date as to how the sawmilling industry can be rehabilitated.

The Honourable Member for Exploits gave notice that he would on tomorrow move the following Resolution:

WHEREAS the forest industry of Newfoundland and Labrador employs over 18,000 people in this Province;

AND WHEREAS our forest resources have suffered over the last forty to fifty years due to inadequate resource protection and management;

AND WHEREAS Government has moved to replace long term concessions to paper companies with short term conditional agreements;

AND WHEREAS Government has introduced new policies for the maximum protection and harvesting of the resource and the creation of over one thousand new jobs in the industry;

THEREFORE BE IT RESOLVED that this House commend the Government for its new and bold advances in the wise development of this valuable resource.

The Honourable Member for Grand Bank gave notice that he would on tomorrow move the following Resolution:

WHEREAS there is a growing concern in the City of St. John's over the many grievances that the Police Brotherhood have with the Government of Newfoundland and Labrador;

AND WHEREAS there is a growing concern in the City of St. John's that the City is being inadequately policed;

AND WHEREAS many citizens are concerned for their safety

and the safety of the Policemen;

AND WHEREAS the Government of the Province of Newfoundland and Labrador has consistently refused to set up an independent commission to investigate the grievances of the Police Brotherhood and the concerns of the City of St. John's with respect to the safety of its citizens;

THEREFORE BE IT RESOLVED that this House urges the Government to set up an independent commission to investigate all matters affecting the Royal Newfoundland Constabulary.

The Honourable Member for Placentia gave notice that he would on tomorrow move the following Resolution:

WHEREAS the North Side of the United States Naval Station has been transferred to the Government of Canada;

AND WHEREAS the area has been subleased to the Province of Newfoundland and Labrador;

AND WHEREAS this facility contains an airport, docking facilities, fuel storage, buildings, ice free harbour, etc.;

AND WHEREAS there chas been approposal to testablish as major site for activities related to the development of offshore resources;

AND WHEREAS the prosecution of the fishing industry has traditionally been a major economic factor in the area;

THEREFORE BE IT RESOLVED that the Department of Development and the Department of Fisheries make every effort to ensure that the full industrial potential of Argentia be encouraged and realized in a manner which does not interfere or detract from the long term enjoyment of the fishing industry.

The Honourable the Member for Fortune-Hermitage gave notice that he would on tomorrow move the following Resolution:

WHEREAS the fishery is the economic and social backbone of our Province;

AND WHEREAS problems and questions concerning this vital

resource are the subject of study by a Royal Commission on the Inshore Fishery;

AND WHEREAS the constitutional debate concerning jurisdiction over the fishery is still ongoing;

AND WHEREAS the Government of Canada has, with great swiftness, introduced radical policies affecting the management and allocation of the resource and the right of our fishermen to full-time participation in the industry;

AND WHEREAS such policies could have drastic effects on hundreds of our small rural communities that depend on the inshore fishery for their survival;

THEREFORE BE IT RESOLVED THAT this House urge the Government of Canada to hear the results of the Royal Commission on the Inshore Fishery and consider all factors carefully and with the best interests of this Province in mind before proceeding with initiatives in this area;

AND BE IT FURTHER RESOLVED that this House urge the Government of Canada to recognize the right and necessity of this Province to have some control over this, its major resource.

On motion it was ordered that when this House rises it adjourn until tomorrow, Tuesday, March 3rd at three of the clock.

On motion the House then adjourned accordingly.

- A Bill "An Act To Amend And Revise The Law Providing For Accessibility To Buildings For Physically Disabled Persons".

His Honour the Lieutenant-Governor then said, "In Her Majesty's Name, I assent to these Bills."

His Honour then left the Assembly Chamber.

The Honourable the President of the Council moved, "That when this House adjourns today it will stand adjourned until Thursday, February 25th, 1982 at 3:00 p.m., provided always that if it appears to the satisfaction of Mr. Speaker or in the case of his absence from the Province, the Chairman of Committees, after consultation with Her Majesty's Government, that the House should meet at an earlier time than the adjournment, the Speaker, or in his absence, the Chairman of Committees may give notice that he is so satisfied and thereupon the House shall meet at the time stated by such notice and shall transact its business as if it had been duly adjourned to that time".

The House divided.

There appeared in favour of the motion: The Hon, the Premier, the Hon. the Minister of Development, the Hon. the Minister of Forest Resources and Lands, the Hon. the Minister of Fisheries, the Hon. the Minister of Municipal Affairs and Housing, the Hon. the Minister of Public Works and Services, Mr. Butt, the Hon. the Minister of Culture, Recreation and Youth & Enviornment, the Hon. the Minister of Labour and Manpower, the Hon. the Minister of Finance, the Hon. the President of the Council, the Hon. the Minister of Rural, Agricultural and Northern Development, the Hon. the Minister of Education, the Hon. the Minister of Health, Mr. Breti, Mr. Walsh, Mr. Baird, Mr. Rideout, Mr. Stagg, Mr. Collins, Mr. Carter, Dr. Twomey, Mr. Doyle, Mr. Patterson, Mr. Aylward, Dr. McNicholas, Mr. Stewart, Mr. Barry.

Against: Mr. Flight, Mr. Lush, Mr. Hodder, Mr. Roberts, Mr. Thoms, Mr. Bennett, Mr. Hollett, Mr. Warren, Mr. Tulk, Mr. Hancock, Mr. Hiscock, Mr. Callan.

An Act Respecting Private Investigation and Security Services was passed to repeal and replace the existing legislation in order to keep pace with changes in the demand for commercial security services. The Fire Prevention Act was amended to provide that where it is necessary, fire lanes on private or public property may be designated as a highway for the purposes of The Highway Traffic Act. In order to remove the appearance of undue interference with judicial discretion, amendments were made to all Acts removing the discretion by the Minister of Justice to allow suspended sentences or discharges.

MR. SPEAKER AND MEMBERS OF THE HONOURABLE HOUSE OF ASSEMBLY:

This Session occurred during the International Year of the Disabled, so it was fitting that my Government directed its attention to assuring the basic rights of disabled citizens. To this end, the Newfoundland Human Rights Code was amended to include physical disability as a basis on which discrimination is prohibited under the Act. An Act To Provide Certain Rights For Blind Persons was also passed and gave to blind persons and their guide dogs the right to facilities customarily available to the public and the right to housing without discrimination.

My Government is committed to the policy that physically disabled persons should have access to buildings, and facilities in buildings, that are available to other members of the public and during this Session a new Act To Amend And Revise The Law Providing For Accessibility To Buildings For Physically Disabled Persons was passed.

The Child Welfare Act was amended to include, specifically in legislation, that the best interests of the child are of paramount importance under the Act and to specify certain considerations in determining those best interests.

MR. SPEAKER AND MEMBERS OF THE HONOURABLE HOUSE OF ASSEMBLY:

My Government is greatly concerned about the health of the people of the Province and during this Session The Denturists Act was passed to provide for a board to regulate and license denturists. The Optometry Act, 1981 was also passed respecting the Newfoundland Association of Optometrists and governing the practice of optometry in the Province. Another Act, The Dispensing Opticians Act, was passed during this Session to provide for a board to supervise the practice of optical dispensing.

Mr. Speaker declared the motion carried, The House then adjourned accordingly.

The House met at three of the clock pursuant to adjournment.

The Sergeant-at-Arms announced the arrival of His Honour the Lieutenant-Governor.

Mr. Speaker left the Chair,

His Honour the Lieutenant-Governor took the Chair and delivered a Speech From The Throne as follows:

MR. SPEAKER AND MEMBERS OF THE HONOURABLE HOUSE OF ASSEMBLY:

The Third Session of the Thirty-Eighth General Assembly of this Honourable House of Assembly is about to be prorogued, but before releasing you from your duties I wish to convey to you my appreciation for the careful and sympathetic attention you have given to the important matters brought before you by my Ministers.

I wish to note the most tragic loss of eighty-four men in the recent Ocean Ranger disaster. It is with my deepest sympathy to the families of those who died that I would invite all Honourable Members to rise with me now for a minute of silence in respect of those men.

Major legislative initiatives were enacted during this Session of this Honourable House of Assembly, particularly in the areas of health, the administration of justice and social services.

In the area of the administration of justice several singnificant legislative measures were enacted.

The Freedom of Information Act was passed to provide persons with a statutory right to have access to information under the control of provincial government departments or certain government bodies. In addition to The Freedom of Information Act, The Privacy Act was passed to create the actionable tort of violation of privacy and the Act provides a civil remedy for recovery of damages.

The Attachment of Wages was amended to increase the amount exempt from attachment or execution permitted under the Act. The Judicature Act was amended to increase by one the number of judges in both Divisions of the Supreme Court.

As an indication that my Government is concerned about the safety of people in the Province on our highways, The Highway Traffic Act was amended to provide for the compulsory use of seat belts and child seating and restraint systems in motor vehicles.

As another indication of my Government's concern for the health and safety of people in the Province, an Act was passed to establish the Alcohol and Drug Dependency Commission of Newfoundland and Labrador.

During this Session The Workers' Compensation Act was amended to extend the benefits of the Act to cover students participating in work training programs. The Act was also amended to extend coverage for compensating volunteer firefighters.

MR. SPEAKER AND MEMBERS OF THE HONOURABLE HOUSE OF ASSEMBLY:

The Volunteer War Service Medal Act was passed to recognize those veterans of the Province who volunteered to serve in the British Imperial Forces during the Second World War.

My Government was determined that the Province should be prepared for developments in relation to petroleum and so established the Petroleum Directorate by passing an amendment to The Department of Mines And Energy Act, 1973. The term of the Option Agreement between the Government and the Lower Churchill Development Corporation Limited was extended from thirty to forty months under The Lower Churchill Development Option Amendment Act. Various other amendments resulted in the reorganization of certain government departments and an Act was passed to establish The Department of Environment. The St. John's Housing Corporation was abolished and its assets and liabilities were transferred to the Newfoundland and Labrador Housing Corporation under an amendment to The Newfoundland and Labrador Housing Corporation Act.

MR. SPEAKER AND MEMBERS OF THE HONOURABLE HOUSE OF ASSEMBLY:

In the area of finance, The Financial Administration Act, 1973 was amended to separate the roles of Comptroller and Deputy Minister of Finance. An Act Respecting The Garnishment

Against The Remuneration Of Public Officials was passed that removes the immunity in respect of garnishment proceedings against civil servants and other public officials. The Pensions Funding Act was enacted to establish the Province of Newfoundland Pooled Pension Fund that will absorb and fund certain pension plans and retirement benefits sponsored by the Province. The Increase of Pensions Act, 1981 provides increases in pensions to public servants.

In an effort to bring my Government matters relating to the youth of the Province, An Act To Establish The Newfoundland and Labrador Youth Advisory Council was passed during this Session.

In order to foster development of local government in the Province, The Municipalities Act was amended to remove a municipality's authority to sell real property for tax' arrears when that property is occupied by the owner for residential purposes.

MR. SPEAKER AND MEMBERS OF THE HONOURABLE HOUSE OF ASSEMBLY:

My Government was concerned about the protection of the forests of the Province from insects and disease and passed during this Session an amendment to The Department Of Forests And Lands Act.

Among the other significant legislative measures enacted during this Session were An Act To Amend And Consolidate The Law Respecting Boilers, Pressure Vessels And Compressed Gas, An Act Respecting Amusement Rides, An Act Respecting The Drilling Of Water Wells And The Conservation And Use Of Ground-Water.

MR. SPEAKER AND MEMBERS OF THE HONOURABLE HOUSE OF ASSEMBLY:

During this Session, three Select Committees of this Honourable House were struck, namely, the Select Committee on Resource Management, the Select Committee to examine draft legislation on Elections, Controverted Elections and Election Financing and the Select Committee to examine draft legislation on the incorporation of the Certified General Accountants and draft legislation relating to Corporation Law.

My Government looks forward to the reports of these Committees being received by this Honourable House during the forthcoming Session.

MR. SPEAKER AND MEMBERS OF THE HONOURABLE HOUSE OF ASSEMBLY:

I thank you for the large measure of supply you have granted. I assure you that the appropriations that you have granted will be expended by my Ministers with care and efficiency.

It is my pleasure that the Third Session of this Thirty-Eighth General Assembly now be prorogued and it is prorogued accordingly.
