Mifflin, Honourable T. Alexander Hickman, Honourable N.S. Noel, Honourable H.B. Morgan, Honourable J.W. Mahoney, Honourable N.H. Goodridge, Honourable J.R. Gushue, Honourable R.E. Fagan, Honourable G.L. Steele and Honourable G.F. Lang, or any of you, are hereby authorized and directed to signify to the Members of the said House of Assembly on the tenth day of May, 1982, that it is my pleasure that they should proceed to the choice of some person to be their Speaker and present such person on the same day for my approbation.

The Honourable Arthur S. Mifflin, Chief Justice of Newfoundland, one of the said Commissioners, then said:

Members of the House of Assembly,

We have it in command from His Honour the Lieutenant-Governor to acquaint you that His Honour will, as soon as the Members of this House shall be sworn; declare that causes of his calling this Assembly, and, it being necessary that a Speaker of this House should be first chosen, it is His pleasure that you do proceed to the appointment of some proper person to be your Speaker; and that you present such person whom you shall so choose here today at three of the clock for His Honour's approbation.

And the Judges having left the Assembly Chamber, the Honourable the Premier then addressed himself to the Clerk, who, standing up, pointed to him and then sat down; moved "That Maxwell James Russell, Esquire, Member for the District of Lewisporte, do take the Chair of the House as Speaker", which motion was seconded by the Honourable the Leader of the Opposition, Esquire, Stephen Neary, Esquire, Member elected for the District of LaPoile.

No other person being proposed as Speaker, Mr. Russell was unanimously called by the House to the Chair, and was conducted to the Chair by the Members who proposed and seconded him.

The Honourable the Premier moved, "That Robert Aylward, Esquire, Member for the District of Kilbride, do take the Chair as Chairman of Committees and Deputy Speaker of the House," which motion was seconded by the Honourable the Leader of the Opposition, Stephen Neary, Esquire, Member elected for the District of LaPoile.

No other person being proposed as Chairman of Committees and Deputy Speaker of the House, Mr. Aylward was unanimously elected as Chairman of Committees and Deputy Speaker.

The Honourable the Premier moved, "That Patrick McNicholas, Esquire, Member for the District of St. John's Centre, do take the Chair as Deputy Chairman of Committees," which motion was seconded by the Honourable the Leader of the Opposition, Stephen Neary, Esquire, Member elected for the District of LaPoile.

No other person being proposed as Deputy Chairman of Committees, Dr. McNicholas was unanimously elected as Deputy Chairman of Committees.

The House then adjourned until three of the clock.

The House met at three of the clock pursuant to adjournment.

At three of the clock the Sergeant-at-Arms notified Mr. Speaker that His Honour the Lieutenant-Governor, Honourable W. Anthony Paddon, had arrived, whereupon Mr. Speaker vacated the Chair.

The Sergeant-at-Arms preceded His Honour the Lieutenant-. Governor to the Chair.

Whereupon the Lieutenant-Governor, having taken his seat, the Honourable the Premier addressed His Honour as follows:

"May it please Your Honour, the House of Assembly, agreeable to Your Honour's Command, have proceeded to the choice of a Speaker, and have elected Maxwell James Russell, Esquire, Member for the District of Lewisporte, to that office, and by their direction, I present him for the approbation of Your Honour."

His Honour was then pleased to reply:

"On behalf of Her Majesty, I assure you of my sense of your efficiency and I do most fully approve and confirm you as the Speaker."

The Honourable the President of the Council asked leave to introduce a Bill entitled, "An Act To Amend The Highway Traffic Act".

On motion of the Honourable the President of the Council and by leave of the House, the said Bill was introduced and read a first time.

On motion it was ordered the said Bill be read a second time on tomorrow.

Mr. Speaker announced that His Honour the Lieutenant-Governor had been pleased to make a Speech to the Members met in the General Assembly and that for greater accuracy he had obtained a copy.

It was unanimously agreed that the Speech should be taken as read.

It was moved by the Honourable the Member for St. Mary's—The Capes and seconded by the Honourable the Member for Twillingate that an Address of Thanks be presented to His Honour in reply to the gracious Speech with which he had been pleased to open the present Session of the Legislature and that a Select Committee be appointed to draft such Address In Reply.

It was ordered accordingly and the following Members were appointed to the said Committee:

Mr. Loyola Hearn, St. Mary's-The Capes Mrs. Ida Reid, Twillingate Mr. Eugene Hiscock, Eagle River

The Honourable the Minister of Finance gave notice that he would on tomorrow, "Ask this House to Resolve itself Into A Committee of the Whole on Supply to Consider Certain Resolutions for the Granting of Interim Supply To Her Majesty."

The Honourable the Member for Terra Nova gave notice that he would on tomorrow move the following Resolution:

WHEREAS the Province of Newfoundland and Labrador has the highest unemployment record in Canada;

AND WHEREAS there are a number of areas in the Province where the unemployment figures are far beyond the Provincial average;

AND WHEREAS many areas of the Province depend on a single resource;

AND WHEREAS the resources already known and available to our Province could, if properly developed, provide full and permanent employment to everyone in the growing Newfoundland and Labrador labour force;

BE IT THEREFORE RESOLVED that this House fully debate all aspects of Resource Development in the Province of Newfoundland and Labrador;

AND BE IT FURTHER RESOLVED that the Government target areas of high unemployment with a view to producing a plan for joint Federal/Provincial co-operation aimed at improving the economy of those areas and to creating long term jobs for unemployed residents of this Province.

The Honourable the Member for Stephenville gave notice that he would on tomorrow move the following Resolution:

WHEREAS the Provincial Government entered into offshore negotiations with the Federal Government on the understanding that the ownership issue had been put aside:

AND WHEREAS the Federal Government requested and obtained an expansion of the SIU labour relations court case into the area of offshore ownership during the period of negotiations;

AND WHEREAS the Provincial Government subsequently referred the offshore ownership issue to the Newfoundland Supreme Court;

BE IT THEREFORE RESOLVED that this Honourable House support the position of the Newfoundland Government in that it is willing to reopen negotiations on the offshore issue with the Federal Government as soon as the Federal Government agrees to set the ownership issue aside for the duration of the negotiations and permanently should an agreement be reached.

The Honourable the Member for Fogo gave notice that he would on tomorrow move the following Resolution:

WHEREAS the fishery is the main thread of Newfoundland's social, cultural and economic fabric;

AND WHEREAS both the inshore and offshore sectors of the Province's fishery are in a state of crisis;

AND WHEREAS there is no coherent or cohesive policy being pursued by the present Provincial Government;

AND WHEREAS it seems apparent that the present Provincial Government has neither the desire nor the ability to develop long-term strategies or policies for the Province's fishery.

BE IT THEREFORE RESOLVED that this Honourable House immediately set as its top priority the development of a comprehensive long-term policy for the Newfoundland fishery;

AND BE IT FURTHER RESOLVED that a Select Committee of this House be appointed to ensure that this policy becomes a reality.

The Honourable the Member for St. Mary's-The Capes gave notice that he would on tomorrow move the following Resolution:

WHEREAS the development of the inshore fishery is the only realistic way of solving rural Newfoundland's unemployment problems;

AND WHEREAS Federal Government policy on the inshore fishery is detrimental to this effect, especially as it relates to the harvesting of the northern cod stock;

BE IT THEREFORE RESOLVED that this Government request the Federal Government to adopt a much more reasonable stand as it relates to this matter. The Honourable the Member for the Strait of Belle Isle gave notice that he would on tomorrow move the following Resolution:

BE IT RESOLVED (a) that the House directs that the electronic media be given full and complete access to the proceedings of both the House and its Committees, and (b) that a Select Committee of three Members be appointed to work out those steps which must be taken to enable the electronic media to have such full and complete access.

The Honourable the Member for Grand Bank gave notice that he would on tomorrow move the following Resolution:

WHEREAS there has been considerable loss of life off the shores of our Province during the past years, and in particular the recent tragic loss of the Ocean Ranger;

AND WHEREAS there is no major Search and Rescue facility located in this Province;

AND WHEREAS a local facility could shorten the response time in the event of an emergency at sea;

BE IT THEREFORE RESOLVED that this Honourable House urge the Federal Government to set up a Search and Rescue facility in the Province of Newfoundland and Labrador:

The Honourable the Member for Torngat Mountains gave notice that he would on tomorrow move the following Resolution:

WHEREAS the only means of travel throughout Coastal Labrador for most of the year is by air;

Bold water Bleevening

AND WHEREAS the cost of such travel is beyond the means of most Labrador residents:

AND WHEREAS there is presently a Newfoundland and Labrador subsidy in existence that is of no assistance to the people travelling within the Labrador boundaries;

BE IT THEREFORE RESOLVED that the Newfoundland and Labrador Air Subsidy program be extended to include air travel between communities within the boundaries of Labrador.

The Honourable the Member for St. John's West gave notice that he would on tomorrow move the following Resolution:

WHEREAS the Port of St. John's has no effective means of fire protection for shipping using the port, and for certain waterfront facilities;

AND WHEREAS this protection can only be provided by means of a properly outfitted and manned fire tug;

AND WHEREAS the activities surrounding the Port of St. John's are increasing at a rapid rate, relative to the use and handling of explosives, petroleum products, and other highly inflammable materials;

AND WHEREAS it is absolutely essential for the safe and effective operation of the Port of St. John's that an adequate fire protection system be provided;

BE IT THEREFORE RESOLVED that this Honourable House urge the St. John's Port Authority and the National Harbours Board to undertake its full responsibility to initiate the providing of this fire tug and protection service.

The Honourable the Member for Bellevue gave notice that he would on tomorrow move the following Resolution:

WHEREAS there is still a large proportion of the secondary roads of this Province which are unpaved and generally in deplorable condition;

AND WHEREAS there is much natural resource potential in the areas concerned especially fisheries, forestry, agriculture and tourism;

AND WHEREAS the maximum development of these resources requires an effective transportation system;

AND WHEREAS the people of these areas are subjected to physical discomforts and extremely higher operating and maintenance costs.

BE IT THEREFORE RESOLVED that the Government of Newfoundland and Labrador escalate their road construction and paving program;

BE IT FURTHER RESOLVED that a program of action be announced during this Session of the House of Assembly.

The Honourable the Member for Burin-Placentia West gave notice that he would on tomorrow move the following Resolution:

WHEREAS Transport Canada is attempting to downgrade coastal boat service to the South Coast;

AND WHEREAS the change in service will effect the way of life of the people living at Petite Forte, South East Bight, and Little Paradise;

AND WHEREAS Transport Canada has now delayed for one year the proposed cut of service from these three communities in Placentia Bay to Argentia;

AND WHEREAS these communities will no longer have any connection to the Burin Peninsula;

AND WHEREAS the change in freight service will cause an increased cost to the consumer;

BE IT THEREFORE RESOLVED that this House condemn the action of Transport Canada and urge the Federal Government to maintain the existing coastal boat service to the entire South Coast.

The Honourable the Member for Port au Port gave notice that he would on tomorrow move the following Resolution:

WHEREAS the Government of Newfoundland and Labrador have no long term development strategy:

AND WHEREAS our economic future is oriented toward large projects and the accommodation of large industrial and multi-national corporations:

AND WHEREAS there has been a total neglect of smaller developments, and businesses, which are vitally important to the economy of this province;

AND WHEREAS the ever increasing number of bankruptcies in small businesses, fishing, forestry and agriculture are leading to record unemployment and loss of income;

BE IT THEREFORE RESOLVED that the Government present to the House of Assembly an industrial and economic development strategy for debate and implementation.

The Honourable the Member for Bay of Islands gave notice that he would on tomorrow move the following Resolution:

WHEREAS the Gros Morne National Park has been recognized as one of the most attractive areas of Canada;

AND WHEREAS the Humber Valley has long been a site for recreation and sightseeing;

AND WHEREAS the Marble Mountain ski facility is rapidly becoming one of the most popular ski centres in Eastern Canada:

AND WHEREAS the Bay of Islands offers great attractions for marine oriented recreation;

AND WHEREAS there exists additional potential for development of tourist attractions in the Western region;

AND WHEREAS the tourist industry offers great opportunity for year round employment;

BE IT THEREFORE RESOLVED that the Government of Newfoundland and Labrador encourage the further development of these attractions and of additional attractions and that every effort be made to promote this areas as a major recreational centre.

The Honourable the Leader of the Opposition gave notice that he would ontomorrow move the following Resolution:

The Sergeant-at-Arms announced the arrival of His Honour the Lieutenant-Governor.

Mr. Speaker left the Chair.

His Honour the Lieutenant-Governor took the Chair and delivered a Speech From The Throne as follows:

#### MR. SPEAKER AND MEMBERS OF THE HONOURABLE HOUSE OF ASSEMBLY:

The First Session of the Thirty-Ninth General Assembly of this Honourable House of Assembly is about to be prorogued, but before releasing you from your duties I wish to convey to you my appreciation for the careful and sympathetic attention you have given to the important matters brought before you by my Ministers.

Sixty-eight pieces of legislation were enacted during this Session of the Honourable House of Assembly. Among the major legislative initiatives taken were those in the areas of the administration of justice, finance, municipal affairs, transportation and communications.

In the area of the administration of justice several significant legislative measures were enacted.

The Unified Family Court Act was originally enacted as a three year trial project. During the trial period, it became readily apparent that the Court represented a progressive step in the administration of justice. Consequently, in this Session, the Act was amended to make the Court a permanent institution. The Judicature Act was amended to increase the number of judges in the Trial Division of the Supreme Court from six to seven. A new section was added to The Jury Act that would provide the right of exemption from serving as a juror to people whose pastoral duties or beliefs would conflict with service as a juror. In order to facilitate the execution of releases of mortgages in this Province, The Conveyancing Act was amended whereby every non-resident mortgagee would be required to have an attorney in the province who could execute a release of mortgage upon the payment of all money under the mortgage. The Parliamentary Commissioner (Ombudsman) Act was amended to include the Waterford Hospital as an agency for the purposes of the Act. As well, the Act was amended to provide for the independent review of complaints against any member of the Royal Newfoundland Constabulary by the Parliamentary Commissioner.

In order to protect the travelling public of the Province, my Government introduced major amendments to The Automobile Insurance Act. This Act was amended so that the compulsory limit of insurance would be increased from Seventy-five thousand dollars to Two hundred thousand dollars. Also the limitation period for the bringing of actions for damages arising out of motor vehicle accidents was changed from one year to two years. As well, in order to be consistent with other Canadian jurisdictions, the Act was further amended to extend the absolute liability provision to gratuitous passengers on the same basis as any other third party claimants.

## MR. SPEAKER AND MEMBERS OF THE HONOURABLE HOUSE OF ASSEMBLY:

In accordance with the recommendations of the Public Accounts Committee, to which my Government is constantly sensitive. The Department of Finance Act was amended to complete the separation of the administrative roles of the Comptroller and Deputy Minister of Finance. entitled. The Financial Corporations Capital Tax Act was passed to impose a tax on the taxable paid-up capital of banks and loan and trust companies. The Conflict of Interest Act, 1973 was amended to enable guidelines and regulations to be made that would govern the standards to be observed by Ministers of the Crown and public employees in the conduct of their official duties so far as they relate to their private affairs in order to safeguard the public interest. In order to modernize and revise the pension plans of the members of the Royal Newfoundland Constabulary, the St. John's Fire Department and the staff of Her Majesty's Penitentiary, a new Uniformed Services Pension Act was passed during this Session. Both The Retail Sales Tax Act, 1978 and The Tobacco Tax Act, 1978 were amended to clarify the law and remove certain doubts. The Tobacco Tax Act, 1978 was further amended to provide inspectors with increased authority to investigate cases where tobacco is imported into the Province and the provincial tobacco tax has not been paid.

Throughout its office my Government has been very sensitive to the needs of persons on fixed incomes, particularly those whose main source of income is a pension. Consequently, pensions to former public servants were further increased during this Session.

### MR. SPEAKER AND MEMBERS OF THE HONOURABLE HOUSE OF ASSEMBLY:

My Government introduced substantial amendments to The Highway Traffic Act. Among those amendments were new provisions dealing with the suspension and cancellation of driver's licences and a new schedule of penalties for violations of the Act. The fines had not changed in over twenty years and in my Government's judgment were no longer a deterrent against violations of the Act.

During this Session, The Dangerous Goods Transportation Act was passed. This Act, when proclaimed into force, will regulate the handling of dangerous goods and their transportation in vehicles on the highways of our Province. The Act is complementary to legislation passed by the Federal Government and other provincial jurisdictions.

My Government introduced amendments to The Public Utilities Act in order to permit the Board of Commissioners of Public Utilities to regulate telecommunications services that come within the legislative jurisdiction of this Province. These amendements also provide that my Government may express to the Board its policy on telecommunications and may order the Board to conduct studies into any aspect of telecommunications coming within the legislative jurisdiction of the Province. The Public Utilities Act Was also amended to permit the Public Utilities Board to allow terminal attachments to the public utility operating telephone equipment under the jurisdiction of the Board.

# MR. SPEAKER AND MEMBERS OF THE HONOURABLE HOUSE OF ASSEMBLY:

In the area of municipal affairs, The Urban and Rural Planning Act was amended during this Session to consolidate and improve the appeal and administrative provisions of the Act and make it a more effective instrument for the planning and regulation of development in the Province. Among the more important provisions enacted were amendments to provide that in relation to certain types of development my Government may require a Development Certificate to be obtained.

Another amendment provides that the Minister of Municipal Affairs may direct that certain applications be submitted to the Minister for a determination. In preparing for future controlled development of land, my Government introduced amendments to The Development Areas (Lands) Act whereby any transaction in relation to land in a Development Area under the Act has to be registered in the Registry of Deeds. Numerous amendments to The Municipalities Act were passed during this Session to further clarify the law.

## MR. SPEAKER AND MEMBERS OF THE HONOURABLE HOUSE OF ASSEMBLY:

In an effort to reopen the asbestos mine at Baie Verte my Government found it necessary to introduce an Act to Expropriate the Property of Advocate Mines Limited. This Act was proclaimed into force on September 3rd, 1982. The mine is now operated by a new mining company.

As an indication of my Government's commitment to the tourist potential of this Province, An Act to Revise the Law Respecting Innkeepers was passed during this Session.

In response to the most tragic loss of the men on the Ocean Ranger last February, my Government introduced amendments to The Workers' Compensation Act to permit a worker or his dependant to claim compensation under the Act and to bring an action against a third party not covered by the Act. Before the amendment to the law, the worker or his dependant could only do one or the other. The amendments to the Act also permit the Workers' Compensation Board to be subrogated to the rights of a worker or his dependants. The Act was also amended to extend the limitation period within which a claim for compensation must be made.

In order to encourage the orderly management of and to discourage the desecration and depletion of our wild life resources, The Wild Life Act was amended to revise the penalties relating to moose and caribou offences. The Act Was further amended to require the forfeiture of any thing used for the transportation of big game taken contrary to the law if the transportation devise was operated by its owner. The Act was also amended to provide that any firearms and other items owned by a non-resident and held by the Department may be disposed of after one year if the non-resident does not appear before a court to answer the charge against him.

Among the other significant legislative measures enacted during this Session were An Act To Amend The Public Libraries Act, 1975, An Act To Amend The Department of Transportation Act, An Act To Amend The Newfoundland And Labrador Hydro Act, 1975, An Act To Amend The Law Society Act, 1977, An Act To Amend The Prisons Act, An Act To Amend The Bay St. George Community College Act, An Act To Amend The Mineral Act, 1976 and An Act To Amend The Newfoundland Industrial Development Corporation Act.

### MR. SPEAKER AND MEMBERS OF THE HONOURABLE HOUSE OF ASSEMBLY:

During this Session, Resolutions pertaining to matters of pressing and immediate public interest were introduced by my Government and fully debated. These Resolutions related to the issues of offshore resource and the transmission of hydro-electrical energy and were introduced in pursuance of my Government's unswerving determination to secure justice and equity in these matters for all people of the Province.

During this Session, a Select Committee of this Honourable House was struck, namely, the Select Committee to examine draft legislation on Elections, Controverted Elections and Election Financing. My Government looks forward to the report of this Committee being received by this Honourable House during this Assembly.

## MR. SPEAKER AND MEMBERS OF THE HONOURABLE HOUSE OF ASSEMBLY:

I thank you for the large measure of supply you have granted. I assure you that the appropriations that you have granted will be expended by my Ministers with care and efficiency.

It is my pleasure that the First Session of this Thirty-Ninth General Assembly now be prorogued and it is prorogued accordingly.
