BEGUN and holden at St. John's in the Province of Newfoundland on Monday, the twelfth day of March, Anno Domini, Nineteen Hundred and Eighty-four, being the thirty-second year of the reign of Her Majesty, our Sovereign Lady, Elizabeth the Second, by the Grace of God of the United Kingdom, Canada and Her other Realms and Territories, QUEEN, Head of the Commonwealth, Defender of the Faith.

His Honour the Lieutenant-Governor having fixed the hour at which he proposed to open the present Session of the Legislature at three of the clock in the afternoon of this Monday, the twelfth day of March, the Members of the House of Assembly met the Assembly Chamber at three of the clock in the afternoon when Mr. Speaker took the Chair.

At three of the clock the Sergeant-at-Arms announced that His Honour the Lieutenant-Governor had arrived.

His Monour entered the Assembly Chamber preceded by the Sergeant-at-Arms.

Mr. Speaker left the Chair.

His Honour the Lieutenant-Governor took the Chair.

His Honour was then pleased to open the Session with a Speech From The Throne.

His Honour the Lieutenant-Governor then left the Assembly Chamber.

Mr. Speaker resumed the Chair.

On motion of the Honourable the President of the Council and by leave of the House, a Bill entitled, "An Act To Amend The Department Of Transportation Act", was introduced and read a first time.

On motion it was ordered the said Bill be read a second time on tomorrow.

Mr. Speaker announced that His Honour the Lieutenant-Governor had been pleased to make a Speech to the Members met in the General Assembly and that for greater accuracy he had obtained a copy.

It was unanimously agreed that the Speech From The Throne should be taken as read.

It was moved by the Honourable the Member for Grand Bank and seconded by the Honourable the Member for Windsor-Buchans that an Address of Thanks be presented to His Honour in reply to the Gracious Speech with which he had been pleased to open the present Session of the Legislature and that a Select Committee be appointed to draft such Address In Reply.

It was ordered accordingly and the following Members were appointed to the said Committee:

The Honourable the Member for Fogo gave notice that he would on tomorrow move the following Resolution:

WHEREAS inshore fishermen have had a decrease in their real income over the last five years;

AND WHEREAS the costs associated with the harvesting sector of the inshore fishery have risen substantially, thereby placing these fishermen in a bankrupt position;

AND WHEREAS the present government has been using the fishing industry as an employer of last resort;

AND WHEREAS the highly publicized restructuring agreement has not lived up to the expectations created by the government's public relations campaign;

AND WHEREAS fishermen, fish plant workers and trawlermen have been frustrated in their efforts to secure a new collective agreement;

AND WHEREAS the present government's lack of fishery development policy is threatening to destroy the economic, social and cultural fabric of Newfoundland and Labrador society;

THEREFORE BE IT RESOLVED that this Honourable House direct the present government to put forward a sound development strategy for the Newfoundland and Labrador fishery which will protect the interests of inshore fishermen, plant workers, trawlermen and the independent processors as well as the major companies involved in the recent restructuring agreement;

AND BE IT FURTHER RESOLVED that the House direct the government to immediately resolve the unsatisfactory labour relations presently existing in the fishing industry as outlined by the "Unity 84" Campaign.

The Honourable the Member for St. Mary's-The Capes gave notice that he would on tomorrow move the following Resolution:

WHEREAS the Supreme Court of Canada has ruled that the ownership and control of the mineral resources on our Continental Shelf belongs to the Government of Canada;

AND WHEREAS Newfoundland's high unemployment rate, a high rate of taxation and a comparatively low level of services are a direct result of the lack of control which the Province exercises over its resources, a situation not unlike that experienced by the Prairie Provinces during the early part of this century;

AND WHEREAS all Newfoundlanders want to achieve a measure of prosperity that is based not on Federal transfer payments, but on the development of our own natural resources;

AND WHEREAS the Government of Canada in 1930 consented to and obtained an amendment to the Constitution of Canada providing the Prairie Provinces with the rights to their resources which had the effect of ensuring for each province, not only economic stability but also substantial growth and prosperity;

AND WHEREAS the Government of Newfoundland has tried, without success, to negotiate an offshore agreement with the Government of Canada, even though this Province was prepared to accept much less than that given to Alberta, Saskatchewan and Manitoba in 1930 and despite the fact that Newfoundland was even prepared to allow the Federal Government the right of paramouncy over all aspects of the development of the resource, so that it could guarantee national security and self-sufficiency of oil and gas;

AND WHEREAS an agreement with the Government of Canada governing the management and development of our offshore resources must be based on fairness and equity and accommodate our goals relating to employment, industrial development, the establishment of safeguards against the negative effects of oil and gas development as well as our rights to receive a fair share of related revenues;

House supports the position of the Government of Newfoundland and Labrador that an agreement with the Government of Canada on the management and development of our offshore oil and gas resources must reflect the principles contained in the Province's last proposal of January, 1983 which would have seen a sharing of management powers between the Province and the Federal Government with national priorities coming before provincial priorities and a revenue sharing formula which would have given Newfoundland the larger share in the first instance and the Federal Government the larger share after economic conditions improved in the Province.

The Honourable the Member for Mount Scio gave notice that he would on tomorrow move the following Resolution:

WHEREAS the Supreme Court of Canada has recently decided in favour of the Federal Government concerning ownership and jurisdiction of offshore resources;

AND WHEREAS this followed a decision of the Newfoundland Court of Appeal which was brought prematurely to the Court and was not properly prepared;

AND WHEREAS the Premier of this Province has indicated that he intends to keep on fighting until there is a change of government in Ottawa rather than now returning with the Federal Government to the bargaining table;

AND WHEREAS the present Leader of the Federal Progressive Conservative Party has refused to commit himself to provincial ownership and jurisdiction of offshore resources and our Province's two Progressive Conservative Members of Parliament have made conflicting statements on this important issue;

AND WHEREAS recent polls create great doubt whether the Progressive Conservative Party will form the Government of Canada after the next election;

AND WHEREAS the Federal Minister of Energy has indicated a willingness to immediately recommence negotiations with the Government of this Province on offshore resources;

THEREFORE BE IT RESOLVED that this House condemn the Provincial Government for weakening our bargaining position through its approach to the offshore issue;

AND BE IT FURTHER RESOLVED that this House demand that the Provincial Government return with the Federal Government to the bargaining table immediately.

The Monourable the Member for Baie Verte-White Bay gave notice that he would on tomorrow move the following Resolution:

WHEREAS the seal fishery has been a part of the way of life of Newfoundlanders and Labradorians for centuries:

AND WHEREAS income derived from the seal fishery constitutes a vital and necessary supplement to the incomes of thousands of inshore fishermen;

AND WHEREAS protest groups are not attempting to destroy major markets for other Canadian fish exports, particularly in the United States and Great Britain;

NOW THEREFORE BE IT RESOLVED that this House urge the Government of Canada in co-operation with the Government of Newfoundland and Labrador, the Fishermen's Union and the Canadian Scalers Association to develop and implement a strategy to protect Canadian interests in both our fish and seal product export markets.

The Honourable the Member for Bellevue gave notice that he would on tomorrow move the following Resolution:

WHEREAS the Newfoundland portion of the Trans-Canada Highway is in a deplorable condition;

AND WHEREAS to ensure safe and rapid transportation across the island there is a dire necessity for a four lane highway:

AND WHEREAS the province has drastically cut the maintenance and construction budget for roads under its jurisdiction;

THEREFORE BE IT RESOLVED that this House direct the Administration to immediately commission an engineering study of the Trans-Canada Highway and other secondary roads to determine what is necessary to bring the Trans-Canada Highway and interconnecting roads up to the standard enjoyed by our fellow Canadians in our sister provinces.

The Honourable the Member for Bay of Islands gave notice that he would on tomorrow move the following Resolution:

WHEREAS the Gros Morne National Park has been recognized as one of the most attractive areas in Canada;

AND WHEREAS the Humber Valley has long been a site for recreation and sightseeing;

AND WHEREAS the Marble Mountain ski facility is rapidly becoming one of the most popular ski centres in eastern Canada:

AND WHEREAS the Bay of Islands offers great attractions for marine oriented recreation;

AND WHEREAS there exists additional potential for development of tourist attractions in the Western region;

AND WHEREAS the tourist industry offers great opportunity for year round employment;

THEREFORE BE IT RESOLVED that the Government of Newfoundland and Labrador encourage the further development of these attractions and of additional attractions and that every effort be made to promote this area as a major recreational centre.

The Honourable the Member for Torngat Mountains gave notice that he would on tomorrow move the following Resolution:

WHEREAS the Lower Churchill and other resource developments in Labrador should proceed in an efficient fashion;

AND WHEREAS Aboriginal Land Claims remain unresolved and a fair and equitable land claims settlement is important to improve the status of our Aboriginal peoples;

AND WHEREAS financial arrangements for resource development will be delayed until title is clarified and lengthy court proceedings such as applications for injunctions will be possible;

AND WHEREAS recent studies have shown that the quality of life of our Wative People is a national disgrace;

AND WHEREAS Government has arbitrarily decided to harvest the George's River caribou herd without consultation with the Labrador people;

THEREFORE BE IT RESOLVED that the Government immediately start negotiations with the Native People of Labrador so as to arrive at an equitable settlement and to ensure unhindered development of Labrador resources to the benefit of all the people of Newfoundland and Labrador.

The Honourable the Member for Carbonear gave notice that he would on tomorrow ask leave to introduce the following Resolution:

WHEREAS it is vital to the economic wellbeing of Newfoundland and Labrador that a joint Federal-Provincial cost-sharing agreement be negotiated in such areas as rural development, secondary roads and Trans-Canada Highway upgrading, etc.;

AND WHEREAS there has been a substantial decline in the amount of funding flowing to this Province during the past few years as a result of the lack of such agreements;

AND WHEREAS during the past few months there has been a renewed effort on the part of both Governments to sign a number of vital development agreements;

THEREFORE BE IT RESOLVED that this House urge: both Governments to continue their efforts to reach new agreements in all areas that are presently outstanding as quickly as possible.

The Honourable the Member for Port au Port gave notice that he would on tomorrow ask leave to introduce the following Resolution:

WHEREAS the Provincial economy is stagnant because of the Provincial Government's lack of plans and policies;

AND WHEREAS many people of Newfoundland and Labrador, as a consequence, are presently suffering severe hard-ship;

AND WHEREAS the response of the present Government is the glorification of desperation and the worship of incompetence;

AND WHEREAS there would be considerable revenue available from a properly renegotiated agreement on the Upper Churchill Contract;

THEREFORE BE IT RESOLVED that the Provincial Government quickly reach a settlement with the Government of Quebec on the Upper Churchill Contract which will see an equitable provision of revenue to this Province from the sale of Labrador power as well as the development of other hydro projects in Labrador;

AND BE IT FURTHER RESOLVED that the revenue then available be invested in our fishing, mining, forestry and agricultural industries and in small business enterprises throughout our Province of Newfoundland and Labrador to create new long term employment for people.

The Honourable the Member for St. Barbe gave notice that he would on tomorrow ask leave to introduce the following Resolution:

WHEREAS there is known oil potential on the West Coast of this Province;

AND WHEREAS unemployment is severe on the West Coast of this Province;

AND WHEREAS the petroleum incentive payments under the national energy program for offshore drilling amounts to 80 percent funding and in the case of the onshore drilling is only 35 percent; AND WHEREAS the Provincial Government has designated certain areas in Western Newfoundland as provisionally open for petroleum exploration;

THEREFORE BE IT RESOLVED that this Honourable House make representation to the Federal Government to increase the petroleum incentive payments under the national energy program for onshore exploration to this amount now given in the offshore.

The Honourable the Leader of the Opposition gave notice that he would on tomorrow ask leave to introduce the following Resolution:

WHEREAS a record number of Newfoundlanders and Labradorians are unable to secure employment;

AND WHEREAS the largest percentage of the unemployed are between the ages of 16 and 25 years;

AND WHEREAS all sectors of our labour force are finding it difficult to survive economically;

AND WHEREAS the present Administration have failed to produce plans and policies to help our unemployed;

AND WHEREAS the collective bargaining process is being eroded by the dictatorial actions of this Administration;

THEREFORE BE IT RESOLVED that the House go on record as condemning the lack of initiatives for job creation and the heavy handed attitude of the government in dealing with public employees.

The Honourable the Member for Humber West gave notice that he would on tomorrow ask leave to introduce the following Resolution:

WHEREAS Bowaters has indicated their intention to withdraw from Corner Brook by the end of 1984;

AND WHEREAS the Pulp and Paper Mill is absolutely vital to the economic well-being of Corner Brook and to the West Coast of the Province;

AND WHEREAS any new operator for the Corner Brook Mill will require substantial funds for the modernization of the operation to ensure its viability in the future;

AND WHEREAS the Federal Government has seen fit to provide financial support of approximately one billion dollars to foreign countries for the development of their pulp and paper capacity;

THEREFORE BE IT RESOLVED that this Honourable House support the Province's request to the Federal Government to establish a program of financial assistance which accommodates the modernization requirements of the Corner Brook Mill thus ensuring the long term viability of the operations and its continued contribution to the economy of Corner Brook, the West Coast and the Province.

The Honourable the Member for Twillingate gave notice that she would on tomorrow ask leave to introduce the following Resolution:

WHEREAS most workers qualify for UIC benefits after ten work weeks;

AND WHEREAS they can then draw UIC benefits for the next forty-four weeks;

AND WHEREAS fishermen do not qualify for benefits before November 15;

AND WHEREAS fishermen do not qualify for benefits after May 15;

THEREFORE BE IT RESOLVED that fishermen qualify for benefits immediately at the end of the designated fishing season in the respective areas;

AND BE IT FURTHER RESOLVED that fishermen qualify to draw such benefits until first earnings or June 15, whichever comes earlier.

On motion it was ordered that when the House rises it adjourn until tomorrow, Tuesday, March 13th at three of the clock.

On motion the House then adjourned accordingly.

The Honourable the Member for Mount Scio rose on a Point of Privilege with respect to remarks made by the Honourable the Minister of Fisheries.

Mr. Speaker reserved his ruling.

Debate on the amendment to the Address In Reply was adjourned for further debate on tomorrow.

It was moved and seconded that when the House rises it adjourn until tomorrow, Wednesday, March 14th at three of the clock.

On motion it was ordered that the said Bills be printed being entitled as above and that they be submitted to His Honour for His Assent.

The Sergeant-at-Arms announced the arrival of His Honour the Lieutenant-Governor.

His Honour the Lieutenant-Governor took the Chair.

Mr. Speaker addressed His Honour as foilows:

"It is my agreeable duty on behalf of her Majesty's dutiful and loyal subjects, Her Faithful Commons in Newfoundland, to present to Your Honour Bills for the appropriation of Supply and Supplementary Supply granted in the present Session.

Whereupon the Clerk read the following Bill:

His Honour the Lieutenant-Governor said, "In Her Majesty's Name, I Assent to these Bills".

The Honourable the President of the Council moved, "That when this House adjourns today it will stand adjourned until Tuesday, February 26th, 1985 at 3 p.m., provided always that if it appears to the satisfaction of Mr. Speaker, or in the case of his absence from the Province, the Chairman of Committees, after consultation with Her Majesty's Government, that the House should meet at an earlier time than the adjournment, the Speaker, or in his absence, the Chairman of Committees, may give notice that he is so satisfied and thereupon the House shall meet at the time stated by such notice and shall transact its business as if it had been duly adjourned to that time.

On motion the House then adjourned accordingly.

The House met at three of the clock pursuant to adjournment.

The Sergeant-at-Arms announced the arrival of His Honour the Lieutenant-Governor.

Mr. Speaker left the Chair.

His Honour the Lieutenant-Governor took the Chair and delivered a Speech From The Throne as follows:

MR. SPEAKER AND MEMBERS OF THE HONOURABLE HOUSE OF ASSEMBLY:

Since the last sitting of this Honourable House, the Province and this Assembly were saddened by the death of the Honourable Member for Humber Valley. The Honourable Wallace House served in this Assembly and the Ministry of this Province with dedication and distinction. The Province has lost a distinguished Newfoundlander who dedicated his life to public service. On behalf of all, I wish to mark his passing and extend formal sympathies from this historic Assembly on behalf of all honourable members and the entire Province to the family of the late Honourable Member for Humber Valley.

The Third Session of the 39th General Assembly of this Honourable House of Assembly is about to be prorogued. Before relieving you from your duties, I wish to convey to you appreciation for the careful and sympathetic attention given to the important matters brought before you by my Ministers.

Forty-six pieces of legislation were enacted during this Session of the Honourable House of Assembly. Major legislative initiatives were taken in the administration of justice, labour, public works, development and education.

In the area of the administration of justice, several significant legislative measures were enacted. For the first time since 1889, a new Judicature Act was passed. This Act, upon proclamation, will revise the law relating to the superior courts of the Province. The Act will create a separate Supreme Court and a separate Court of Appeal. The Act will also provide for the making of new Rules of both Superior Courts and for the merger of what is now the Trial Division of the Supreme Court with the District Court. It is my Government's hope that the services of the Supreme Court will, upon merger, be brought closer to people in the rural areas of our Province. In addition, the existing District Court Act was amended to provide for the appointment of a second District Court Judge in the City of Corner Brook.

As an indication of my Government's desire to implement the reform of our laws to conform with the Canadian Charter of Rights and Freedoms and extend full rights to all members of society, The Newfoundland Human Rights Code was amended to include the words "mental disability" in the existing heads of discrimination that are prohibited by the Code. The reform of our law will be completed during the next Session of this Honourable House.

The Companies Act was amended to provide for the issuance of certificates of continuance and discontinuance of companies under our law.

MR. SPEAKER AND MEMBERS OF THE HONOURABLE HOUSE OF ASSEMBLY:

In order to ensure that employers, prospective employers and most importantly, employees in this Province understand their rights, The Labour Standards Act was amended to make a clear distinction with respect to temporary lay-offs and termination of employment.

After many months of negotiations, my Government was overjoyed to conclude an agreement with Kruger Incorporated whereby that company took over the operation of the Corner Brook Newsprint Mill. An Act To Ratify, Confirm And Adopt Certain Agreements entered into between the Government of the Province and Kruger Incorporated respecting the future operation and modernization of the Corner Brook Newsprint Mill was enacted during this Session. Aso, during this Session, An Act to govern collective bargaining between the Government and Interns and Residents was enacted.

As an indication of my Government's commitment to the workers of this Province, my Government introduced amendments to The Occupational Health and Safety Act to provide for the making of regulations respecting the health and safety of workers in the mines of the Province. This authority was previously vested in The Regulation of Mines Act which was considered an ineffective instrument to deal with occupational health and safety matters of miners.

The Elevators Act was amended to bring tower cranes and overhead travelling cranes within the ambit of the Act from which they had previously been excluded.

As a further indication of my Government's commitment to the future of our young people and the fishery resources of this Province, my Government introduced an Act Respecting the Establishment and Operation of the Newfoundland and Labrador Institute of Fisheries and Marine Technology. The new facilty will be completed this Fall and the old Fisheries College on Parade Street in St. John's will be abandoned. During this Session, The Schools Act was amended to increase the proportion of elected members to school boards from one-third to two-thirds. This amendment will provide for elections to school boards to be held on the same day as general elections of municipalities.

MR. SPEAKER AND MEMBERS OF THE HONOURABLE HOUSE OF ASSEMBLY:

During the past year, my Government reorganized a portion of the public service, in particular career development, advanced studies and matters relating to consumer affairs and communications. To this end, the following new Department Acts were passed by this Legislature: The Department of Career Development and Advanced Studies Act, The Department of Labour Act, The Department of Consumer Affairs and Communications Act and The Department of Education Act.

On April 2, 1984, the Government of Canada proclaimed into force the new Young Offenders Act. Therefore, it was necessary for this Province to revise the law respecting juvenile delinquents. The Young Persons Offences Act was passed during this Session as complementary legislation to the Federal Act. It replaces The Welfare of Children Act which has served well the young people of this Province since 1944.

In the area of consumer affairs, a new Act respecting collection agencies and collectors were passed. Upon proclamation, this Act will repeal and replace The Collection Agencies Act of 1973.

Some time ago, my Government announced that the Newfoundland and Labrador Award for Bravery would be established to honour those who show exemplary courage and place themselves in peril while rendering assistance to persons in distress. This Honourable House has recognized this award by passing The Bravery Award Act.

My Government has been concerned for some time that our past be preserved for future generations. The Heritage Foundation Act was passed to stimulate an understanding of and an appreciation for the architectural and historical heritage of this Province as well as to support and contribute to the preservation and restoration of historical buildings.

In the area of agriculture, my Government introduced an amendment to The Livestock Act so that an owner of livestock would be liable for damage to property caused by livestock that is roaming at large.

MR. SPEAKER AND MEMBERS OF THIS HONOURABLE HOUSE OF ASSEMBLY:

In 1974, the first Public Tender Act was passed by this Honourable House. My Government thought that it was now necessary, given the experience of the past ten years and the recommendations of the Report of the Commission of Enquiry into Purchasing Procedures of the Department of Public Works and Services, that the legislation be strengthened by a new Public Tender Act. This new Act will provide for the calling of tenders for the execution of public works and the acquisition of goods and services by not only the Departments of Government but by all Government funded bodies. When the new Act is shortly proclaimed into force, it will also bring into force The Provincial Preference Act. This Act will provide for the calculation and consideration of the provincial content factor in the awarding of tenders by Departments of Govern-These two new Acts are ment and Government funded bodies. bold steps on my Government's part to provide for a rigid calling of public tenders and the implementation of provincial preference.

Among the other significant legislative measures enacted during this Session were An Act To Amend The Quarry Materials Act, 1976, An Act To Amend The Education (Teachers' Pensions) Act, An Act To Amend The Boiler, Pressure Vessel and Compressed Gas Act, An Act To Amend The Dispensing Opticians Act, An Act To Amend The Medical Act, 1974, An Act To Amend The Financial Administration Act, 1973, An Act To Amend The Public Service (Pensions) Act, An Act To Repeal the Gander Development Corporation Act, 1975, and An Act To Provide for the Exemption of Baie Verte Mines Inc. from Taxes imposed by the Retail Sales Tax Act, 1978.

MR. SPEAKER AND MEMBERS OF THE HONOURABLE HOUSE OF ASSEMBLY:

During this Session, the House of Assembly Act was amended to implement without alteration the recommendations of the Report of the Newfoundland Electoral Districts Boundaries Commission as tabled in this Honourable House of Assembly by the Honourable Minister of Justice on April 13, 1984.

The Select Committee of this Honourable House, which was struck during the last Session to recommend draft legislation relating to the Certified General Accountants Association presented its Report. As a result of the recommendations of the Report, The Certified General Accountants Act was passed during this Session. Another Select Committee of this Honourable House, which was struck during the last Session to examine food prices throughout the Province, presented its Report to this Honourable House.

MR. SPEAKER AND MEMBERS OF THE HONOURABLE HOUSE OF ASSEMBLY:

I thank you for the large measure of supply you have granted. I assure you that the appropriations that you have granted will be expended by my Ministers with care and efficiency.

It is my pleasure that the Third Session of this 39th General Assembly now be prorogued and it is prorogued accordingly.
