And appoint you or any of you to be Our Commissioners for the purpose of administering the Oath of Allegiance to the persons elected to be Members of Our General Assembly for Newfoundland at the General Election held on the 2nd day of April, 1985, hereby granting unto you all the rights, powers and advantages which to the said office do or may lawfully appertain, and requiring you diligently to perform the duties thereof.

IN TESTIMONY WHEREOF We have caused these our Letters to be made Patent and the Great Seal of Newfoundland to be hereunto affixed.

Our trusty and well-beloved the Honourable W. Anthony Paddon Member of Our Order of Canada, Lieutenant-Governor in and for our Province of Newfoundland.

AT OUR GOVERNMENT HOUSE in Our City of St. John's, this 23rd day of April in the year of Our Lord one thousand nine hundred and eighty-five and in the thirty-fourth year of Our Reign.

The House met at three of the clock pursuant to adjournment.

At three of the clock the Sergeant-at-Arms notified Mr. Speaker that His Honour the Lieutenant-Governor, Honourable W. Anthony Paddon, had arrived, whereupon Mr. Speaker vacated the Chair.

The Sergeant-at-Arms preceded his Honour the Lieutenant-Governor to the Chair.

Whereupon the Lieutenant-Governor, having taken his seat, the Honourable the Premier addressed His Honour as follows:

"May it please Your Honour, the House of Assembly, agreeable to Your Honour's Command, have proceeded to the choice of a Speaker, and having elected Patrick McNicholas, Esquire, Member for the District of St. John's Center, to that office, and by their direction, I present him for the approbation of Your Honour."

His Honour was then pleased to reply:

"On behalf of Her Majesty, I assure you of my sense of your efficiency and I do most fully approve and confirm you as the Speaker."

Whereupon Mr. Speaker addressed His Honour as follows:

"Your Honour having approved the choice of this House in constituting me its Speaker, it now becomes my duty in the name of the representatives of Her Majesty's Loyal subjects, the people of this Province, to claim respectfully of Your Honour their accustomed rights and privileges, especially that they shall have freedom from arrest during their attendance in Parliament and that I, as Speaker, may have full access to Your Honour's presence at all reasonable times, and that they have confirmed to them all their ancient rights and privileges which have been confirmed to them by Your Honour Predecessors."

His Honour was pleased to reply:

"On behalf of Her Majesty I do confirm this House in the enjoyment of all its ancient and undoubted rights and privileges." His Honour was then pleased to open the Session with a Speech From the Throne.

His Honour then left the Assembly Chamber.

Mr. Speaker resumed the Chair.

The Honourable the President of the Council asked leave to introduce a Bill entitled, "An Act To Amend the Youth Advisory Council Act".

On motion of the Honourable the President of the Council and by leave of the House, the said Bill was introduced and read a first time.

On motion it was ordered the said Bill be read a second time on tomorrow.

Mr. Speaker announced that His Honour the Lieutenant-Governor had been pleased to make a Speech to the Members met in the General Assembly and that for greater accuracy he had obtained a copy.

It was unanimously agreed that the Speech should be taken as read.

It was moved by the Honourable the Member for Humber Valley and seconded by the Honourable the Member for LaPoile that an Address of Thanks be presented to His Honour in reply to the gracious Speech with which he had been pleased to open the present Session of the Legislature and that a Select Committee be appointed to draft such Address In Reply.

It was ordered accordingly that the following Members were appointed to the said Committee:

Mr. Rick Woodford, Humber Valley

Mr. Calvin Mitchell, LaPoile

Mr. C. Decker, Strait of Belle Isle

The Honourable the Member for Bonavista North gave notice that he would on tomorrow move the following Resolution:

WHEREAS the Province of Newfoundland and Labrador has the highest unemployment rate in Canada;

AND WHEREAS the present administration has failed in the past to execute effective plans and policies to help our unemployed;

AND WHEREAS the provincial economy is now stagnant;

AND WHEREAS the Provincial General Election was called to give the present administration a mandate to create jobs;

AND WHEREAS we now have finally arrived at that supposedly blissful, euphoric and utopian Government practising the same political philosophy;

BE IT THEREFORE RESOLVED THAT both Governments - Provincial and Federal be called upon to immediately produce an employment strategy which will substantially reduce the numbers of unemployed people in this Province;

AND BE IT FURTHER RESOLVED THAT in an attempt to stiumlate the economy and thereby create jobs that the Provincial Government immediately take steps to reduce the level of taxation in this Province;

AND BE IT FURTHER RESOLVED THAT the reduction of the tax level start by a reduction of the Retail Sales Tax from 12% to 10%.

The Honourable the Member for Port au Port gave notice that he would on tomorrow move the following Resolution:

WHEREAS the Upper Churchill power contract is unfair to the Province of Newfoundland and Labrador;

AND WHEREAS much undeveloped hydro electric potential remains in Labrador and Northern Quebec;

AND WHEREAS the Prime Minister of Canada has expressed an interest in helping to resolve these long-standing issues between the Province of Newfoundland and Labrador and the Province of Quebec;

AND WHEREAS the Government of Quebec has recently expressed a renewed interest in the cooperative aspects of Canadian Federalism;

THEREFORE BE IT RESOLVED that this Honourable House go on record as encouraging the Governments of Canada, Newfoundland and Labrador and Quebec to seek a resolution to outstanding issues with regard to developed and undeveloped hydro electric resources in Labrador and Northern Quebec.

The Honourable the Member for Fogo gave notice that he would on tomorrow move the following Resolution:

WHEREAS all parties in the Honourable House have formerly had an all plants open policy;

AND WHEREAS the Government adopted such a policy during the negotiation of the Restructuring Agreement;

AND WHEREAS under that Restructuring Agreement the Provincial Government has to consent to the closing of fish plants in this Province;

AND WHEREAS many fish plants are the sole means of economic and social survival of many communities;

AND WHEREAS the Government has recently allowed fish plants in this Province to close and placed them on the auction block:

AND WHEREAS it is necessary to provide time for fish plants to prove their economic viability under the restructuring scheme;

BE IT THEREFORE RESOLVED that this Honourable House, through approval of this Liberal Policy, instruct the present administration to adopt a policy ensuring that all fish plants in this Province remain open for a period of not less than four years.

The Honourable the Member for Placentia gave notice that he would on tomorrow move the following Resolution:

WHEREAS the Argential Vessel Traffic Surveillance Centre provides a vital service for the safe navigation of vessels within Placentia Bay;

AND WHEREAS the proposed phase-out of the V.T.S. Centre at Argentia will jeopardize the safety of mariners, including the hundreds of fishermen who operate within Placentia Bay on a daily basis;

AND WHEREAS the risk to the marine environment will be placed at an unacceptably high level due to the unregulated and haphazard movement of phosphorus tankers, oil carriers and other shipping;

AND WHEREAS the elimination of V.T.S. service will jeopardize the offshore oil and gas industrial development potential in centres within Placentia Bay;

AND WHEREAS the fishery within Placentia Bay contributes millions of dollars to the Provincial economy and provides hundreds of jobs for our people;

AND WHEREAS the decision to eliminate the V.T.S. operations at Argentia was based on a report which was seriously flawed and inaccurate;

BE IT THEREFORE RESOLVED that the Provincial Government intervene with the Federal Department of Transport in an effort to have this ill-conceived and unacceptable action immediately rescinded;

AND BE IT FURTHER RESOLVED that the Provincial Government make strong representation to the Department of Transport to upgrade V.T.S. facilities which have been described by qualified Coast Guard personnel as inadequate for the safe movement of shops within the Newfoundland Region.

The Honourable Member for Menihek gave notice that he would on tomorrow ask leave to introduce the following Bills:

- A Bill "An Act To Amend The Conveyancing Act"
- A Bill "An Act To Amend The Labour Standards Act".

- A Bill "An Act To Amend The Labour Relations Act, 1977 And The Public Service (Collective Bargaining) Act, 1973".
- A Bill "An Act Respecting Publicly Funded Day Care Services In The Province".
- A Bill "An Act To Provide For A Provincial Pension Plan".
- A Bill "An Act To Amend The Bills Of Sale Act".

The Honourable the Member for Torngat Mountains gave notice that he would on tomorrow move the following Resolution:

WHEREAS many workers qualify for U.I.C. benefits after ten (10) weeks;

AND WHEREAS they then draw unemployment insurance for the next forty-four (44) weeks;

AND WHEREAS fishermen do not qualify for benefits before November 15;

AND WHEREAS fishermen living in some areas of Newfoundland and all of the coast of Labrador are treated very unfairly by the present regulations;

BE IT THEREFORE RESOLVED that this House of Assembly make representation to the Federal Government that fishermen qualify for benefits immediately at the end of the designated fishing season in the respective areas;

AND BE IT FURTHER RESOLVED that this House of Assembly make representation to the Federal Government that fishermen qualify to draw such benefits until first earnings or July 1st, whichever comes earlier.

The Honourable the Member for Gander gave notice that he would on tomorrow move the following Resolution:

WHEREAS municipalities of this Province are now being forced in a dictatorial manner, to pay the total property assessment costs for the Province;

AND WHEREAS some grants to municipalities have been drastically cut during the past three years;

AND WHEREAS this unfair shifting of the tax burden from the Province to the municipalities will force municipalities to reduce services and increase taxes;

AND WHEREAS this may cause problems in the November municipal elections;

BE IT THEREFORE RESOLVED that this Government immediately set up a Select Committee of the House to fully examine the effects of these increased costs on municipal governments in the Province;

AND BE IT FURTHER RESOLVED that, until this examination is complete, the grants that have been cut, and the costs of assessment, be returned to the previous formulas.

The Honourable the Member for Carbonear gave notice that he would on tomorrow move the following Resolution:

WHEREAS there is a demonstrated need for daycare spaces for the many preschool children in this Province;

AND WHEREAS Government has received representation from the Newfoundland and Labrador Day Care Advocates' Association;

AND WHEREAS Government hopes to set an example for the private sector by establishing a Child Care Centre for the children of public servants working at Confederation Complex;

AND WHEREAS this Province is a member of a Federal/Provincial/Territorial Working Group on Child Care reviewing critical financing issues for child care;

THEREFORE BE IT RESOLVED that insofar as is fiscally possible, Government continue to increase its child care services in a prudent fashion to the benefit of all residents of the Province.

The Honourable the Member for Windsor - Buchans gave notice that he would on tomorrow move the following Resolution:

WHEREAS the cost of electricity has more than doubled in the last ten years;

AND WHEREAS this increase is exclusive of the utility company's fuel adjustment charge;

AND WHEREAS the fuel adjustment charge is simply a convenient method of increasing electricity costs to consumers while appearing not to;

AND WHEREAS repeated Government promises to effect measures to reduce the crushing burden of high electricity rates on consumers have not been kept;

AND WHEREAS the Peckford Administration, and not the Public Utilities Board, decides whether there will be electricity rate increases or not;

AND WHEREAS Government incompetence has brought to a standstill any worthwhile re-negotiation with Quebec of the Upper Churchill contract;

AND WHEREAS Government appears to have abandoned its intentions to develop the Lower Churchill;

THEREFORE BE IT RESOLVED that this House instruct the present Administration to immediately eliminate the fuel adjustment charge and place a freeze on electricity rates in this Province until a study of the method of power generation and distribution is carried out;

AND BE IT FURTHER RESOLVED that the Administration again approach the Province of Quebec with the aim of re-negotiating the Upper Churchill agreement so that fruitful development of other hydro resources in that area of the Province can also be pursued.

The Honourable the Member for Burin - Placentia West gave notice that he would on tomorrow move the following Resolution:

WHEREAS both our fisheries and our offshore oil and gas resources present major opportunities for employment generation;

AND WHEREAS capturing opportunities in the offshore oil and gas sector represent a new area of technology and pose a particular challenge to us;

AND WHEREAS the opportunities in neither field can be fully captured without strong education research support;

AND WHEREAS in many cases, such as the new campus for the Institute of Fisheries and Marine Technology, the same research and education facilities can serve both industries;

THEREFORE BE IT RESOLVED that this Honourable House encourage both the Federal and Provincial Governments to spend a significant proportion of the Offshore Development Fund, established under the Atlantic Accord, on marine-related education and research, not only to capture benefits from the oil, but also to ensure the development of a more broadly based marine capability in the Province.

The Honourable the Member for Stephenville gave notice that he would on tomorrow move the following Resolution:

WHEREAS a record number of young Newfoundlanders and Labradorians are unable to secure employment;

AND WHEREAS the largest percentage of unemployed for any group is for the group between the ages of 16 and 25;

AND WHEREAS all sectors of our labour force are finding it difficult to survive economically;

AND WHEREAS the present Administration has failed to produce plans and policies to help our unemployed;

AND WHEREAS in 1979 when the present Premier assumed power, youth unemployment stood at 40.8%;

THEREFORE BE IT RESOLVED that this Honourable House direct the present Administration to introduce fresh, new, imaginative and innovative programs to put our young Newfoundland sons and daughters, the forgotten generation, back to work before much more serious and permanent social problems result from this irreparable human tragedy of youth unemployment;

AND BE IT FURTHER RESOLVED that one new program adopted be the Apprenticeship and Training Program proposed by the Liberal Party.

The Honourable the Member for Terra Nova gave notice that he would on tomorrow move the following Resolution:

WHEREAS Government recognizes the need for greater participation by women in the senior ranks of the Public Service and in professional and managerial positions generally;

AND WHEREAS His Honour, in the gracious Speech from the Throne on March 12th, 1984, affirmed Government's intention to assist women obtain their rightful place in the workforce;

AND WHEREAS as a first step to this end, Government has launched an Accelerated Management Development Program for women with demonstrated potential for advancement;

AND WHEREAS the Peckford Government established a Task Force to undertake a full policy review of Affirmative Action;

AND WHEREAS this Task Force on Affirmative Action has now submitted its Report to Government;

THEREFORE BE IT RESOLVED that Government actively consider the recommendations of the Task Force on Affirmative Action and continue to use its considerable resources to assure that the potential of female employees is developed in keeping with wise human resource management.

The Honourable the Member for Eagle River gave notice that he would on tomorrow move the following Resolution:

WHEREAS the Youth of Our Province are our greatest and richest resource;

AND WHEREAS the education of our Youth in Newfoundland and Labrador has been a low priority with the present administration:

AND WHEREAS Government spend less money per capita on our students than any other Province in Canada;

AND WHEREAS the primary and elementary schools have been completely forgotten by the Peckford Administration;

AND WHEREAS Grade XII has had some good points but this has led to overcrowding: e.g. students using libraries, gymnasiums and office space for classrooms;

AND WHEREAS there are no overall goals or priorities for our education system in this province to help us cope with the many complex problems in our society today;

AND WHEREAS the post-secondary education in our province is now becoming a privilege and not a right;

AND WHEREAS the Federal/Provincial Governments give grants and tax breaks to businesses;

BE IT RESOLVED that the Premier should enter into negotations with his P.C. friends in Ottawa to ensure that the repayment of student loans become tax deductible;

AND BE IT FURTHER RESOLVED that this Administration spend an increasing percentage of its budget in Education, where now Education is receiving less percentage of the budget each year, extra funds have to be spent on our Education system if we are to bring it up to a national level;

AND BE IT FURTHER RESOLVED that a Royal Commission be established to ensure that our Youth are properly prepared to enter and lead us into the 21st century. The Royal Commission would study education from pre-school to post-secondary education to ensure that we have a society that is sound socially, economically and culturally.

The Honourable the Member for LaPoile gave notice that he would on tomorrow move the following Resolution:

WHEREAS recent developments in the field of aquaculture, especially Atlantic Salmon Farming, show that a major new industry is developing worldwide;

AND WHEREAS this Province is blessed with abundant unpolluted sites for aquaculture and has a work force with many of the basic skills needed for aquaculture;

AND WHEREAS the Government of this Province has already started to develop an aquaculture program;

THEREFORE BE IT RESOLVED that this Honourable House go on record as encouraging the Province, on a priority basis and in co-operation with the Federal Government, Rural Development Associations and other interested parties, to develop a major program of aquaculture development for salmon, mussels and other species suitable to our waters as a key program to create long term suitable employment opportunities in rural areas of the Province.

The Honourable the Member for Naskaupi gave notice that he would on tomorrowmove the following Resolution:

WHEREAS the vast Region of Labrador is the area within the province most ignored by the present Administration;

AND WHEREAS the present Administration, by its callous and uncaring attitude, has shown its disregard for all peoples of Labrador by failing to provide Cabinet representation from the region;

AND WHEREAS this retaliatory measure will tend to destroy the provincial unity necessary for the bright economic future often promised by the present Administration;

AND WHEREAS the much touted Utopian circumstances of Federal and Provincial Governments of the same persuasion now exists;

BE IT THEREFORE RESOLVED that the Government immediately establish a Select Committee of the House to deal with the problems confronting the people of Labrador.

AND BE IT FURTHER RESOLVED that the Government seriously address the question of Native Land Claims and Aboriginal Rights in a manner which will allow development of the Natural Resources of Labrador, while at the same time, recognizing the legitimate needs and aspirations of our aboriginal people;

AND BE IT FURTHER RESOLVED that the Committee of the House, aforementioned, have as its mandate, in part, the requirement to provide recommendations to the Government respecting the development of the Tourism Industry, including sponsoring a Major Labrador Tourism, the development of the Natural Resources of the Region of Labrador, and the resolution of the socio-economic problems of the Region, giving respect to the dignity and rights of all peoples of Labrador, regardless of ethnic origins;

(4) The Appeals Tribunal shall not hear, determine or dispose of an appeal from a decision, order or ruling of the Commission unless the procedures established by the Commission for consideration of issues respecting the matters mentioned in clause (3)(b) or (c) have been exhausted, and the Commission has made a final decision, order or ruling thereon.

At five-thirty of the clock, pursuant to Standing Order 31, a certain question raised by an Honourable Member was debated following which, pursuant to Standing Order 31, Mr. Speaker put the question that the House do now adjourn.

The motion was carried.

Mr. Speaker left the Chair until tomorrow, Friday, February 21st at ten of the clock in the forenoon.

Mr. Speaker ruled on the Point of Privilege raised by the Honourable the President of the Council with respect to remarks made by the Honourable the Member for Port de Grave when referring to a statement made by the Honourable the Minister of Consumer Affairs and Communications on Thursday, February 20th.

Mr. Speaker asked the Honourable the Member for Port de Grave to withdraw his remarks whereupon the Honourable the Member for Port de Grave withdrew his remarks.

The Honourable the Minister of Rural, Agricultural and Northern Development made a statement with respect to the Newfoundland Dairy Industry.

The Honourable the Member for Torngat Mountains moved the following motion:

WHEREAS many oil companies in the Province of Newfoundland and Labrador have lessened the burden on consumers by reducing the price of this petroleum products;

AND WHEREAS oil companies in central and coastal Labrador have decided not to reduce this price;

BE IT THEREFORE RESOLVED that this House unanimously request that those oil companies in Labrador show compassion to the consumer who are already paying the highest price in the province, by taking similar action in reducing their prices.

The Honourable the Member for Gander presented a Petition on behalf of residents of Fogo District with respect to road conditions in their communities.

The Honourable the Member for Stephenville presented a Petition on behalf of residents of the Harmon Complex with respect to proposed rent increases.

Pursuant to order and on motion debate was continued on second reading of the Bill entitled, "An Act To Implement An Agreement Between the Government of Canada and the Government of Newfoundland and Labrador on Offshore Petroleum Resource Management and Revenue Sharing".

The Sergeant-at-Arms announced the arrival of His Honour the Lieutenant-Governor.

Mr. Speaker addressed His Honour as follows:

May it please Your Honour the General Assembly of the Province have at its present Session passed a certain Bill to which in the name and on behalf of the General Assembly, I respectfully request Your Honour's Assent.

Whereupon the Clerk read the following Bill:

A Bill "An Act Respecting The Users Of Tobacco".

His Honour the Lieutenant-Governor said, "In Her Majesty's Name, I Assent to this Bill".

Mr. Speaker left the Chair.

His Honour the Lieutenant-Governor took the Chair and delivered a Speech From The Throne as follows:

MR. SPEAKER AND MEMBERS OF THE HONOURABLE HOUSE OF ASSEMBLY:

The First Session of the 40th General Assembly of this Honourable House of Assembly is about to be prorogued. Before relieving you from your duties, I wish to convey to you appreciation for the careful and sympathetic attention given to the important matters brought before you by my Ministers.

As has been customary during the tenure of this Administration the first Sitting of this Session was concerned primarily with the Address In Reply to my Speech from the Throne at the commencement of this Session and consideration of the granting of Supply to Her Majesty. The Second Sitting during the Fall, as has become customary concerned itself with legislative measures.

However, this Session was unique in that a Third Sitting was held in the year ensuing the Speech from the Throne. The purpose of this Sitting was to acquit my Government's obligation under clause 57 of the Atlantic Accord, within one year of the signing of that historic document, to introduce in this Honourable House legislation necessary to implement that Agreement which is so vital to the interests of Newfoundland and Labrador.

I am pleased to note that this was accomplished on February 7th, 1986. I am equally pleased to observe on that same day in the House of Commons, the mutual and parallel legislation envisaged by the Atlantic Accord and entitled the Canada-Newfoundland Atlantic Accord Implementation Act was introduced into the Parliament of Canada.

The process of enacting legislation mutual and parallel to a corresponding Bill being simultaneously enacted by the Parliament of Canada is unique in the history of this Honourable House. In order to preserve the essential mutuality of both Bills, it is necessary that they both proceed through their various stages of enactment more or less in concert. Consequently, it would have been inappropriate to have pursued The Canada-Newfoundland Atlantic Accord Implementation (Newfoundland) Act through all of its stages in this present Session.

The Second Reading of this important measure can conveniently resume in the Second Session of this 40th General Assembly shortly to be convened. During that Session, Committee Stage on this historic Bill will also take place coincidentally or following Committee Stage of its sister Bill in the House of Commons. Following this, Third Reading and the Assent requisite to pass this most historic Bill into the Law of this Province will take place.

My Ministers look forward with immense anticipation to the continued debate on this - the most important Bill to be considered by this Honourable House since Confederation with Canada - in the forthcoming Session of this Assembly.

MR. SPEAKER AND MEMBERS OF THE HONOURABLE HOUSE OF ASSEMBLY:

Thirty-five pieces of legislation were enacted during this Session of the Honourable House of Assembly. In particular, legislative initiatives were taken in the administration of justice, labour, municipal affairs, consumer affairs, cultural affairs and finance.

In the area of the administration of justice, my Government recognized that the Canadian Charter of Rights and Freedoms imposes new and substantial obligations on it. My Government ordered a comprehensive review of all the laws of the Province with a view to determining whether they complied with the Charter. The purpose in so doing was to acknowledge our constitutional duty to safeguard the entrenched rights of those subject to the laws of the Province, and to fulfill that duty by ensuring that our provincial laws do not violate the Charter. As a result of the review, this Honourable House passed a Bill amending over seventy pieces of legislation in order to ensure the standards of the Charter, with which legislation must comply, would be reflected in the Public General Statutes.

My Government, also in the area of the administration of justice, introduced An Act To Amend The Judicature Act that increased from seven to eight the number of judges in the Trial Division of the Supreme Court of Newfoundland. The Arbitration Act was passed to provide a new piece of legislation dealing exclusively with arbitrations in the Province.

MR. SPEAKER AND MEMBERS OF THE HONOURABLE HOUSE OF ASSEMBLY:

As an indication of my Government's commitment to the consumers of this Province, The Public Utilities Act was amended to empower my Government to issue directions to the Board of Commissioners of Public Utilities on any matter pertaining to compensation for the use of utility poles owned by a public utility by a licensed cable television system. As well,

my Government appointed another Commissioner to the Board of Commissioners of Public Utilities to represent the interests of consumers on that Board. The Insurance Companies Act was amended during this Session to provide for the licensing in this Province of extra-provincial insurance companies and also to provide for reciprocial deposits. Another amendment to The Insurance Companies Act also provides that all insurance companies in the Province must be members of a compensation fund. As well, the Newfoundland Automobile Assigned Risk Plan was completely reorganized to provide further protection to the public during this Session.

MR. SPEAKER AND MEMBERS OF THE HONOURABLE HOUSE OF ASSEMBLY:

In the area of labour, my Government introduced very significant legislation respecting labour relations, workers' compensation and collective bargaining in the public service.

With respect to labour relations, my Government introduced amendments to The Labour Relations Act, 1977 to clarify the authority of the Labour Relations Board to hold hearings, to permit the Board to settle the terms of a first collective agreement and to provide for the collection by an employer of union dues from unionized and non-unionized employees.

My Government also introduced amendments to The Public Service (Collective Bargaining) Act, 1973 to limit the number of employees in the public service who may be considered essential by the employer and to limit to employees in health care institutions certain provisions requiring a waiting period of thirty days before calling a strike.

Furthermore, my Government introduced amendements to The Workers' Compensation Act, 1983 to clarify the meaning of "injury" for the purposes of that Act and to Provide for the integration of Canada Pension plan disability benefits with workers' compensation benefits.

In the area of health care, my Government introduced legislation respecting the registration of psychologists qualified to practice in the Province.

In the area of the fishery, my Government introduced amendments to The Fisheries Loan Act To afford protection to fishermen respecting amounts deducted by fish processors for remittance to the Fisheries Loan Board on their behalf. An amendment was also introduced to provide that interest owing by a fisherman on a loan that is in arrears through no fault of the fisherman may be forgiven.

In the area of cultural affairs, my Government introduced legislation to revise existing legislation respecting the preservation of the province's historic resources. My Government also introduced legislation to provide for the creation of the Heritage Foundation to aid in the preservation of buildings and other structures that are of architectural or historical significance.

The Local School Tax Act was amended to exempt from taxation buildings on productive farmland and woodland and to exempt from the real property tax certain buildings used for residential purposes.

MR. SPEAKER AND MEMBERS OF THE HONOURABLE HOUSE OF ASSEMBLY:

During this Session, my Government introduced a number of amendments to certain financial measures. A new Tobacco Tax Act was passed to revise the law, particularly as it relates to enforcement.

The Financial Corporations Capital Tax Act and The Department of Finance Act were also amended to clarify administrative procedures. As well, The Liquor Corporation Act, 1973 was amended to enable my Government to prescribe the proportion of alcohol in various classes of beer. That Act was further amended to empower the Newfoundland Liquor Corporation to manufacture, blend, package, mix and prepare for sale alcoholic liquor.

In the area of municipal affairs, my Government introduced new legislation respecting the City of Corner Brook. The new Act reflects the larger and more developed aspects of municipal government in our west coast City. My Government also introduced several legislative changes to enhance the smooth running of municipal elections in the City of St. John's.

In recognition of the responsibility and representative position of municipalities in this Province, my Government introduced amendments permitting municipalities to make regulations respecting the method of display of pornographic materials in shops and the access by minors to those materials.

Among the other legislative measures enacted during this Session were An Act To Amend The Loan and Guarantee Act, 1957, An Act To Amend The Youth Advisory Council Act, An Act To Amend The Management Accountants Act, An Act To Amend The Day Care And Homemaker Services Act, 1975, An Act To Amend The Fishing Industry Advisory Board Act, 1975, An Act To Amend The Public Service (Pensions) Act And An Act To Amend The Memorial University (Pensions) Act.

MR. SPEAKER AND MEMBERS OF THE HONOURABLE HOUSE OF ASSEMBLY

I thank you for the large measure of supply you have granted. I assure you that the appropriations that you have granted will be expended by my Ministers with care and efficiency.

It is my pleasure that the First Session of this 40th General Assembly now be prorogued and it is prorogued accordingly.
