## Tuesday, March 23rd, 2004

The House met at 1:30 o'clock in the afternoon pursuant to adjournment.

The Member for Cartwright-L'Anse au Clair (Ms. Jones) presented a Petition on behalf of certain residents of the Province requesting the Government of Newfoundland and Labrador to direct the Western Health Care Complex to maintain the obstetrical, surgical and laboratory services at the Sir Thomas Roddick Hospital at current levels and to provide the Corporation with any additional funding necessary to maintain such services.

The Member for Labrador West (Mr. Collins) presented a Petition on behalf of certain residents of his District requesting the Government to proceed without delay with the planning and construction of a new health care facility in Labrador West as the most cost effective approach in the long term to provide the necessary health care facility.
