Thursday, May 27th, 2004

The House met at 1:30 o'clock in the afternoon pursuant to adjournment.

The Leader of the Opposition (Mr. Grimes) rose on a point of order to allege that certain comments made by the Honourable the Minister of Transportation and Works (Mr. Rideout) on May 26th as quoted in Hansard were not factual and that the Members of the House were misled by these comments. The Honourable the Government House Leader (Mr. Byrne) rose to say that the Leader of the Opposition had imputed motives to the Minister and that the matter was not a valid point of order.

The Speaker ruled there was no point of order but a disagreement between two Members as to the facts and circumstances relating to the matter.

Whereupon the Leader of the Opposition (Mr. Grimes) rose to establish a *prima facie* case of privilege by alleging that the Minister of Transportation and Works (Mr. Rideout) who spoke on behalf of the Government had stated that a certain letter was circulated to the Official Opposition caucus when in fact it had not been circulated.

The Speaker ruled that the Leader of the Opposition had not established a *prima facie* case of privilege. He quoted Beauchesne's 6th Edition, paragraph 31 which states that a dispute arising between two Members as to the allegations of fact does not fulfill the conditions of parliamentary privilege.

The Member for Port de Grave (Mr. Butler) made a Statement to congratulate Craig Snow, Samantha March and Peggy Wakeham who were honoured by the Town of Bay Roberts as the 2003 Athletes of the Year. The Member recounted the athletic prowess of these young persons.

The Member for Port au Port (Mr. Jim Hodder) made a Statement respecting the presentation of Vive La Rose - The Emile Benoit Story a play about the well known Francophone musician from his District, the late Emile Benoit.

The Member for Cartwright-L'Anse au Clair (Ms. Jones) made a Statement to recognize a group of hard working and dedicated volunteers in her District who had worked towards helping teens quit the unhealthy habit of smoking by participating in the AKick the Nic@ Program.

The Member for Signal Hill-Quidi Vidi (Mr. Harris) made a Statement to acknowledge the important step taken by the Inuit of Labrador towards the creation of Nanutsavut - Our Beautiful Land - as a recognized Inuit Territory and a third order of First Nations Government. The Member noted that the eventual agreement will allow a large measure of self-determination and self-government to the Inuit people of the Province.

The Honourable the Minister of Transportation, Works and Aboriginal Affairs (Mr. Rideout) made a Statement on behalf of the Province to congratulate the Labrador Inuit Association and their President, Mr. William Andersen III on the successful Inuit ratification vote with respect to the Labrador Inuit Land Claims Agreement.

The Honourable the Minister of Finance and President of Treasury Board (Mr. Sullivan) made a Statement to announce that Standard & Poor's Rating Services had affirmed the Province's current credit rating at A- and that the outlook was considered stable.

The Honourable the Minister of Human Resources, Labour and Employment (Ms. Burke) made a Statement to draw attention to a public education campaign launched by the Workplace, Health, Safety and Compensation Commission to promote safety at work in an effort to prevent workplace injuries, illnesses and deaths.

The Honourable the Minister of Human Resources, Labour and Employment (Ms. Burke) tabled:

- (a) the 2002-03 Annual Report of the Department of Human Resources and Employment; and
