The House met at 1:30 o'clock in the afternoon pursuant to adjournment.

The Member for Bonavista South (Mr. Fitzgerald) made a Statement to congratulate Mr. Marv Ryder of Bonavista on receiving the Hockey Canada Order of Merit Award during Hockey Canada's Annual Awards Dinner in Thunder Bay.

The Member for Bay of Islands (Mr. Joyce) made a Statement to congratulate the members of the Meadows Volunteer Fire Department who recently participated in a two day basic firefighting course held in the Regional Fire Training Centre in Gillams.

The Member for St. Barbe (Mr. Young) made a Statement to commend the Joint Council of the Northern Peninsula for organizing a meeting of government representatives and business leaders in order to discuss new approaches of developing that area of the Province.

The Member for Grand Falls-Buchans (Ms. Thistle) made a Statement to congratulate Ms. Alice Dicks and Ms. Loretta Osmond, owner and manager of the Lilac Tree in her District on receiving the 2003 Tourist Choice Award for being chosen the number one craft and gift shop in Central Newfoundland. The Member for Trinity-Bay de Verde (Ms. Johnson), on behalf of the Select Committee appointed to draft a reply to the Speech of His Honour the Lieutenant-Governor, presented the Report of the Select Committee as follows:

The Member for Lake Melville (Mr. Hickey) presented a Petition on behalf of certain residents of his District in particular those from the outfitting and tourist industries requesting the Government of Newfoundland and Labrador to repeal the prohibition on Sunday hunting under the *WildLife Act*.

The Honourable the Minister of Fisheries and Aquaculture and Labrador Affairs and Member for The Straits & White Bay North (Mr. Taylor) presented a Petition on behalf of

certain residents of the Northern Peninsula and Southern Labrador requesting the Government of Newfoundland and Labrador to maintain the present services approved by the Grenfell Regional Health Services and to maintain the present board structure while providing the necessary funding to fulfill its mandate.

On motion it was ordered that Bill No. 32 be printed being entitled as above and that it be submitted to His Honour the Lieutenant Governor for His Assent.

The Sergeant-at-Arms announced the arrival of His Honour the Lieutenant Governor.

His Honour the Lieutenant Governor the Honourable Edward Roberts, Q.C. took the Chair.

The Speaker addressed His Honour by formally extending to His Honour and his family the condolences of all Members on the passing of his father, Dr. Harry Roberts. Whereupon His Honour the Lieutenant Governor replied by thanking the Speaker, the Honourable the Premier, the Leader of the Opposition and the Member for Signal Hill-Quidi Vidi for their kind remarks.
