The House met at 1:30 o'clock in the afternoon pursuant to adjournment.

By leave, the Honourable the Minister of Justice and Attorney General (Mr. Marshall) gave notice and moved a Resolution that Mr. Philip Wall be appointed the new Information and Privacy Commissioner in accordance with section 42.1 of the *Information and Privacy Act* with effect as of December 13<sup>th</sup>, 2004. The Leader of the Opposition (Mr. Grimes) and the Member for Signal Hill - Quidi Vidi (Mr. Harris) spoke and gave their concurrence to the Minister's Resolution.

The Speaker put the question on the Resolution and declared the Resolution carried.

The Member for Exploits (Mr. Grimes) made a Statement to congratulate two talented individuals from the Exploits Valley namely: Mr. Corey Tetford and Mr. Barry Canning who were recently recognized for their talents by the Music Industry Association of Newfoundland and Labrador.

The Member for St. John's Centre (Mr. Skinner) made a Statement to recognize the unsung angels of the Christmas season namely the many volunteers who give of their time and resources to help those who are less fortunate than themselves.

The Member for Port de Grave (Mr. Butler) made a Statement to congratulate Ms. Nellie Strowbridge, formerly from the Port de Grave District who had recently released her second book entitled *Far From Home -* Dr. *Grenfell's Little Orphan*.

The Honourable the Premier (Mr. Williams) made a Statement to pay tribute and offer condolences to the family of the late Honourable Fabian O'Dea, former Lieutenant Governor of the Province, a prominent and outstanding citizen. The Leader of the Opposition (Mr. Grimes) and the Member for Signal Hill-Quidi Vidi (Mr. Harris) also spoke and agreed that the Speaker send a letter to the family of the late Mr. O'Dea expressing the condolences of all Members.

The Honourable the Minister of Tourism Culture & Recreation (Mr. Shelley) made a Statement to advise Members that applications were available for the Premier's Athletic Awards, a program designed to assist provincial athletes to compete at the national and international levels.

The Opposition House Leader (Mr. Parsons) raised a point of order respecting the use of lecterns by Members and whether cellular telephones and other communication and electronic devices could be used in the Chamber during debate.

## Monday, December 13<sup>th</sup>, 2004

The Speaker (Mr. Hodder) tabled the Report of the Commission of Internal Economy for the fiscal year April 1, 2003 to March 31, 2004.

The Honourable the Minister of Finance and President of Treasury Board (Mr. Sullivan) gave notice that he would on tomorrow Move that the House Resolve itself into a Committee of the Whole to Consider certain Resolutions relating to the Granting of Supplementary Supply To Her Majesty (Bill No. 67).

The Honourable the Minister of Justice and Attorney General (Mr. Marshall) gave notice that he would on tomorrow ask leave to introduce a Bill entitled, "An Act To Amend The Law Society Act, 1999" (Bill No. 66).

The Member for Terra Nova (Mr. Oram) gave notice that he would on tomorrow move the following Resolution:

"WHEREAS today seniors make up approximately 13 percent of the Province's population and by 2021, Statistics Canada predicts the number of seniors to grow to more than one-guarter of the Province's population;

**AND WHEREAS** it is necessary for Government to incorporate this demographic shift into its planning process;

**AND WHEREAS** seniors have, and continue to make, significant contributions to building our Province;

**AND WHEREAS** the Government is committed to encouraging the participation of seniors in planning for and responding to their needs;

THEREFORE BE IT RESOLVED that this House of Assembly support recent Government initiatives, such as the creation of the Division of Aging and Seniors, the Provincial Advisory Council on Aging and Seniors and the Ministerial Council on Aging and Seniors, which allow for significant participation and input from seniors to assist Government in planning for and developing policies, programs and services that better accommodate an aging population, promote healthy aging, and foster an environment that better understands aging."

The Member for Cartwright - L'Anse au Clair (Ms. Jones) presented a Petition on behalf of certain residents of her District requesting the Government of Newfoundland and Labrador to continue snow clearing on the Red Bay to Lodge Bay section of the Trans Labrador Highway during the winter months.

The Member for Labrador West (Mr. Collins) presented a Petition on behalf of certain residents of the Province requesting the Government to increase funding for problem gambling, strictly to enforce the existing VLT regulations, at the very least remove VLTs from venues frequented by individuals under 19 years of age and to hold a province wide referendum on banning video lottery terminals in conjunction with municipal elections in 2005.

The Member for Burgeo & La Poile (Mr. Parsons) presented a Petition on behalf of certain residents of the Province opposing the proposed mandatory snowmobile trail permits, and any supporting regulations and restrictions that will negatively impact their snowmobiling culture under Bill No. 45, "An Act To Amend The Motorized Snow Vehicles And All Terrain Vehicles Act" until public consultations have been held.

The Member for Carbonear-Harbour Grace (Mr. Sweeney) presented a Petition on behalf of certain residents requesting the Government of Newfoundland and Labrador to reinstate operations and rehire scale operators in Port aux Basques, Foxtrap and other locations to protect the safety of citizens of Newfoundland and Labrador.

Pursuant to order and on motion debate commenced and concluded on Second

Reading of a Bill entitled, "An Act Respecting The Government Purchasing Agency" (Bill No. 41) and on motion it was ordered that Bill No. 41 be read a second time presently.

Pursuant to order and on motion the Bill entitled, "An Act Respecting The Government Purchasing Agency" (Bill No. 41) was read a second time and on motion it was ordered that Bill No. 41 be referred to a Committee of the Whole House presently.

Pursuant to order and on motion debate commenced on Second Reading of a Bill entitled, "An Act To Amend The Public Tender Act" (Bill No. 53) and on motion debate was adjourned for further debate on tomorrow.

The Honourable the Government House Leader (Mr. Ed Byrne) moved pursuant to Standing Order 11 that the House not adjourn at 5:30 o'clock in the afternoon and that the House not adjourn at 10 o'clock in the evening.

The Chair ruled the amendment in order.

The Chair put the question on that amendment and declared that amendment defeated.

The Committee passed the Bill entitled, "An Act To Amend The House Of Assembly Act And The Elections Act, 1991" (Bill No. 40) with an amendment.

The Committee considered and passed the Bill entitled, "An Act Respecting Court Security" (Bill No. 54).

The Committee considered and passed the Bill entitled, "An Act To Remove Anomalies And Errors In The Statute Law" (Bill No. 59).

The Committee considered the Bill entitled, "An Act To Provide For The Registration Of Lobbyists" (Bill No. 43).
