The Speaker resumed the Chair.

The Chairperson of the Committee of the Whole House (Mr. Fitzgerald) reported that the Committee of the Whole House had considered the matters to it referred and had passed the Bill entitled, "An Act To Amend The Liquor Corporation Act" (Bill No. 61) without amendment and asked leave to sit again.

On motion the report of the Committee was received and adopted.

On motion it was ordered that Bill No. 61 be read a third time presently.

The Honourable the Government House Leader moved pursuant to Standing Order 47 that the debate on Bill No. 61 entitled, "An Act To Amend The Liquor Corporation Act" standing in the name of the Honourable the Minister of Finance and President of Treasury Board and any amendments to that motion for Third Reading of Bill No. 61 shall

not be further adjourned and that further consideration of any amendments relating to Third Reading of Bill No. 61 shall not be further postponed.

The Speaker put the question on the motion and declared the motion carried.

Pursuant to order and on motion the Bill entitled, "An Act To Amend The Liquor Corporation Act" (Bill No. 61) was read a third time and passed.

On motion it was ordered that Bill No. 61 be printed being entitled as above and that it be submitted to His Honour the Lieutenant Governor for His Assent.

On motion of the Honourable the Government House Leader (Mr. Ed Byrne) the House resolved itself into a Committee of the Whole House.

The Speaker left the Chair. Mr. Fitzgerald took the Chair of Committee of the Whole House.

The Chair put the question on the motion and declared the motion carried.

The Speaker recessed the House for a few minutes to await the arrival of His Honour the Lieutenant Governor.

The Sergeant-at-Arms announced the arrival of His Honour the Honourable Edward Roberts, Q.C. the Lieutenant Governor of Newfoundland and Labrador.

The Speaker left the Chair.

His Honour the Lieutenant Governor took the Chair.

The Speaker addressed His Honour the Lieutenant Governor as follows:

The Honourable the Government House Leader (Mr.Ed Byrne) moved, "That when this House adjourns today, it stands adjourned until the call of the Chair. The Speaker, or in the absence from the Province the Deputy Speaker, may give notice and thereupon the House shall meet at the time and date stated by the notice of the proposed sitting. And I also move that this House do now adjourn".
