

Thursday, March 30th, 2006

The House met at 2 o'clock in the afternoon pursuant to adjournment.

The Honourable the Minister of Finance and President of Treasury Board (Mr. Sullivan) moved "That This House Approves in General the Budgetary Policy of the Government." In making the motion the Honourable the Minister of Finance and President of Treasury Board delivered the Budget Speech.

It was moved by the Honourable the Minister of Finance and President of Treasury Board that debate on the Budget Speech be adjourned for further debate on tomorrow.

The Speaker put the question on the motion.

The motion was carried.

The Honourable the Minister of Finance and President of Treasury Board (Mr. Sullivan) informed the House that he had received a Message from His Honour the Lieutenant Governor. The Message was read to the House by the Speaker as follows:

"30 March, 2006

As the Lieutenant Governor of the Province of Newfoundland and Labrador, I transmit Estimates of sums required for the Public Service of the Province for the year ending 31 March, 2007, in the aggregate of \$4,424,206,400, and in accordance with the provisions of sections 54 and 90 of the *Constitution Act, 1867*, I recommend these Estimates to the House of Assembly.

It was moved by the Honourable the Minister of Finance and President of Treasury Board (Mr. Sullivan) that the Message together with the Estimates, be referred to a Committee of the Whole on Supply.

Pursuant to order and on motion the House resolved itself into a Committee of the Whole on Supply.

The Chairperson of the Committee reported that the Committee had considered the matters to it referred, had made some progress and asked leave to sit again.

On motion the report of the Committee was received and adopted and it was ordered that the Committee have leave to sit again on tomorrow.

The Honourable the Minister of Finance and President of Treasury Board (Mr. Sullivan) gave notice that he would on tomorrow move that the House Resolve itself into a Committee of the Whole to consider certain Resolutions respecting the Imposition of Taxes on Tobacco (Bill No. 6).

The Honourable the Government House Leader (Mr. Ed Byrne) gave notice and moved:

Newfoundland and Labrador Housing Corporation

By leave, the Speaker put the question on the motion and declared the motion carried.

It was moved and seconded that when the House rose it would adjourn until tomorrow, Monday, April 3rd at 1:30 o'clock in the afternoon.

On motion the House then adjourned accordingly.
