The House met at 1:30 o'clock in the afternoon pursuant to adjournment.

The Member for St. John's Centre (Mr. Dinn) made a Statement to recognize Walter Harding and his team for his contribution to the community in carrying out litter clean-ups in the City for 25 years.

The Member for Topsail – Paradise (Mr. Dinn) made a Statement to thank Louise and Bernie Mercer for instituting an annual food drive as a tribute to their late children Alex and Riley.

The Member for Windsor Lake (Mr. Crosbie) made a Statement to pay tribute to the staff and volunteers of the MacMorran Community Centre who continued to operate its food bank to provide the essentials for those in the Community.

The Member for Humber – Bay of Islands (Mr. Joyce) presented a Petition from certain residents of the Province calling upon the House of Assembly to urge Government to ensure urgent repair work on Route 450 and other upgrades are carried out during the 2020 construction season.

The Honourable the Minister of Transportation and Works (Mr. Crocker) replied to the Petition.

The Member for Conception Bay South (Mr. Petten) presented a Petition from certain residents of the Province calling upon the House of Assembly to urge Government to take the necessary steps to repair and repave roads in the District of Harbour Main, which are in need of upgrading, to ensure the safety of the driving public who use them on a regular basis.

The Honourable the Minister of Transportation and Works (Mr. Crocker) replied to the Petition.

The Member for Torngat Mountains (Ms. Evans) presented a Petition from certain residents of the Province calling upon the House of Assembly to urge Government to provide an air transportation subsidy to reduce the cost of airfare between Happy Valley-Goose Bay and the northern Labrador communities.

The Member for Harbour Main (Ms. Conway Ottenheimer) presented a Petition from certain residents of the Province calling upon the House of Assembly to urge Government to take the necessary steps to immediately repair and restore the train trestle in the Seal Cove Channel to ensure boater safety of the general public who use this channel for their recreational pleasure.

The Honourable the Minister of Tourism, Culture, Industry and Innovation (Mr. Davis) replied to the Petition.

The Member for St. John's Centre (Mr. Dinn) presented a Petition from certain residents of the Province calling upon the House of Assembly to urge Government to update anti-racism education in Newfoundland and Labrador secondary schools.

The Honourable the Minister of Education and Early Childhood Development (Mr. Warr) replied to the Petition.

The Member for Labrador West (Mr. Brown) presented a Petition from certain residents of the Province calling upon the House of Assembly to urge Government to bring forward amendments to the *Labour Relations Act* to impose binding arbitration (when only one of two parties makes application) in cases where strikes or lockouts are prolonged, where collective bargaining has failed, or when it is in the public interest to do so; and to also bring forward amendments to the *Labour Relations Act* to ban the use of replacement workers.

The Member for Grand Falls – Windsor – Buchans (Mr. Tibbs) presented a Petition from certain residents of the Province calling upon the House of Assembly to urge Government to ensure proper maintenance is carried out on the Buchans Highway permanently or regularly to obviate the need to repair a new highway again to prevent accidents.

The Honourable the Minister of Transportation and Works (Mr. Crocker) replied to the Petition.

The Member for Topsail – Paradise (Mr. Dinn) presented a Petition from certain residents of the Province calling upon the House of Assembly to urge Government to develop a childcare strategy that will provide affordable, accessible and quality childcare for Newfoundland and Labrador parents of different economic and social backgrounds.
