Pursuant to order and on motion the Bill entitled "An Act To Amend The Pension Benefits Act, 1997" (Bill No. 54) was read the second time and on motion it was ordered that Bill No. 54 be referred to a Committee of the Whole presently.

On motion of the Honourable the Government House Leader (Mr. Crocker) the House resolved itself into a Committee of the Whole House to consider a Bill entitled "An Act To Amend The Pension Benefits Act, 1997" (Bill No. 54).

The Speaker left the Chair.

Mr. Pardy took the Chair of Committee of the Whole House.

On motion the Committee rose.

On motion it was ordered that the said Bill be printed being entitled as above and that it be submitted to Her Honour the Lieutenant Governor for her assent.

It was moved and seconded that when the House rose it would adjourn to the call of the Chair.

On motion the House then adjourned accordingly.
