Pursuant to notice and on motion, debate commenced and concluded on the resolution standing in the name of the Member for Stephenville - Port au Port (T. Wakeham):

Pursuant to notice and on motion, debate commenced on the motion standing in the name of the Government House Leader (S. Crocker) as follows:

**THAT** this House concur in the report of the Commissioner for Legislative Standards entitled, "The Joyce Report, April 12, 2022";

**AND THAT** the Member for Humber Bay of Islands is directed to submit the required information to the Commissioner for Legislative Standards within 7 business days of the adoption of this resolution;

**AND THAT** should the information not be submitted, in accordance with paragraph 45(1)(c) of the House of Assembly Act, the Member for Humber-Bay of Islands be suspended from the House of Assembly;

**AND THAT** the said suspension be without pay and shall continue until such time that the Commissioner for Legislative Standards advises the Speaker that the statutory obligations referred to in the Report have been met.

During the debate, the Member for Carbonear - Trinity - Bay de Verde (S. Crocker) moved an amendment.

The Speaker recessed the proceedings to consider the amendment.

The Speaker resumed the Chair and ruled the amendment in order.

Debate resumed and concluded on the amendment and the motion itself.

The Speaker put the question and declared the amendment carried.

The motion then read:

**THAT** this House concur in the report of the Commissioner for Legislative Standards entitled, "The Joyce Report, April 12, 2022";

**AND THAT** the Member for Humber - Bay of Islands is directed to submit the required information to the Commissioner for Legislative Standards within 7 clear sitting days of the adoption of this resolution;

**AND THAT** the Speaker is ordered to appoint a mediator to assist the parties to resolve the matters described in the Report;

**AND THAT** the mediator appointed by the Speaker shall, within 7 clear sitting days, report to this House;

**AND THAT** if the House is not then in session, that report may be tabled as if it were a report under section 19.1 of the House of Assembly Act;

**AND THAT** where the mediator finds that a resolution cannot be achieved due to unwillingness by the MHA for Humber - Bay of Islands to comply with a reasonable requirement of the Commissioner for Legislative Standards and as a result the Member's statutory obligations are still outstanding, the Member for Humber - Bay of Islands shall, as of the date of the tabling of the mediator's report, be suspended from the House of Assembly in accordance with paragraph 45(1)(c) of the House of Assembly Act;

**AND THAT** the said suspension be without pay and shall continue until such time that the Commissioner for Legislative Standards advises the Speaker that the statutory obligations referred to in the Report have been met.

The Speaker put the question on the motion as amended and declared the motion carried.

Pursuant to order and on motion, the House resolved itself into a Committee of the Whole on Supply to consider the estimates of the Legislature and the Executive Council.

The Speaker left the Chair.

The Deputy Speaker (B. Warr) took the Chair of Committee of the Whole on Supply.

On motion, the Committee rose.

The Speaker resumed the Chair.

The Chair (B. Warr) reported the Committee of the Whole on Supply had considered the matters to them referred and had passed without amendment the estimates of the Legislature and Executive Council.

The Speaker put the question and it was ordered the report be received and adopted.
