WHEREAS the Government of Newfoundland and Labrador has committed to achieving net-zero by 2050.

WHEREAS the Government of Canada's decision to impose the Federal carbon tax and to enact the *Clean Fuel Regulations* (Canada) fails to acknowledge the Government of Newfoundland and Labrador's efforts to meet emission targets and fails to consider the hardship that residents, families and businesses are experiencing with the high cost of living resulting, in part, from the COVID-19 pandemic.

WHEREAS the Federal carbon tax and the *Clean Fuel Regulations* (Canada) have a disproportionate impact on Newfoundlanders and Labradorians.

WHEREAS the Government of Canada's decision to impose the Federal carbon tax and to enact the *Clean Fuel Regulations* (Canada) does not consider this province's unique geography and economy.

WHEREAS the imposition of the Federal carbon tax and the enactment of the *Clean Fuel Regulations* (Canada) further amplifies the dramatic increases in food prices, and costs for energy, transportation and other essential goods and services in this province.

WHEREAS the Premier has publicly expressed his belief that the carbon tax and the *Clean Fuel Regulations* (Canada) be repealed and has stated this belief in a letter to the Prime Minister dated August 15, 2023.

THEREFORE BE IT RESOLVED that this House urge the Government of Canada to immediately repeal the carbon tax and the *Clean Fuel Regulations* (Canada).
