8. Member for Stephenville - Port au Port – To move:

WHEREAS targeted relief solutions are needed that lift people from crisis, keep their homes warm, ensure their families are fed and healthy;

AND WHEREAS many people in Newfoundland and Labrador are struggling to survive soaring food costs, skyrocketing housing costs, gas prices through the roof, and a carbon tax on top of all their other taxes and fees;

AND WHEREAS we have seniors sharing medication, or cutting their pills in half, because they can't afford the cost of the medicines they need. Many seniors are living below the poverty line, too poor to stay healthy;

BE IT RESOLVED THAT this Hon. House urge the government to:

- order a complete review of all taxes and fees, cutting or adjusting those that are hurting people;
- lead the charge to end the carbon tax for good;
- eliminate the sugar tax;
- continue the provincial gas tax relief;
- order a complete review of the Income Support Program and an evaluation of all programs and services intended to support vulnerable populations to ensure they deliver;
- index the seniors benefit programs to inflation; and
- deliver a new poverty reduction strategy.
