Issue: Appeal of Claim Ruling – Supporting Documentation for Proof of Payment

Background:

- The Member for Conception Bay East-Bell Island is appealing the denial of payment by Corporate and Members' Services Division of certain allowable expenses incurred by the Member. The expenses were rejected as the claim for reimbursement did not contain the appropriate supporting documentation for proof of payment.
- Subsection 16(4) of the Members Resources and Allowances Rules states that
 - (4) A member's claim, except a daily allowance or mileage claim, shall not be paid unless it is supported by the original invoice together with the instrument evidencing payment, such as a credit card voucher or notification, debit card voucher, cancelled cheque or cash receipt.
- Subsections 24(1), 24(8) and 24(9) of the *House of Assembly Accountability*, *Integrity and Administration Act* (the Act) state:
 - 24(1) Where a member incurs an expense and a claim for reimbursement, or payment has been rejected by an officer or staff member of the House of Assembly service, or the member is unsure as to whether an expense, if incurred, will qualify for reimbursement or payment, he or she may request a ruling from the speaker.
 - (8) Where the ruling of the speaker is that the expenditure does not comply with the rules and directives of the commission, the member may appeal that ruling to the commission and, after giving the member an opportunity to make a submission in writing in support of the appeal, the commission may decide to reverse, uphold or modify the ruling of the speaker, and the decision of the commission is final.

- (9) Notwithstanding that an expense claim has been denied by an officer, staff member or the speaker, in accordance with the rules, where there is an appeal to the commission under this section and the commission determines that that claimed expense amount
 - (a) has been incurred by the member; and
 - (b) is a permitted expense under the Act and rules; and
 - (c) does not exceed an expense amount or allowance allocation permitted under the rules,

and a denial of payment of the expense amount would, in the opinion of the commission, be unjust, the commission may approve the expenditure for the claimed expense to the extent that the commission considers to be just and the decision of the commission is final.

- The expenses submitted, totaling \$51.28, are permitted expenses under the *Members Resources and Allowances Rules* (the Rules). The Member used a gift card in the amount of \$25.00 to pay for a portion of the expenses, and paid the remaining balance (\$26.28) using credit card. However, the proof of payment slip obtained from the vendor only showed the balance paid by credit card, and not the portion paid by gift card.
- Following a review of the claim and supporting documentation by the Corporate and Members' Services Division, it has been determined it is not eligible for reimbursement as the documentation provided for proof of payment does not comply with the provisions of subsection 16(4) of the Rules.
- The attached letter from the Member for Conception Bay East-Bell Island provides further details.

Background:

- Subsection 43(9) of the *House of Assembly Accountability, Integrity and Administration Act* states that:
- (9) In addition to the financial audit required by this section, the auditor general shall perform and complete a compliance audit at least once during every General Assembly to determine and express an opinion on whether
 - (a) collections of public money

(i) have been effected as required under law and directives and decisions of the commission,

- (ii) have been fully accounted for, and
- (iii) have been properly reflected in the accounts of the province;
- (b) disbursements of public money

(i) have been made in accordance with the authority of a supply vote, or relevant law,

(ii) have complied with regulations, rules, directives and orders applicable to those disbursements,

- (iii) have been properly reflected in the accounts, and
- (iv) have been made for the purposes for which the money was appropriated and authorized;
- (c) accounts have been faithfully and properly kept;

(d) assets acquired, administered or otherwise held by or for the House of Assembly and the statutory offices are adequately safeguarded and accounted for;

(e) accounting systems and management control systems that relate to revenue, disbursements, safeguarding or use of assets or the determination of liabilities are in existence, are adequate and have been complied with;

(f) accountability information with respect to the operations of the House of Assembly and the statutory offices is adequate; and

(g) there are factors or circumstances relating to expenditure of public money which in the opinion of the auditor general should be identified and commented on as part of the audit function.

- The Compliance Audit Report for the period October 11, 2011 to March 31, 2014 is attached. The report is for information purposes only.
- At its January 8th. 2015 meeting, the Audit Committee met with the Auditor General to discuss the results of the Compliance Audit Report. The Auditor General identified some weaknesses relating to the administration of the operational funding grants of the caucuses and Speaker and made recommendations on actions which should be taken to address these weaknesses. The Audit Committee endorses the recommendations of the Auditor General and, in the attached letter to the Commission dated January 8th, 2015, makes recommendation accordingly.
- The recommendations of the Audit Committee require amendments to the Caucus Operational Funding Grants Policy approved by the Commission in February, 2010. If the Commission so directs, House officials can draft revisions to the current policy to reflect the recommendations of the AG and the Audit Committee. The new policy can be brought forward to a future meeting of the Commission for consideration and approval.

INDEPENDENT AUDITOR'S REPORT

To the Members of the House of Assembly Management Commission Province of Newfoundland and Labrador

I have audited the 47th General Assembly's compliance with the provisions established by section 43(9) of the *House of Assembly Accountability, Integrity and Administration Act* (the *Act*) for the period October 11, 2011 to March 31, 2014, to determine whether:

- collections of public money have been effected as required under law and directives and decisions of the House of Assembly Management Commission have been fully accounted for and have been properly reflected in the accounts of the Province;
- disbursements of public money have been made in accordance with the authority of a supply vote or relevant law, have complied with regulations, rules, directives and orders applicable to those disbursements, have been properly reflected in the accounts, and have been made for the purposes for which the money was appropriated and authorized;
- accounts have been faithfully and properly kept;
- assets acquired, administered or otherwise held by or for the Assembly are adequately safeguarded and accounted for;
- accounting systems and management control systems that relate to revenue, disbursements, safeguarding or use of assets or the determination of liabilities are in existence, are adequate and have been complied with; and
- accountability information with respect to the operations of the Assembly is adequate.

INDEPENDENT AUDITOR'S REPORT (cont.)

Compliance with the provisions of section 43(9) of the *Act* is the responsibility of the Assembly. My responsibility is to express an opinion on this compliance based upon my audit.

I conducted my audit in accordance with Canadian generally accepted auditing standards. Those standards require that I plan and perform an audit to obtain reasonable assurance whether the Assembly complied with the provisions established by the *Act* as referred to above. Such an audit includes examining, on a test basis, evidence supporting compliance, evaluating the overall compliance with these provisions, and where applicable, assessing the accounting principles used and significant estimates made by management.

In my opinion, the General Assembly was in compliance, in all material respects, with the provisions established by section 43(9) of the *Act* for the period October 11, 2011 to March 31, 2014. I also report that there are no factors or circumstances relating to the expenditure of public money which in my opinion should be identified and commented on as part of the audit function.

At the meeting of the Audit Committee held on January 8th, 2015 the Committee met separately with the Auditor General, and the Clerk and the Chief Financial Officer, to discuss the results of the Compliance Audit performed by the Auditor General pursuant to subsection 43(9) of the *House of Assembly Accountability, Integrity and Administration Act.* The Auditor General identified some weaknesses relating to the administration of the operational funding grants of the caucuses and the Speaker, and made recommendations regarding action which should be taken to address these weaknesses. The Audit Committee has considered the findings of the Auditor General with respect to the caucus funding grants, endorses the recommendations of the Auditor and recommends accordingly that the Management Commission

- instruct the caucuses and the Speaker to perform monthly bank reconciliations as a control procedure for the bank accounts related to caucus operational funding grants;
- instruct the Government Members' Caucus and the Official Opposition Caucus to maintain supporting documentation related to expenditures incurred through their caucus operational funding grants;
- instruct the Third Party Caucus to ensure that the records they maintain reconcile to the annual summary of expenditures report;
- revise policy to require that the annual summary of expenditures report template related to caucus operational funding grants include a reconciliation of expended and unexpended balances on a year over year basis to ensure all money is accounted for and spent for the purpose for which it was intended;

- instruct each caucus and the Speaker to establish and implement control procedures over reimbursable expenditures to promote the accountability of operational funding grants and
- instruct the Government Members' Caucus to have cheque images returned on its monthly bank statements or to make a photocopy of each cheque issued to enable the caucus to complete a thorough review of the disbursements from the bank account.

Title: MHA Pensions

Issue: Strategy for Review of MHA Pensions

Background:

- In accordance with the *House of Assembly Accountability, Integrity and Administration Act,* a Members' Compensation Review Committee is appointed at least once during each General Assembly to review and make recommendations with respect to MHA salaries, pensions, severance and allowances.
- In 2009, the first Members' Compensation Review Committee (MCRC) made recommendations with respect to MHA pensions which were approved by the Commission at its December 2, 2009 meeting (CM 2009-071 refers). The required legislative amendments were approved by the House on December 15, 2009. The amendments included a reduction of the pension accrual rate; a reduction in the maximum amount of pension accrual; and, changes to the pension plan eligibility criteria.
- In 2012, the MCRC made several recommendations with respect to pensions. At its February 27, 2013 meeting the Commission deferred the decision respecting the composition of the next MCRC and the resources to be provided to it, to the Management Commission in place at the time of its appointment. CM 2013-013, 014, 015, and 016 refer.
- The Commission endorsed the following MCRC recommendation and directed the Speaker to develop a strategy for undertaking a thorough review of the proposal.
 - Immediately upon receipt of this report, the Management Commission should adopt recommendation 78 of the Green Report and develop a proposal that either converts the MHA pension plan to a defined contribution plan or significantly modifies the existing defined benefit plan. This proposal should be submitted to the next Members' Compensation Review Committee and that Committee should be given the necessary time and resources to conduct a thorough review of the proposal and of the existing MHA pension plan.
- The Commission directed that the proposed strategy be brought to a future meeting for review and approval. The attached strategy has been developed in consultation with officials of the Department of Finance.
- The Speaker has written the Minister of Finance requesting that the Department of Finance undertake an actuarial review of the MHA Pension Plan.

Strategy to Review MHA Pension Plan

The Report of the Review Commission on Constituency Allowances and Related Matters was released in May, 2007 and included the following recommendations with respect to MHA pensions.

- The House of Assembly Management Commission, assisted by the Department of Finance, should proceed to develop a proposed new pension structure for MHAs: (a) eliminating the existing defined benefit plan and implementing a defined contribution, RRSP type of arrangement that takes account of cost and level of benefits relative to other public service plans; or (b) significantly modifying the terms of the existing defined benefit plan to make it conform more closely, in terms of levels of benefits, with other public service plans;
- The new pension structure should be developed on the basis that it will apply only to MHAs who have not already been elected to the House and that existing and former MHAs be "grandfathered" under the existing system;
- The proposed new pension structure should be submitted to the next committee on Members' salaries, benefits and allowances constituted under the new *House of Assembly Accountability, Integrity and Administration Act* as recommended elsewhere in this report, and that that committee should be provided with sufficient funding to engage actuarial and other advice to enable a thorough study of the appropriate levels and features of the plan that should be adopted; and
- Following receipt of this Commission's report, government should introduce legislation within six months effecting the recommended changes.
- In the future, matters of pension policy related to the pension benefit structure for MHAs should be referred to the review committee on Members' salaries, benefits and allowances constituted under the new *House of Assembly Accountability, Integrity and Administration Act* as recommended elsewhere in this report, as part of the committee's mandate as a matter of course so that they can be addressed in the same context as salaries and other key compensation arrangements for MHAs.

The *House of Assembly Accountability, Integrity and Administration Act* (the Act), passed in June, 2007, included a provision for the appointment of a committee, during each General Assembly, to review and make recommendations with respect to MHA salaries, pensions,

severance and allowances. The Committee, known as Members' Compensation Review Committee (MCRC) has 120 days to complete its review and submit its report to the House of Assembly.

The first Members' Compensation Review Committee (MCRC) submitted its report in October, 2009. The report recommended that the MHA pension plan accrual rate be reduced from 5% per year for the first 10 years and 2.5% per year from year 11 to 20, to 3.5 % per year for each year to a maximum of 20 years. This effectively reduced the maximum pension accrual from 75% to 70%. Currently there is no maximum accrual for the Public Service Pension Plan, Teachers Pension Plan or the Uniformed Services Pension Plan.

It also recommended changing the pension plan eligibility criteria so that an MHA would be eligible for pension entitlement at the age of 55 years provided that MHA has at least 5 years service as an MHA and has served in at least two General Assemblies. The Member could also elect to take a reduced pension between the ages of 50 and 55 years with a minimum of 5 years as an MHA and having served in at least two General Assemblies. In this case, the MHA pension would be reduced by 6% for each year below the age at which the Member's unreduced pension would begin.

At its December 2, 2009 meeting, the Commission approved the recommendations of the Members' Compensation Review Committee regarding pensions, including the proposed legislative amendments, subject to final wording by the Office of Legislative Counsel. The new provisions applied to those Members elected after December 31, 2009. (CM 2009-071 refers.)

The amendments to the *Members of the House of Assembly Retiring Allowances Act* received Royal Assent on December 15, 2009.

The second MCRC submitted its report in November 2012 and recommended that the current MHA pension scheme remain unchanged but that, immediately upon receipt of the MCRC report, the Management Commission should adopt recommendation 78 of the Green Report

and develop a proposal that either converts the MHA pension plan to a defined contribution plan or significantly modifies the existing defined benefit plan. This proposal should be submitted to the next Members' Compensation Review Committee and that Committee should be given the necessary time and resources to conduct a thorough review of the proposal and of the existing MHA pension plan.

The MCRC also recommended that the next Members' Compensation Review Committee be provided with actuarial and other resources necessary to conduct a thorough review of the MHA pension plan and that an actuary be appointed as one of the members of the next Members' Compensation Review Committee.

At its February 27, 2013 meeting, the Commission adopted recommendation 5 of MCRC 2012 that the current MHA pension plan remain unchanged and endorsed the proposal outlined in recommendation 6 of MCRC 2012 that either the MHA pension plan be converted to a defined contribution plan or that the existing defined benefit plan be significantly modified. <u>The Commission directed the Speaker to develop a strategy for undertaking a thorough review of the proposal. This proposed strategy is to be submitted to the Commission for review and approval at a future meeting of the Commission. (CM 2013-013 and CM 2013-014 refer,)</u>

The Commission did not adopt recommendations 7 and 8 respecting the composition of the next MCRC and the resources to be provided to it and deferred the decisions to the Commission in place at the time of the appointment of the next MCRC. (CM 2013-015 and CM 2013-016 refer.)

In accordance with **CM 2013-014**, an Advisory Committee comprising officials from the House of Assembly and the Pensions Division, Department of Finance has been established and includes:

- a. Sandra Barnes, Clerk of the House of Assembly
- b. Marie Keefe, Policy & Communications Officer, House of Assembly
- c. Maureen McCarthy, Director of Pensions Administration
- d. William Noftall, Manager, Pension Benefits, Human Resource Secretariat

The Committee will conduct and review the pension provisions for elected Members in all Canadian provinces and territories, as well as the federal government. The data will be updated as needed to ensure the most current data is provided to the next MCRC.

The public sector pension plans in NL were modified in 2014 based on the following criteria:

- Current retirees' pensions would not be impacted;
- A defined benefit pension plan would be maintained;
- Accrued benefits would be protected; and
- Joint sponsorship would be provided by a professional Board of Trustees

(The amendments to the Pensions Funding Act and the Public Service Pensions Act, 1991, received Royal Assent on December 16, 2014.)

The Advisory Committee will review the criteria adhered to in the modification of the public sector plans to determine their relevant applicability to the MHA Pension Plan.

The Department of Finance has been requested to do an actuarial review of the MHA Pension Plan.

The Committee will do an analysis of all compiled information and provide both the analysis and the information to the next Members' Compensation Review Committee.
