Departmental Overview

The Intergovernmental Affairs Secretariat (the Secretariat) works to build and strengthen relationships with other governments and international entities to advance Newfoundland and Labrador's intergovernmental and trade policy priorities. The Secretariat supports the Premier and ministers in building important intergovernmental relationships to advance provincial interests and provides strategic advice and support related to domestic and international trade.

Organizational Structure

The Intergovernmental Affairs Secretariat is comprised of three divisions: Economic Policy, Social Policy, and Trade Policy.

- The Economic Policy Division provides intergovernmental policy advice relating
 to resource, environmental, fiscal and economic, industry and technology,
 infrastructure and constitutional priorities. The Division also supports provincial
 participation in First Ministers' Meetings (FMM), the Council of Atlantic Premiers
 (CAP), the Atlantic Growth Strategy (AGS) Leadership Committee, and the
 Conference of New England Governors and Eastern Canadian Premiers.
- The Social Policy Division provides intergovernmental policy advice relating to
 priorities in health, education, immigration and population growth, labour, justice
 and public safety, tourism, culture, and social development, as well as provincial
 interests related to national defence and foreign affairs. This Division also
 supports provincial participation in the Council of the Federation (COF).
- The Trade Policy Division leads the formulation of policy advice and consultative services related to domestic and international trade, including the negotiation and implementation of trade agreements.

Staff and Budget

As of March 31, 2022, the Secretariat had a staff complement of 15 (seven female and eight male), and a budget of approximately \$2,005,000.

The Secretariat is located in the East Block of the Confederation Building in St. John's.

Highlights and Partnerships

Intergovernmental Collaboration on the COVID-19 Pandemic

The COVID-19 pandemic continued to wreak havoc on the global community in 2021-22, which required a multitude of intergovernmental discussions with respect to Canada's response to COVID-19. The Secretariat supported the Premier's participation in regular calls between Canada's Premiers through COF, between Atlantic Premiers through CAP, as well as regular calls between Premiers and the Prime Minister on public health measures in Canada, COVID-19 vaccines, personal protective equipment, and economic and social supports.

Collaboration with Atlantic Provinces and Other Partners

Newfoundland and Labrador continued to serve as the provincial lead for the Atlantic Growth Strategy, a collaborative initiative of the Atlantic Provinces and the Federal Government aimed at accelerating the growth of Atlantic Canada's economy. In this role, the Secretariat co-led initial planning discussions for the next Atlantic Growth Strategy meeting, which was delayed by the COVID-19 pandemic. Through CAP, provinces coordinated a discussion of regional priorities between Atlantic Premiers and federal Intergovernmental Affairs Minister, the Hon. Dominic LeBlanc and Immigration, Refugees and Citizenship Minister, the Hon. Sean Fraser, in March 2022.

In 2021-22, the Secretariat also supported the Province's participation in regional initiatives related to the Atlantic Growth Strategy. The Clean Power Roadmap (released

on March 11, 2022) and the Atlantic Loop project, aim to enhance electricity system interconnections in Atlantic Canada and Quebec. The Secretariat worked on this initiative in consultation and collaboration with the Department of Industry, Energy and Technology, provincial utilities, as well as Provincial and Federal Government partners.

Another initiative saw the Secretariat supporting the Department of Immigration, Population Growth and Skills in working with the Federal Government and Atlantic Provinces to make the Atlantic Immigration Program (AIP) permanent. As Atlantic Canada continues to build a more inclusive and equitable society for newcomers and local residents, the AIP strengthens Newfoundland and Labrador's ability to attract and retain skilled workers and international graduates using an innovative approach to immigrant selection and closer coordination between governments, employers, communities, and settlement agencies to improve the retention of immigrants.

The Secretariat also worked closely with the Department of Education to negotiate multi-year bilateral agreements with the Federal Government that will transform early learning and child care in the province. Funding through these agreements will enable increased access to child care, improved affordability, and improved quality and inclusivity of early learning and child care programming.

Coordination in Key Strategic Priorities

In 2021-22, the Secretariat enhanced its coordination role within the Government of Newfoundland and Labrador in relation to key strategic priorities that require successful intergovernmental engagement and cooperation. A Senior Advisor position was added to the Secretariat, which is responsible for managing the progress of a portfolio of complex initiatives that span multiple lines of business in departments and agencies throughout Government. This position also fosters collaborative and mutually supportive relationships with senior-level cross-functional teams, provides support to enhance file advancement and results; and, manages interdependencies and

coordination across files to ensure that information relating to file deliverables, risks and issues are effectively communicated between senior-level stakeholders. Key strategic priorities may include health care funding, climate change, and a Just Transition (i.e., ensuring an equitable and prosperous future for workers and communities due to the global transition to net-zero).

Domestic and International Trade Policy

During the reporting period, the Secretariat continued to advance domestic and international trade priorities, including the following:

- Chaired Canadian Free Trade Agreement (CFTA) working groups including the Regulatory Reconciliation and Cooperation Table's (RCT's) Administrative Review Working Group, the Trade in Cannabis Working Group, and the Electricity Transmission Working Group.
- Actively participated in a number of working groups under the (CFTA) including the Internal Trade Representatives Table, the Alcoholic Beverages Working Group, and the Procurement Committee.
- Supported the Premier in his participation in the annual Committee on Internal Trade ministerial meeting on December 13, 2021.
- Represented the province for meetings under the new Atlantic Trade and Procurement Partnership (ATPP).
- Represented provincial interests on international trade issues at the Federal-Provincial-Territorial Committee on International Trade (C-Trade) including providing input during the negotiation of the Canada-United Kingdom Trade Continuity Agreement.
- Represented provincial interests in various forums under international trade agreements such as the Canada-European Union Comprehensive Economic and Trade Agreement (CETA) and Canada-United States-Mexico Agreement (CUSMA).
- Provided trade policy advice and analysis to stakeholders and government writ large.

Report on Performance

Issue One – Advancing the Province's Strategic Intergovernmental Priorities

The Secretariat plays a key role in supporting Government's efforts to advance Newfoundland and Labrador's intergovernmental priorities. Priorities are advanced through productive relationships with the Federal Government and other sovereign governments.

In 2021-22, the Secretariat supported the Premier's participation in various intergovernmental meetings and initiatives, including multilateral meetings of COF, CAP, Canada's First Ministers (i.e., Premiers and the Prime Minister), as well as bilateral meetings and discussions with the Prime Minister and federal ministers. The Secretariat also provided support to departments when engaging with other governments, including the negotiation of intergovernmental agreements.

The division will continue to work with other Canadian jurisdictions to make improvements to the Canadian Free Trade Agreement and will work with the Federal Government to ensure that Newfoundland and Labrador interests are reflected in ongoing negotiations with trading partners such as the United Kingdom, India, Indonesia, the Association of Southeast Asian Nations (ASEAN) trading bloc, as well as, any other international trade negotiations that arise.

2022-23 Objective:

By March 31, 2023, the Secretariat will have continued to support the advancement and defence of the Province's domestic and international trade priorities.

2022-23 Indicators:

Furthered coordination of Provincial input on the negotiation of free trade agreements, and provided strategic advice and analysis on the implementation of existing agreements, including responses to protectionist policies in other jurisdictions.

Continued to contribute to advancing the implementation of the CFTA, by continuing to engage in key working groups. This includes chairing the negotiations to incorporate non-medical cannabis into the CFTA and participating in working groups on alcohol, financial services, procurement and the Regulatory Reconciliation and Cooperation Table.

Opportunities and Challenges

Newfoundland and Labrador continues to face a challenging fiscal situation in the context of high debt servicing costs and long-standing structural issues, such as the high costs of providing services across a vast geography, and an aging, declining population. Health care remains a top concern, with Newfoundland and Labrador continuing to see some of the poorest health outcomes in the country and the share of federal funding in the Province's health care system has continued to decline. As other provinces and territories are facing similarly increasing difficulties, there is growing willingness and opportunity to pursue collaborative efforts at this level, and the Province has significantly increased its engagement with both provinces and territories and the Federal Government in this regard.

In addition to long-standing structural issues such as health care, the Province is confronting the worldwide inflationary pressures emerging from the end of the COVID-19 pandemic and the unprovoked Russian invasion of Ukraine. Prices for many goods and services in the Province have increased and present cost-of-living challenges for many residents. There additionally is a growing risk that efforts by central banks to rein in inflation by raising interest rates will lead to economic recession

As European and other countries seek near- and medium-term alternatives to oil and gas supplies from Russia, the Province is in a position to benefit due to its offshore reserves. At the same time, the war in Ukraine is pushing European, North American and other countries to accelerate their shift to renewable energy and clean fuels. This may be bearish for the Province's oil and gas sector in the long run, but the Province's considerable potential for wind energy and hydrogen generation in particular is attracting growing domestic and international interest that can promote the establishment of a thriving clean energy sector. The shift to low-carbon technologies is also driving renewed interest and investment in the Province's mining sector, which produces several minerals that are essential to the production of key clean technologies such as batteries for electric vehicles.

The transition is not without its complications as federally-legislated increases in carbon taxes and increasingly ambitious federal emissions reductions targets, as well as the implications of such measures for Provinces with significant natural resource sectors, raise questions about the affordability and equitability of the transition and its impact on residents. The Province will therefore seek to ensure that these considerations are reflected and accounted for in its engagement with the Federal Government and other stakeholders to ensure a positive and just outcome for Newfoundlanders and Labradorians.

These and other long-standing and emerging challenges and opportunities are driving higher levels of overall engagement by the Province with other provinces and territories, the Federal Government, and foreign governments. This higher level of engagement extends to international trade, as the Province is actively representing its interests in negotiations toward free trade agreements that Canada is engaged in with the United Kingdom, Indonesia, and India. Increased engagement with domestic and foreign governments affords the Province greater opportunity to advocate for its interests and influence key decision-making processes. The Intergovernmental Affairs Secretariat will continue to actively participate in and support engagements across all areas of government to promote and secure the Province's interests.
