Dear Speaker:

Section 214 of the Elections Act states that "The Chief Electoral Office shall publish within 9 months after each general election and each by election a book containing pertinent statistics of the election, including poll by poll results of each electoral district." That report with respect to the February 12, 2007 By Election in the electoral district of Humber Valley is now complete.

Section 273(3) states that "The Chief Electoral Officer shall report annually to the Speaker upon the affairs of the Office of the Chief Electoral Officer under this part and the report shall be laid before the House of Assembly at the first convenient opportunity."

I am enclosing at this time copies of the Humber Valley By Election for distribution to Members of the House of Assembly as per Section 19.1 (1) and (2) of the House of Assembly Act as outlined below.

19.1 (1) Notwithstanding another Act, where a report or other document that an officer of the House of Assembly is required to submit to the House of Assembly is submitted to the Speaker or the Clerk of the House of Assembly when the Assembly is not in session, the Speaker or the Clerk shall provide a copy to each member and make it available for inspection by the public immediately after the report or other document is submitted.

(2) A report or other document is considered to have been tabled before the House of Assembly when it is submitted to the Speaker or Clerk under subsection (1).

HUMBER VALLEY BY ELECTION

On Friday, January 19, 2007 a Writ of Election was issued for a by election in the Electoral District of Humber Valley to be held on Monday, February 12, 2007. The by election was called to fill a vacancy created by the resignation of Progressive Conservative Ms. Kathy Goudie who resigned on Friday, January 19, 2007.

The List of Electors that was printed on January 19, 2007 was used as the Preliminary List and contained 7396 electors. Throughout the election period, updates to the list continued to be made until 4:00 p.m., February 9, 2007. A revised list containing 7138 electors was subsequently printed which identified electors who applied to vote by special (mail in) ballot, electors who voted at the advance poll and electors who applied to be added, as well as other changes such as elector moves and corrections to electors' names and/or addresses. This final revised list was distributed to political parties and candidates on Saturday, February 10, 2007 and was used by the Returning Officer for the electoral district and all election officials as the Official List of Electors on polling day.

Nomination Day was held on Friday, February 2, 2007 with a total of three candidates officially nominated at the close; namely Dwight Ball for the Liberal Party, Darryl Kelly for the Progressive Conservative Party, and Shelley Senior for the New Democratic Party

The advance poll was held on Friday, February 9, 2007 in three locations, Deer Lake, Woody Point and Hampden.

A total of 97 Special (Mail In) Ballot applications were received and approved with 88 ballot kits returned by the 4:00 p.m., Friday, February 9, 2007 deadline.

The preliminary count on election night resulted in 4419 votes cast. There were a total of 283 votes cast at three advance polls; 88 votes cast by special (mail in) ballot and 4048 votes cast at 30 regular polls with a 62% voter turnout. Mr. Ball received 2156 votes, Mr. Kelly received 2138 votes and Ms. Senior received 119 votes. There were a total of 6 rejected ballots and 6 cancelled ballots. A total of 574 electors were "sworn in" at the advance, special (mail in) ballot and regular polls.

The Official Addition of the votes was held on Thursday, February 15, 2007 at the Office of the Returning Officer. The results of the Official addition did not confirm the preliminary results on election night and resulted in a 9 vote difference in the total votes cast for Mr. Ball at 2156 and Mr. Kelly at 2147. Ms. Senior's final vote count changed as well to 123. There were a total of 6 rejected ballots.

In accordance with sections 156(3) and 165(1) of the Elections Act, The Chief Electoral Officer made application to the Supreme Court of Newfoundland for a Judicial Recount. The Judicial Recount was held on March 1 and 2, 2007 in the City of Corner Brook and presided by Judge Alan Seaborn. Upon conclusion of the Judicial Recount, Judge Seaborn certified 2153 votes for Mr. Dwight Ball, 2146 votes for Darryl Kelly and 122

votes for Ms. Shelly Senior. There were a total of 10 rejected ballots and 6 cancelled ballots. Mr. Ball was then declared elected after the Judicial Recount and sworn in as a Member of the House of Assembly on March 16, 2007. The results of this by election left representation in the House of Assembly with 34 Progressive Conservatives, 12 Liberals, 1 New Democrat, and 1 vacancy in the District of Labrador West.

The Chief Electoral Officer would like to extend thanks to the Returning Officer, Ms. Duane Tompkins, her election clerk, Ms. Ruth Rumbolt, the election workers from the district and the staff at the Chief Electoral Office for a job well done.
