This may include advice on proposed activities, and/or comment on the progress and success of the Strategy's ongoing efforts. The committee also serves to assist and support in the dissemination of relevant information from the Senior Project Team to stakeholder groups.

The Terms of Reference for the committee has established a meeting frequency of twice annually or at the call of the Chair. The secretariat for the committee operates out of the Sustainable Development and Strategic Science (SDSS) offices in St. John's, and functions as an administrative body, and a conduit for two-way exchange between committee members and the Senior Project Team responsible for the Caribou Strategy.

Committee members serve on a volunteer basis, with travel, accommodations and related costs covered under the Caribou Strategy budget within the Sustainable Development and Strategic Science Branch.

Vision

The vision of the Caribou Resource Committee is a healthy and sustainable population of woodland caribou on the island of Newfoundland that meets the social, cultural, ecological and economic needs of its residents at present, and in the future.

Mission

The mission of the Caribou Resource Committee reflects the intent of the Department, which is the reduction of adverse impacts of human activities on the environment and the improvement of the health of our ecosystems. By supporting the deliberations of the Caribou Strategy, the committee will enhance the Senior Project Team's ability to effectively and sustainably manage an integral species in our ecosystem, which in turn will promote a more robust environment.

Objective and Activities

The following objective identifies the priorities of the Caribou Resource Committee for fiscal years 2011-12, 2012-13 and 2013-14. The Committee's main purpose is to participate in the Caribou Strategy process by way of expressing the concerns or suggestions of various stakeholder groups. Further to this, the Committee will advise on ways in which to increase public knowledge with respect to the Caribou Strategy.

Objective 1: The Caribou Resource Committee will continue to provide meaningful input to the Senior Project Team on a wide array of factors, encompassing biological, social, economic, cultural, and operational considerations.

Measure: Provided input to the Senior Project Team.

Indicators:

- The Caribou Resource Committee will advise on ways to increase public awareness and efficiently disseminate information on the activities and progress of the Caribou Strategy to a wider group of stakeholders.
- Members' points of view, and hence stakeholder interests, are considered in the development of recommendations for caribou management on the island.

The Caribou Resource Committee did not meet during the 2013-2014 fiscal year.

Individual members of the Caribou Resource Committee contacted the secretariat informally with information requests on behalf of their represented group.

The Caribou Resource Committee supported the Caribou Strategy by providing meaningful input and comment to the Senior Project Team during the development and implementation of Caribou Strategy activities. These activities ended in March 2013, thus advice, feedback and formal information exchange was not required in the 2013-14 fiscal year.

During 2013-2014, the Caribou Strategy project team compiled and analyzed data, interpreted results and drafted reports. The Caribou Resource Committee has concluded its mandate; however it is scheduled to have one final meeting in early 2014-15.
