## RE: Tabling of Document in Relation to the Bill 5

As undertaken during debate with respect to the Bill to Amend the Access to Information and Protection of Privacy Act, 2015, I herewith table correspondence from Mr. Michael Harvey, the Information and Privacy Commissioner, in relation to the Bill.

In his letter, Mr. Harvey indicated he had no concerns with the exemption of the Inquiry from the Act while the Inquiry is doing its work. However, he requested confirmation that the records in the custody and control of the Inquiry would come into the custody and control of the Department of Justice and Public Safety once the Inquiry had concluded. Departmental officials have confirmed with the Commissioner of the GSAR Inquiry that the custody and control of the records of the GSAR Inquiry will be assumed by the Department of Justice and Public Safety once the GSAR Inquiry is concluded and this confirmation has been communicated to Mr. Harvey. Once the Inquiry records are in the custody and control of the Department, the records would then be subject to the provisions of the Act as is the case with any record in the custody and control of the Government.

I trust this to be satisfactory.

#### Tara.

We have reviewed the Bill forwarded yesterday as well as the letter sent from Jennifer this morning. We have no concerns with the exemption of the Inquiry from ATIPPA while it is doing its work. However, we recall that when we were consulted on the similar amendment regarding the Muskrat Falls Inquiry, we were advised that following the conclusion of the Inquiry that the records would be housed in the Department of Justice and subject to ATIPPA. I note from Jennifer's letter that "while this proposed amendment exempts the Inquiry and records in its possession, GNL records will continue to be accessible as per the normal request process under ATIPPA". Is it your intention that, with this Inquiry as well, the records will pass into the possession of JPS once it is finished its work?

If the intent of the exclusion of these records from ATIPPA is to avoid prejudicing the work of the Inquiry, presumably that concern would no longer be relevant after the Inquiry is finished its work. I note that such records housed in JPS would be subject to ATIPPA including all appropriate exceptions to access within.
