

Departmental Overview

The mandate of the Labrador Affairs Secretariat is to advance the social and economic development of Labrador by ensuring the unique perspectives of Labrador are considered in the formation of government policy and in the delivery of Provincial Government programs and services in Labrador. It is responsible for the development, implementation and administration of provincial policies and programs respecting Labrador issues. The Secretariat aims to ensure that provincial policies, programs and services consider Labrador-related issues by providing advice to Provincial Government departments and agencies and through its participation in provincial horizontal initiatives.

The Labrador Affairs Secretariat is responsible for the administration of Labrador-specific programming through the Labrador Transportation Grooming Subsidy and the Labrador Sports Travel Subsidy. The Secretariat also provides annual grants to Labrador's three Indigenous groups to support food initiatives and artistic endeavours through the Labrador Aboriginal Nutritional and Artistic Assistance Program and supports the Combined Councils of Labrador by providing an annual operating grant. Labrador-specific programming demonstrates Government's commitment to Labrador and supports engagement with Labrador stakeholders.

In addition to programming, the Labrador Affairs Secretariat often takes a prominent role on Labrador-focused committees such as the Arctic Policy Working Group. It liaises with other Northern ministries and assists in the management of intergovernmental relations on Labrador and Northern issues, such as the Northern Development Ministers Forum and the Arctic and Northern Policy Framework. The Secretariat is also consulted on Labrador-related initiatives by other provincial departments and provides support as required. Arctic and Northern Initiatives

The geographic location of Labrador and its proximity to the Arctic has provided Newfoundland and Labrador with the opportunity to engage in areas of economic and social development in the Arctic and Canada's North. The Labrador Affairs Secretariat leads Arctic and Northern policy initiatives for the Province. This falls within its mandate to advance the social and economic development of Labrador while providing advice on government policies, planning and programs that impact Labrador.

The Labrador Affairs Secretariat has long been involved with policy initiatives in Canada's North. The Secretariat has developed a positive relationship with its Northern partners in Canada and has positioned itself as a contact for Ministries across the North.

Since 2000, the Secretariat has played a lead role in the Northern Development Ministers Forum (NDMF) for the Province. The mandate of the NDMF is to advance the diverse and common interests of the people living in Canada's North, while raising awareness among decision-makers and the public about the accomplishments, contributions and potential of the North. In 2019-20 officials regularly participated in meetings with colleagues in other northern jurisdictions for the planning of the Forum, to work on priority projects, and other requirements as needed. The Labrador Affairs Secretariat chairs the Arctic Policy Working Group. The working group is comprised of various provincial departments/entities that have an active involvement or interest in the Arctic and Canada's North. The mandate of the group is

to facilitate the coordination and collaboration between Provincial Government departments and entities on the social and economic development activities of the Government of Newfoundland and Labrador related to the Arctic and Canada's North.

On September 10, 2019, the Government of Canada released the Arctic and Northern Policy Framework (ANPF). The Framework is expected to provide overarching direction to the federal government's priorities, activities and investments in the Arctic until 2030. The Labrador Affairs Secretariat represents Newfoundland and Labrador on the ANPF working group. Following the release of the Framework, the Secretariat has continued to work with the federal government on phase two of the Framework which includes a governance model and investment strategy. Phase two was delayed due to the COVID-19 pandemic but is expected to continue in the coming year.

Labrador Transportation Grooming Subsidy

In 2019-20, the Labrador Affairs Secretariat continued to provide funding to support the Labrador Transportation Grooming Subsidy (LTGS). The purpose of the LTGS is to maintain snowmobile trails to remote Labrador communities that do not have year-round road connection to service centres. The communities include Hopedale, Makkovik, Postville, Rigolet, Nain, Norman Bay, Black Tickle, and Mud Lake. In 2019-20, funding for the LTGS was increased to \$471,000 annually. In addition, the Secretariat provided funding for new equipment for Nain, Hopedale and Norman Bay for the purchase of snowmobile and drags that are used for grooming and marking the trails. Cartwright was provided funding for the purchase of a new groomer which supports access for the isolated community of Black Tickle.

Labrador Travel Sports Subsidy

The Government of Newfoundland and Labrador recognizes that the cost of air and ground transportation between Labrador and the island portion of the province continues to be challenging to Labrador athletes and teams. In 2019-20, the Labrador Affairs Secretariat assumed responsibility for the administration of the Labrador Sport Travel Subsidy (LSTS) Program. The LSTS provides support for sport travel to provincial

competitions, provincial training camps and Canada Games team selections, training and competitions with a total budget of \$730,000 annually. The program also provides support for coach and official development, and subsidizes the cost of hosting provincial minor championships in Labrador. Through the LSTS, funds are provided to School Sports NL (SSNL) for Labrador schools for travel throughout their calendar year. A \$300,000 contribution agreement between LSTS and SSNL allows this organization the opportunity to fund specifically agreed upon sporting events for school athletes. The travel restrictions put in place by Government in March 2020 to combat the spread of COVID-19 affected the distribution of program funds. SSNL was able to disburse approximately 90% of their yearly funds, while approximately 70% of the remaining program funding was distributed.

Partnerships

Transient Population Senior Officials Working Group

The Town of Happy Valley-Goose Bay has experienced an increase in both its homeless and transient populations in recent years. Homelessness is traditionally defined as lacking a permanent place of residence whereas people who are transient tend to be in communities short term and typically have permanent fixed addresses elsewhere. In response, in 2019, a Senior Officials Working Group on the Transient Population was formed with a multi-sectoral approach in finding pro-active solutions to the issue. The working group is co-chaired by the Town Manager of Happy Valley-Goose Bay and the Labrador Affairs Secretariat. Members of the committee include relevant Government departments and entities, the federal government, Indigenous groups and community organizations.

Cooperative Management Boards for the Akami-Uapishk^U-KakKasuak-Mealy Mountains National Park Reserve

The Labrador Affairs Secretariat represents the Province on the Cooperative Management Boards for the Akami-Uapishk^U-KakKasuak-Mealy Mountains National Park Reserve. The Secretariat has observer status on the management boards for the Innu Nation and the Nunatsiavut Government. Initial meetings were held in February for

the Innu Board in Ottawa, and in March for the Nunatsiavut Government Board in Happy Valley-Goose Bay. The cooperative boards will be developing management plans that include the sustainability of the land; heritage of the park and requirements for protection; and, guest services management.

Regional Advisory Board on Homelessness

The Labrador Affairs Secretariat represents the Province on the Regional Advisory Board. The Board is responsible for setting direction for addressing homelessness in the community or region and has representatives from the federal government and community organizations. The Board coordinates efforts to address homelessness in communities. The Board also reviews and approves funding applications for community-based projects that provide support to ensure that people who are homeless and those at risk of becoming homeless can stabilize their circumstances and move beyond emergency needs.

Labrador Engagement

In 2019-20, the Labrador Affairs Secretariat worked in collaboration with the Public Engagement Division of the Communications and Public Engagement Branch to support stakeholder engagement and consultation in Labrador. Engagement sessions included topics such as the roundtable on immigration, public post-secondary review, dementia care and quarry legislation.

Local River Watch Committee

In response to the 2017 flooding of the Lower Churchill River, the Local River Watch Committee (LRWC) was set up to monitor activity updates along the river. The committee is led by Environment, Climate Change and Municipalities and consists of Nalcor and local and Government representatives including the Labrador Affairs Secretariat. The committee holds regular meetings to solicit feedback during the ice formation and ice breakup seasons and support community readiness in the event of flooding.

Report on Performance

The goals and objectives identified below are based on the assigned 2017-20 reporting period.

Issue One: The Socio-Economic Development of Labrador

The mandate of the Labrador Affairs Secretariat is to ensure provincial policies, programs and planning must appropriately adapt to the unique issues and opportunities that exist in Labrador.

Major resource developments in Labrador contribute to the economic progress of Labrador, and the province as a whole. As these developments are pursued, the Labrador Affairs Secretariat collaborates with departments to ensure they reflect the social, cultural, geographic and economic needs of the region. The Labrador Affairs Secretariat works with entities that provide frontline delivery of important supports such as housing, food security, health and transportation to address issues of social and economic relevance.

Advocacy, open communication and support are required to ensure that matters of importance to Labrador are addressed, with the Labrador Affairs Secretariat taking leadership in these areas. Through Government's strategic planning process, the Secretariat will help ensure the Province is prepared for existing and future demands.

Goal Statement

By March 31, 2020, the Labrador Affairs Secretariat will have supported the socioeconomic development of Labrador through implementation, collaboration, communication and input from a Labrador perspective.

2019-20 Objective

By March 31, 2020, the Labrador Affairs Secretariat will continue to support the socioeconomic development of Labrador through implementation, collaboration, communication and providing information from a Labrador perspective.

Status
In 2019-20, a new grooming machine was purchased for
the Eagle River Development Association to groom the
trail to allow access into Cartwright for residents of Black
Tickle. A new snowmobile and drag configuration was
purchased for the Norman Bay Recreation Committee to
groom the trail between Norman Bay and Charlottetown.
For the North Coast, new snowmobile and drags were
purchased for the Nain Inuit Community Government,
and the Hopedale Inuit Community Government. The
Town of North West River received funding to make
safety improvements to the trail system that allows
access from the North Coast to Central Labrador.
As part of the requirements under the Labrador
Aboriginal Nutritional and Artistic Assistance Program,
the proponents are required to provide invoices and
summaries of how the funding was utilized.
The Labrador Affairs Secretariat received supporting
documentation from the proponents between April-June
2019. The funding was used to support food security
initiatives such as a breakfast program, community food
bank, and the transportation of moose meat. Funding

2017-20 Discussion

The priorities identified for the Labrador Affairs Secretariat for the 2017-20 reporting period was to support the socio-economic development of Labrador and to support Labrador relationships. Through its commitment to enhance Labrador specific programming, the Secretariat completed an evaluation of the Labrador Transportation Grooming Subsidy program in 2017. The program also underwent a number of improvements through commitments as determined through strategic direction. In 2018 the trail system was extended to allow access between Nain and Natuashish. New grooming equipment was purchased based on needs identified in the evaluation.

The Secretariat enhanced its programming by assuming the Labrador Sport Travel Subsidy program in 2019-20 and completed a review of the program which resulted in updated guidelines and the inclusion of Special Olympians for funding. The Secretariat

continued to support food security and artistic endeavours in Labrador through the Labrador Aboriginal Nutritional and Artistic Assistance Program by providing funding to Labrador's three Indigenous organizations.

The Secretariat continued to engage stakeholders through these programs. Through participation in various stakeholder engagement and government sessions, the Labrador Affairs Secretariat was able to gather local information which was used to support public policy and decision-making. The Secretariat worked in collaboration with the Public Engagement Division of the Communications and Public Engagement and Planning Branch to develop a stakeholder engagement plan in 2018-19.

The Labrador Affairs Secretariat supported consultations and engagement sessions in Labrador and provided resources to assist with engagement. The Secretariat also provided input on sessions and worked with Provincial Government departments/entities, the federal government, municipalities, and community organizations on engagement sessions.

Since 2017, the Secretariat has led the Arctic and Northern file for the Province as it falls within its mandate to advance the social and economic development of Labrador while providing advice on government policies, planning and programs that impact Labrador. The Secretariat has developed a positive relationship with its Northern partners in Canada and has positioned itself as a contact for Ministries across the North.

During the reporting period, the Labrador Affairs Secretariat provided support for the Premier in a number of Labrador-related conferences, events, and meetings by preparing briefing materials, speaking notes and coordinating logistics. This included the Labrador Winter Games, Expo Labrador, Northern Lights, Northern Exposure and Cain's Quest to name a few.

Opportunities and Challenges

The mining industry in Labrador has shown remarkable growth in 2019-20. The Labrador West region has a thriving iron ore mining industry and is home to one of the largest private sector employers in the province, the Iron Ore Company of Canada (IOC). The region is experiencing growth with Tacora Resources' new operation in Wabush and IOC's new mining pit Wabush 3. On the North Coast, Vale is proceeding with its underground expansion in Voisey's Bay which is expected to extend the life of the mine by at least 15 years. In addition to these projects, there is mineral exploration occurring throughout Labrador with potential for future development. Search Minerals is in the environmental assessment process to develop a rare earth minerals mine on the South Coast and has been working with the NunatuKavut Community Council. In addition to these projects, there is mineral exploration occurring throughout Labrador with potential for future development.

There is tremendous potential for future development in the agriculture, tourism and other renewable resource sectors in Labrador. A priority for Newfoundland and Labrador is be a strong, diversified province with a high standard of living. Labrador has an abundance of natural resources that will play a strong role in the future economic development.

Transportation remains a critical focus for development in Labrador. Widening and hard surfacing continues along the Trans Labrador Highway and Government continues to explore a fixed link between Labrador and the Island of Newfoundland. In 2019 coastal Labrador had two new ferries to support marine services in the region. The Qajaq W. had its initial run in January 2019 across the Strait of Belle Isle. The Kamutik W. began service on the North/South Coasts in July 2019. Both services are fully accessible with ice-strengthened bows and will reduce the previous carbon footprint in half.

Social issues, such as homelessness, affordable housing, mental health and addictions, remain a concern across Labrador. The Labrador Affairs Secretariat continues to work with stakeholders in the region and sits as an ex-officio executive member on Violence Prevention Labrador, and on the Regional Advisory Board on Homelessness.

Opportunities in the North and Arctic and how the province maximizes these developments will be high on the agenda for the Labrador Affairs Secretariat. The Secretariat will continue to participate and represent the province through the Northern Development Ministers Forum and lead initiatives such as the Arctic Policy Working Group.

The Labrador Affairs Secretariat will continue to offer Labrador-specific programming and to provide advice and input on government policy and programming that impacts Labrador. Ultimately, the Secretariat strives to advance the well-being of all Labrador communities and is optimistic about future opportunities for the region.
