#### **BY-ELECTION SUMMARY**

On Monday, September 7, 2020, Premier Dwight Ball, the Liberal Member for the electoral district of Humber-Gros Morne, resigned his seat resulting in a vacancy in the House of Assembly.

A proclamation was issued on Monday, September 7 pursuant to Order in Council Number 2020-180 and the Chief Electoral Officer issued a writ of election to the Humber – Gros Morne Returning Officer, Ms. Millicent Payne.

The by-election date was set for Tuesday, October 6. The following key dates and deadlines were in effect for the by-election:

Official Addition of the Votes

At the time of the by-election call, the distribution of seats in the provincial legislature was 19 Liberals, three New Democrats, 15 Progressive Conservatives, two independent/non-affiliated members and one vacancy. The distribution of votes during the by-election was as follows:

- 4060 votes cast at the Regular Polls
- 924 votes cast at five Advance Polls
- 345 Special Ballot votes were received at ENL by the specified deadline

Mr. Andrew Furey, the Liberal candidate, was declared elected as the Member of the House of Assembly for Humber-Gros Morne.

#### PLAN TO MAINTAIN VOTER AND ELECTION WORKER SAFETY

The Humber-Gros Morne by-election marked Newfoundland and Labrador's first pandemic electoral event.

Elections NL began its pandemic election planning in March 2020 which included consultations with the Office of the Chief Medical Officer and other electoral management bodies in Canada. The objective of the pandemic election plan was to protect both voters and workers at the polls, to ensure that electors had confidence in the safety measures put in place and to ensure all measures followed public health advice. The pandemic election plan included the following measures and recommendations:

- Election training sessions were conducted in groups of no more than 20 people, with social distancing in place.
- Election Official training included a newly developed module on COVID-19 protocols.
- Elections NL promoted and encouraged early voting through the use of Special Ballot voting via mail
  and in person at Elections NL office in St. John's and at the district offices located in Parsons Pond, Deer
  Lake and Trout River. Advance Poll voting was also promoted as an early-voting option.
- Advertising for the by-election (print, radio, and online) used the tagline, "Vote Early. Vote your way." This messaging was crafted to speak to the idea that voting is a personal choice when it comes to selecting a candidate to vote for, but also a personal choice as to how that vote can be conducted based on an elector's comfort level (by mail, in person at an office, in person at the Advance Polls or in person on Election Day).
- Masks were mandatory in all Elections NL facilities, district offices and voting locations. Voters and
  election workers were encouraged to bring their own masks. However, masks were made available for
  distribution at all voting locations.

- Voters were instructed to sanitize their hands upon entry to any Elections NL facility or voting location.
- Each voter was issued a new pencil to use at the polling stations. Voters were also permitted to bring their own pencil with them.
- Voting compartments were sanitized after each voter left the voting compartment.
- High contact areas, such as door handles and table tops, were sanitized frequently.
- Floor decals and other types of signage were put in place to facilitate social distancing in offices and voting locations.
- There was increased distancing between election workers while sitting at the voting tables and hand sanitizer was provided at each table, as well.

#### PROCEDURAL AND ADMINISTRATIVE CHANGES IN EFFECT FOR THE HUMBER-GROS MORNE BY-ELECTION

#### 1. New District Office Position - Election Assistant

Upon reviewing the May 16, 2019 General Election, it was determined that an additional staff member was required in the district Returning Offices. The main purpose of this position was to aid with administrative duties, including the completion and verification of payroll and travel claims for poll workers. Additionally, this role would provide support to the Returning Officer and Election Clerk in securing staff and polling station locations. For the Humber – Gros Morne by-election, the Election Assistant position provided invaluable assistance in terms of facilitating social distancing, assisting electors with Special Ballot services and providing hand sanitizer and masks (if required).

#### 2. New Polling Station Position - Poll Attendant

To assist with COVID-19 protocols and to ensure a safe election environment for workers and the public, 44 Poll Attendants were hired and placed at entrances to buildings and near voting compartments. Their main duties were to provide hand sanitizer to electors upon entrance along with providing masks to anyone who needed them. Poll Attendants were also responsible for sanitizing voting compartments after each elector and removing any materials left in the voting compartment.

# 3. Additional Special Ballot Officer at Special Ballot (Satellite) Offices

Due to an increase in voting and home visits requested at Satellite Special Ballot Offices during the May 16, 2019 General Election, an additional Special Ballot Officer was approved for each Satellite Office for any future electoral event. For the Humber-Gros Morne by-election, a second Special Ballot Officer was appointed for the Deer Lake Satellite Office which was very busy throughout the Special Ballot voting period.

# 4. Scrutineers Seated at the Polling Stations

In keeping with proper social distancing and spacing requirements at the polling stations, scrutineers were not permitted to sit at the same table as election officials. Each candidate was permitted to have one scrutineer present at each polling location to oversee voting activities, however they were socially distanced from the Deputy Returning Officers, Poll Clerks, and polling booths.

#### 5. C-13 Scrutineer Record of Electors Form

To maintain social distancing measures and to allow scrutineers minimum contact at the polls, Elections NL designed and introduced a new form to be used at the polling station on Regular Polling Day – C -13 (Scrutineer Record of Electors). Modeled after similar forms used by federal and provincial counterparts, the form was informally referred to as the 'Bingo Sheet'. As each elector voted, the Poll Clerk struck the corresponding number on the Bingo Sheet to their consecutive number on the list of electors.

The form was printed as a six part carbonless form with one copy for each candidate, one copy for Elections NL records and a spare. Scrutineers were permitted to collect their copies of the Bingo Sheet at designated times throughout Election Day. Each scrutineers was also permitted to take a photo of the C-13 form.

This new procedure alleviated the necessity of scrutineers remaining at polling stations for the duration of the 12-hour voting day, as had been past practice.

#### **BOUNDARIES AND POLLING STATIONS**

The number of poll boundaries for Humber-Gros Morne by-election were the same as those in the 2015 Provincial General Election. There was a total of 45 polling divisions in the district, comprised of 39 regular polling divisions, five Advance Polls and one Special Ballot poll.

A listing of the polling divisions and their boundary descriptions (**Appendix A**), along with a map of the electoral district showing the polling division boundaries (**Appendix B**), are included in this report.

#### **ELECTION OFFICIALS**

The Returning Officer, who manages the election at the district level, appoints an Election Clerk, an Election Assistant and two Special Ballot Officers. Together, they work in the district Returning Office to help administer the by-election. In the Humber–Gros Morne district, there was also a Special Ballot (Satellite Office) in Deer Lake with two Special Ballot Officers and a Special Ballot Designated (Remote) Office in Trout River with one Special Ballot Officer.

The Returning Officer is also responsible for hiring and training all election officials for their district. This includes everyone who will work in the polls: Deputy Returning Officers, Poll Clerks, Supervisors, Registration Clerks, Door Attendants, Parking Attendants, Poll Attendants, Messengers and Witnesses. The Returning Office also hires and trains the Special Ballot Officers who conduct the hospital and personal care home votes.

#### CANDIDATE REGISTRATION AND NOMINATION

At the time of the Humber-Gros Morne by-election, there were four registered parties in the province: the Liberal Party, the New Democratic Party, the NL Alliance, and the Progressive Conservative Party. Each of the four registered parties put forth a candidate by the 2:00 p.m. deadline on Tuesday, September 15, 2020.

#### METHODS OF VOTING

# **Special Ballot Voting**

Special Ballot applications were available to electors on the Elections NL website, by mail, at Elections NL headquarters in St. John's and at the Humber-Gros Morne district Returning Office in Parsons Pond.

Elections NL headquarters and the district Returning Office began accepting Special Ballot applications from the date of the writ issue (Monday, September 7) to the application deadline of 6:00 p.m. on Tuesday, September 29.

Beginning on Tuesday, September 15 after 3:00 p.m., electors were able to vote by Special Ballot by mail or in person at the district Returning Office, at the Satellite Office in Deer Lake and at Elections NL headquarters. Once a Special Ballot application was approved, a Special Ballot voting kit was issued and the applicant was considered to have voted.

Administrative deadlines must be in place and adhered to in order to provide sufficient time for the application to be completed and approved, and to allow adequate time for the ballots to be returned by mail or in person in time for counting. The deadline for receipt of a completed Special Ballot kit was Thursday, October 1 at 4:00 p.m. at the District Returning Office and Saturday, October 3 at 4:00 p.m. at Elections NL Headquarters.

A total of 352 Special Ballot applications were processed. Seven Special Ballots were not returned to Elections NL headquarters in time for the Special Ballot count procedure, resulting in a total of 345 Special Ballot votes being

counted. Comparatively, there were 321 electors who voted by Special Ballot in the district in the 2019 General Election.

# **Special Ballot Voting: Personal Care Homes**

Special Ballot voting was offered to Humber-Gros Morne residents in three personal care homes on Tuesday, September 22. Representatives from the Humber-Gros Morne Special Ballot District Office and a facility representative arranged the vote. A total of 55 votes were cast.

# **Special Ballot Voting: Hospitals**

Special Ballot voting was conducted at the four St. John's hospitals and at the Bonne Bay Health Centre on Wednesday, September 23, 2020.

Due to COVID-19 restrictions, a representative from the Volunteer Resources Centre conducted the vote at the four St. John's hospitals. Special Ballot Officers from the Humber-Gros Morne district office, in conjunction with a facility representative, arranged the vote at the Health Care Centre in Bonne Bay. There was a total of five ballots cast from all hospitals.

#### **Advance Poll**

Advance Poll voting was held in the Humber-Gros Morne district on Tuesday, September 29 from 8:00 a.m. to 8:00 p.m. Advance voting took place in three buildings. One building in Deer Lake housed three polling stations while a building in each of Rocky Harbour and Hampden housed one poll each (for a total of five Advance Polls):

- Pioneer 50 Plus Club (Senior's Centre), 10 Rectory Lane, Rocky Harbour
- Roman Catholic Parish Hall, 21 Upper Nicholsville Road, Deer Lake
- Hampden Fire Hall, 74 Country Road, Hampden

The Returning Officer hired and trained 24 election officials for the Advance Polls.

The preliminary list of electors, certified on September 9, 2020 and containing 9,584 electors, was used by candidates, political parties and at district offices for Special Ballot voting.

A second, updated list of electors was certified on September 23 and contained 9,585 electors. This alphabetical list of electors was comprised of revisions and updates from both Special Ballot voting and used at the Advance Poll on Tuesday, September 29.

A final, revised list of electors was certified on September 30 and contained 9,650 electors. This list contained all revisions and updates of electors who voted at the Advance Poll and by Special Ballot and was used at all polling stations on polling day.

The Advance Poll results were as follows:

- 924 votes cast on Tuesday, September 29, 2020
- 3 rejected ballots (which resulted in a total of 921 valid ballots)

Comparatively, during the 2019 Provincial General Election, there were 617 votes cast during one day of Advance Polling in the district of Humber-Gros Morne, with zero rejected ballots for a total of 617 valid votes cast.

# **By-Election Day**

Regular poll voting took place on Tuesday, October 6, 2020 from 8:00 a.m. to 8:00 p.m. There was a total of 39 regular polls held in 15 single poll locations and seven multiple poll locations.

There were 5318 valid ballots cast in the by-election. This compares with 6072 valid votes cast in the 2019 Provincial General Election.

eligible electors on the final list of electors for that particular electoral event, as well as any swear-ins that took place at the polls. Note that voter turnout is rounded to the nearest tenth of a percent.

# **ELECTOR PARTICIPATION Elector Registration**

The preliminary list of electors for Humber-Gros Morne, certified by the Chief Electoral Officer on September 9, contained a total of 9,584 registered electors.

The list of electors was revised prior to the by-election call. Revision activities included direct communication with electors facilitated through our website, e-mail or the Elections NL contact centre, swear-ins during one day of Advance Poll voting, as well as Special Ballot voting at personal care homes, hospitals, the district Returning Office and Elections NL head-quarters.

Voter Information Cards (VICs) were mailed to each elector on the preliminary list of electors prior to the beginning of the revision period. The distribution of these cards prompted electors to contact Elections NL to verify, update, remove or add their information on the voters list. There were 9,650 electors on the final revised list of electors.

The table below illustrates voter turnout in by-elections over the last 10 years. 'Eligible Voters' below includes the total number of

#### OFFICIAL ADDITION OF THE VOTES

In accordance with s. 153 of the **Elections Act, 1991**, the Official Addition of the Votes must take place three days after polling day. In the case of the Humber-Gros Morne by-election, the Official Addition took place on Friday, October 9 at 9:00 a.m. at the Returning Office in the presence of two required witnesses.

During the official addition process, the Returning Officer removes the Official Statement of the Poll sheets from each district ballot box and reviews them to ensure the accuracy of the calculation of vote totals.

The conclusion of the Official Addition of the Votes confirmed the election of Liberal Candidate Andrew Furey.

#### **RETURN OF THE WRIT**

Section 163(1) of the **Elections Act, 1991** requires a waiting period of 12 clear days between the conclusion of the Official Addition and the return of the writ of election. This provides sufficient time for a candidate, voter, district officer or scrutineer to request a judicial recount. A recount was not requested in the Humber-Gros Morne by-election. As a result, the writ of election was returned to Elections NL on Thursday, October 22 and the Liberal Candidate, Mr. Andrew Furey, was sworn into office the same day.

# **OBSERVATIONS OF THE CHIEF ELECTORAL OFFICER**

The Humber-Gros Morne by-election was the first opportunity for Elections NL to test procedures developed as part of the plan for conducting safe voting during a pandemic. While procedures had been put in place for directing electors and monitoring lineups, there were still unknowns regarding the usage and required amounts of items such as masks, hand sanitizer, etc.

Overall, the procedures that were put in place as a result of the plan were determined to be effective and provided electors a safe environment to conduct their vote. Below are further specifics on observations made at the polling locations.

#### Masks

Prior to the Humber-Gros Morne by-election a provincial mask order was in place for individuals to wear masks in all public buildings. Elections NL had planned to supply masks for every elector if required. Masks were deployed to each polling location for distribution to electors. Masks and face shields were deployed to the Returning Office for use by all staff during polling activities.

Elections NL monitored the amount of masks distributed to electors during the Advance Polling day and determined that majority of electors were in compliance of the provincial mask order and brought their own masks to wear while in the polling station. At the Advance Polling location in Deer Lake only one box of 90 masks was partially used with a throughput of over 900 electors at that location.

Polling staff wore a combination of masks or face shields on polling days. Staff reported that interchanging between masks and face shields throughout the day was preferred. Polling station supervisors primarily used face shields to aid in communicating with electors when they arrived in the polling locations. As a result of these findings face shields were included as part of the distribution of PPE to all election workers.

Training procedures on how to wear a mask will be included with all worker training materials as there were isolated cases of election workers wearing masks improperly.

#### Sanitizer

Sanitizer was deployed to each polling station for use by electors and election workers. Elections NL used bottles of 236ml liquid hand sanitizer with a pump and monitored usage of hand sanitizer through polling day. Each poll reported using one full bottle of hand sanitizer, but no poll required more than two bottles.

A liquid sanitizer was also used to clean each polling station after use by an elector. Election workers reported that one bottle of 950ml Triton sanitizer used in conjunction with a spray bottle was sufficient for each poll.

#### **Pencils**

Pencils were deployed to each polling location in quantities such that each elector could use a new pencil. Observations from polling days determined that the Poll Attendant responsible for cleaning each booth should be responsible for replacing the pencils at the polling booths to avoid having electors reaching into the box of pencils to retrieve a new one.

In addition, Elections NL determined that any used pencils should be collected and placed in a separate bag at each poll in the event that insufficient pencils are on hand at a polling location. These pencils could be sanitized and re-used if necessary.

#### Signage

Elections NL deployed directional signage to assist electors in moving safely through the polling location. Larger rondels were used to identify a space where an elector should stand while waiting to vote. Smaller rondels with arrows were used to direct the flow of electors within the polling locations. As the rondels were temporary they had to be low tack to ensure they could be removed at the end of the day.

The signage was designed to be similar to signage used in other public places such as grocery stores where electors would be familiar with directional arrows and queue spaces. In addition Elections NL deployed signage reminding electors to wear masks and how to properly sanitize their hands.

Feedback from election workers and electors was positive with respect to the signage used in polling locations. The signage felt seamless with respect to similar signage used in other public buildings.

# **Additional Staff at Polling Locations**

As part of the plan for conducting an election during a pandemic, Elections NL determined that additional staff would be needed to monitor and control lineups, as well as clean and sanitize each polling booth and location.

Additional Door Attendants were hired to monitor lineups, and ensure that electors safely moved throughout each polling location, or while queued to enter the building. Elections NL observed that each building would

have to be assessed by a Returning Officer or Supervisor to determine how many Door Attendants would be required. Areas such as hallways, entranceways, or vestibules would need Door Attendants to monitor and move electors through these parts of each polling location as necessary to avoid congestion.

For the Humber-Gros Morne by-election Elections NL deployed a Poll Attendant to each poll with the primary responsibility of cleaning and sanitizing each poll booth after an elector had finished voting. After observing activities at the polls, Elections NL determined that each poll should continue to have one Poll Attendant assigned to each polling booth, and that Poll Attendants should not be responsible for more than one poll booth. This reduced the risk of polling stations not being cleaned prior to an elector using the booth and having a new pencil in place.


