## VERBATIM REPORT (Hansard)

Speaker: Honourable James Russell

The House met at 3:00 p.m.

MR. SPEAKER (Russell): Order, please!

Sergeant-at-Arms:

Mr. Speaker, His Honour the Lieutenant-Governor has arrived.

#### MR. SPEAKER:

Admit His Honour the Lieutenant-Governor.

Ladies and Gentlemen, it is the wish of His Honour the Lieutenant-Governor that all present be seated.

MR. SPEAKER AND MEMBERS OF THE HONOURABLE HOUSE OF ASSEMBLY:

Since the last sitting of this Honourable House, the Province and this Assembly were saddened by the death of the Honourable Member for The Honourable Humber Valley. Wallace House served in Assembly and the Ministry of this with dedication and Province Province has The distinction. distinguished lost а Newfoundlander who dedicated his life to public service. On behalf of all, I wish to mark his passing and to extend formal sympathies from this historic Assembly on behalf of all honourable members and the entire Province to the family of the late Honourable Member for Humber Valley.

I ask you to rise for a moment of silence to the late Honourable Wallace House.

#### Moment of Silence

The Third Session of the 39th General Assembly of this Honourable House of Assembly is about to be prorogued. Before relieving you from your duties, I wish to convey to you appreciation for the careful and sympathetic attention given to the important matters brought before you to my Ministers.

Forty-six pieces of legislation were enacted during this Session of the Honourable House of Assembly. Major legislative initiatives were taken in the administration of justice, labour, public works, development and education.

In the area of the administration significant several of justice, measures legislative enacted. For the first time since 1889, a new Judicature Act was Act, This passed. proclamation, will revise the law relating to the superior courts of the Province. The Act will create a separate Supreme Court and a separate Court of Appeal. The Act will also provide for the making of new Rules of both Superior Courts and for the merger of what is now the Trial Division of the Supreme Court with the District Court. It is my Government's hope that the services of the Supreme upon merger, will, Court brought closer to people in the rural areas of our Province. existing District the addition. Court Act was amended to provide for the appointment of a second District Court Judge in the City of Corner Brook.

As an indication of my Government's desire to implement the reform of our laws to conform with the Canadian Charter of Rights and Freedoms and extend full rights to all members of society, The Newfoundland Human Rights Code was amended to include

the words "mental disability" in the existing heads of discrimination that are prohibited by the Code. The reform of our law will be completed during the next Session of this Honourable House.

The Companies Act was amended to provide for the issuance of certificates of continuance and discontinuance of companies under our law.

### MR. SPEAKER AND MEMBERS OF THE HONOURABLE HOUSE OF ASSEMBLY:

In order to ensure that employers, prospective employers and most importantly, employees in this Province understand their rights, Labour Standards Act was amended make а clear distinction with respect temporary lay-offs and termination of employment.

After many months of negotiations, Government was overjoyed to conclude an agreement with Kruger Incorporated whereby that company took over the operation of the Corner Brook Newsprint Mill. Act To Ratify, Confirm and Adopt Certain Agreements entered between the Government of Province and Kruger Incorporated respecting the future operation and modernization of the Corner Brook Newsprint Mill was enacted during this Session. Also, during this Session, An Act to collective bargaining between the Government and Interns and Residents was enacted.

As an indication of mу Government's commitment to the workers of this Province, mν Government introduced amendments Occupational Health Safety Act to provide for the making of regulations respecting

the health and safety of workers in the mines of this Province. This authority was previously vested in The Regulation of Mines Act which was considered ineffective instrument to occupational with health and safety matters of miners.

The Elevators Act was amended to bring tower cranes and overhead travelling cranes within the ambit of the Act from which they had previously been excluded.

As a further indication of Government's commitment to future of our young people and the fishery resources of this Province, my Government introduced Act Respecting Establishment and Operation of the Newfoundland and Labrador Institute of Fisheries and Marine The new facility will Technology. be completed this Fall and the old Fisheries College on Parade Street in St. John's will be abandoned. During this Session, The Schools Act was amended to increase the proportion of elected members to school boards from one-third to two-thirds. This amendment will provide for elections to school boards to be held on the same day general elections ofmunicipalities.

## MR. SPEAKER AND MEMBERS OF THE HONOURABLE HOUSE OF ASSEMBLY:

During this past year, my Government reorganized a portion the service, public particular career development. advanced studies and matters relating to consumer affairs and communications. To this end, the following new Department Acts were passed by this Legislature: Department of Career Development and Advanced Studies Act, Department of Labour Act. The

Department of Consumer Affairs and Communications Act and The Department of Education Act.

On April 2, 1984, the Government of Canada proclaimed into force Offenders Act. new Young Therefore, it was necessary for this Province to revise the law respecting juvenile delinquents. The Young Persons Offences Act was Session during this passed complementary legislation to the The Federal Act. It replaces Welfare of Children Act which has served well the young people of this Province since 1944.

In the area of consumer affairs, a new Act respecting collection agencies and collectors was passed. Upon proclamation, this Act will repeal and replace The Collection Agencies Act of 1973.

My Government has been concerned for some time that our past be preserved for future generations. In the area of agriculture, my Government introduced an amendment to The Livestock Act so that an owner of livestock would be liable for damage to property caused by livestock that is roaming at large.

In 1974, the first Public Tender Act was passed by this Honourable House.
