The Opposition House Leader (Mr. Parsons) rose to advise the House that leave had been given to announce this Wednesday's Private Member's Resolution in view of the fact the House had not met on Monday, March 27th.

The Member for Grand Bank (Ms. Foote) gave notice that she would on tomorrow move the following Resolution:

"WHEREAS FPI was established by this Legislature to strengthen the fishing industry in this province and to ensure maximum employment stability;

AND WHEREAS the provincial Minister of Fisheries and Aquaculture admits that he is having trouble obtaining information on all FPI operations;

AND WHEREAS the provincial Minister has said that FPI broke the laws of this province in shipping out fish with no authorization;

AND WHEREAS the provincial Minister says charges will be laid against FPI;

AND WHEREAS there are widespread allegations and suspicions involving the overall operations of FPI;

AND WHEREAS the livelihood of thousands of people in this province are being thrown into turmoil as a result of the actions being taken by FPI;

THEREFORE BE IT RESOLVED that this House of Assembly calls on the Government to establish an independent public inquiry into the operations of FPI."

On motion the report of the Committee was received and adopted.

Pursuant to order and on motion the following Resolution was read a first and second time and adopted:

"That it is expedient to introduce a measure to provide for the granting to Her Majesty for defraying certain expenses of the public service for the financial year ending March 31, 2007, the sum of \$1,509,510,800."

Pursuant to order and on motion a Bill entitled, "An Act For Granting To Her Majesty Certain Sums Of Money For Defraying Certain Expenses Of The Public Service For The Financial Year Ending March 31, 2007 And For Other Purposes Relating To The Public Service" (Bill No. 2) was read a first, second and third time and passed.

On motion it was ordered that Bill No. 2 be printed being entitled as above and that it be submitted to His Honour the Lieutenant Governor for His Assent.

The Sergeant-at-Arms announced the arrival of His Honour the Honourable Edward Roberts, Q.C. the Lieutenant Governor of Newfoundland and Labrador.

The Speaker left the Chair.

His Honour the Lieutenant Governor took the Chair.

The Speaker addressed His Honour the Lieutenant Governor as follows:

"It is my agreeable duty on behalf of Her Majesty's dutiful and loyal subjects, Her Faithful Commons in Newfoundland and Labrador, to present to Your Honour a Bill for the appropriation of Interim Supply granted in the present Session."

Whereupon the Clerk read the following Bill:

A Bill,

"An Act For Granting To Her Majesty Certain Sums Of Money For Defraying Certain Expenses Of Money For Defraying Certain Expenses Of The Public Service For The Financial Year Ending March 31, 2007 And For Other Purposes Relating To The Public Service" (Bill No. 2).

The Honourable the Minister of Finance and President of Treasury Board (Mr. Sullivan) informed the House that he had received a Message from His Honour the Lieutenant Governor.

The Message was read to the House by the Speaker as follows:

As Lieutenant Governor of the Province of Newfoundland and Labrador, I transmit Estimates of sums required for the Public Service of the Province for the year ending March 31, 2006, by way of Supplementary Supply, and in accordance with the provisions of sections 54 and 90 of the *Constitution Act, 1867,* I recommend these Estimates to the House of Assembly.

The Committee of Supply considered and passed a certain Resolution and a Bill entitled, "An Act For Granting To Her Majesty Certain Sums Of Money For Defraying Certain Additional Expenses Of The Public Service For The Financial Year Ending March 31, 2006 And For Other Purposes Relating To The Public Service No. 2" (Bill No. 4).

On motion the Committee rose. The Speaker resumed the Chair.

The Chairperson of the Committee (Ms. Osborne) reported that the Committee of the Whole on Supply had considered the matters to it referred and had passed a certain Resolution and a Bill consequent thereto and recommended that Bill No. 4 be introduced to give effect to the Resolution.

On motion the report of the Committee was received and adopted.

Pursuant to order and on motion the following Resolution was read a first and second time and adopted:

"That it is expedient to introduce a measure to provide for the granting to Her Majesty for defraying certain additional expenses of the public service for the financial year ending March 31, 2006, the sum of \$2,897,700."

Pursuant to order and on motion a Bill entitled, "An Act For Granting To Her Majesty Certain Sums Of Money For Defraying Certain Additional Expenses Of The Public Service For The Financial Year Ending March 31, 2006 And For Other Purposes Relating To The Public Service No. 2" (Bill No. 4) was read a first, second and third time and passed.

On motion it was ordered that Bill No. 4 be printed being entitled as above and that it be submitted to His Honour the Lieutenant Governor for His Assent.

It was moved and seconded that when the House rose it would adjourn until tomorrow, Wednesday, March 29th at 2:00 o'clock in the afternoon.

On motion the House then adjourned accordingly.
