The Member for Placentia & St. Mary's (Mr. Collins) made a Statement to congratulate teachers, students and parents of Laval High School and St. Anne's Academy of Placentia for hosting the 17th Annual Provincial Student Leadership Conference from October 19th to 21st, 2006.

The Member for Grand Falls-Buchans (Ms. Thistle) made a Statement to congratulate Mr. Doug Butt of Grand Falls-Windsor who recently received the Peace Officer Exemplary Service Medal.

The Honourable the Minister of Health and Community Services (Mr. Osborne) moved the following amendment to Bill No. 23:

"1. That Clause 5 of Bill No. 23 be renumbered as subclause 5(1) and the following subclause be added immediately after it:

- (2) The authority shall have responsibility to enhance public awareness of the ethical dimension of health research involving human subjects.
- 2. That subclause 9(3) of the Bill be deleted and the following substituted:
 - (3) The authority shall, within 2 business days of its receipt, refer an application made to it under subsection (2) in the research ethics board or a research ethics board body approved by the authority under section 8."

The Chair declared the amendment in order.

After some debate, the Chair put the question on the amendment and declared the amendment carried.

The Committee passed the Bill entitled "An Act To Establish A Health Research Ethics Authority For The Province" (Bill No. 23) with amendments.

The Committee considered and passed the Bill entitled "An Act To Amend The Vital Statistics Act". (Bill No. 43)

On motion it was ordered that the above noted Bills be printed being entitled as above and that they be submitted to His Honour the Lieutenant Governor for his Assent.

Pursuant to order and on motion debate commenced and concluded on Second Reading of a Bill entitled "An Act To Amend The City Of Corner Brook Act And The City Of Mount Pearl Act" (Bill No. 41) and on motion it was ordered that Bill No. 41 be read a second time presently.

Pursuant to order and on motion the Bill entitled "An Act To Amend The City Of Corner Brook Act And The City Of Mount Pearl Act" (Bill No. 41) was read a second time and on motion it was ordered that Bill No. 41 be referred to a Committee of the Whole House presently.

Pursuant to order and on motion debate commenced and concluded on Second Reading of a Bill entitled "An Act To Amend The Taxation Of Utilities And Cable Television Companies Act" (Bill No. 42) and on motion it was ordered that Bill No. 42 be read a second time presently.

Pursuant to order and on motion the Bill entitled "An Act To Amend The Taxation Of Utilities And Cable Television Companies Act" (Bill No. 42) was read a second time and on motion it was ordered that Bill No. 42 be referred to a Committee of the Whole House presently.

On motion of the Honourable the Government House Leader (Mr. Sullivan) the House resolved itself into a Committee of the Whole House.

The Speaker left the Chair. Mr. Fitzgerald took the Chair of Committee of the Whole House.

- A Bill, "An Act To Amend The Taxation Of Utilities And Cable Television Companies Act" (Bill No. 42).

On motion it was ordered that the said Bills be printed being entitled as above and that they be submitted to His Honour the Lieutenant Governor for his Assent.

The Honourable the Minister of Finance and President of Treasury Board (Mr. Sullivan) informed the House that he had received a Message from His Honour the Lieutenant Governor.

The Chairperson of the Committee (Ms. Osborne) reported that the Committee of the Whole on Supply had considered the matters to it referred, had made some progress and asked leave to sit again.

On motion the report of the Committee of Supply was received and adopted and on motion it was ordered that the Committee have leave to sit again on tomorrow.

It was moved and seconded that when the House rose it would adjourn until tomorrow, Monday, November 27th at 1:30 o'clock in the afternoon.

On motion the House then adjourned accordingly.
