"May 14 2007

As Lieutenant Governor of the Province of Newfoundland and Labrador, I transmit Estimates of sums required for the Public Service of the Province for the year ending 31 March 2008, by way of further Supply, and in accordance with the provisions of sections 54 and 90 of the *Constitution Act, 1867,* I recommend these Estimates to the House of Assembly.

Sgd. Edward Roberts Lieutenant Governor." On motion of the Honourable the Government House Leader (Mr. Rideout), the House resolved itself into a Committee of the Whole House on Supply to consider the Message together with a Certain Resolution and Bill No. 2 for the Granting of Supply to Her Majesty.

The Speaker left the Chair. Mr. Fitzgerald took the Chair of Committee of the Whole on Supply.

The Committee of the Whole considered and passed a Certain Resolution and a Bill entitled "An Act For Granting To Her Majesty Certain Sums Of Money For Defraying Certain Expenses of the Public Service For The Financial Year Ending March 31, 2008 And For Other Purposes Relating To The Public Service" (Bill No. 2).

The Speaker resumed the Chair.

The Chairperson of the Committee (Mr. Fitzgerald) reported that the Committee of the Whole on Supply had considered the matters to them referred and had passed a certain Resolution and a Bill consequent thereto and recommended that Bill No. 2 be introduced to give effect to the Resolution.

On motion the House then adjourned accordingly at 12:18 o'clock in the evening.
