The Member for Grand Falls – Windsor – Green Bay (Mr. Hunter) made a Statement to congratulate Pat Williams who is the Town of Triton 2008 Citizen of the Year.

The Member for Kilbride (Mr. Dinn) made a Statement to recognize the longevity and success of the Goulds Recreational Men's Slow Pitch Softball League.

The Honourable the Minister of Health and Community Services (Mr. Wiseman) made a Statement to inform the House about the Department's addictions awareness campaign: Get Up On It.

The Honourable the Minister of Tourism, Culture and Recreation (Mr. Jackman) made a Statement to recognize Mr. Stan Cook Jr. who was recently elected Chair of the Tourism Industry Association of Canada.

The Honourable the Government House Leader (Ms. Burke) gave notice that she would on tomorrow move pursuant to Standing Order 11 that the House not adjourn at 5:30 o'clock in the afternoon and that the House not adjourn at 10 o'clock in the evening on Tuesday, December 9<sup>th</sup>, 2008.

Pursuant to order and on motion the Bill entitled "An Act To Amend The Provincial Court Act, 1991 No. 2" (Bill No. 50) was read a second time and on motion it was ordered that Bill No. 50 be referred to a Committee of the Whole House now.

The Speaker left the Chair. Mr. Osborne took the Chair of Committee of the Whole House.

The Committee considered and passed a Bill entitled "An Act To Amend The Provincial Court Act, 1991 No. 2" (Bill No. 50) without amendment.

On motion the Committee rose.

The Speaker resumed the Chair.

The Chairperson of the Committee of the Whole House (Mr. Osborne) reported that the Committee of the Whole House had considered the matters to them referred, and had passed the Bill entitled "An Act To Amend The Provincial Court Act, 1991 No. 2" (Bill No. 50) without amendment.

On motion the report of the Committee of the Whole House was received and adopted and on motion it was ordered that Bill No. 50 be read a third time on tomorrow.

The Honourable the Minister of Finance and President of Treasury Board (Mr. Kennedy) informed the House that he had received a Message from His Honour the Lieutenant Governor.

The Message was read to the House by the Speaker as follows:

As Lieutenant Governor of the Province of Newfoundland and Labrador, I transmit Estimates of sums required for the Public Service of the Province for the year ending 31 March 2009, by way of Supplementary Supply, and in accordance with the provisions of sections 54 and 90 of the *Constitution Act, 1867*, I recommend these Estimates to the House of Assembly.

Pursuant to notice and on motion of the Honourable the Government House Leader (Ms. Burke) the House resolved itself into a Committee of the Whole on Supply to consider a certain Resolution and Bill No. 67 for the granting of Supplementary Supply To Her Majesty.

The Speaker left the Chair. Mr. Osborne took the Chair of Committee of the Whole on Supply.

The Committee of the Whole on Supply considered and passed a certain Resolution and a Bill entitled "An Act For Granting To Her Majesty Certain Sums Of Money For Defraying Certain Additional Expenses Of The Public Service For The Financial Year Ending March 31, 2009 And For Other Purposes Relating To The Public Service" (Bill No. 67).

On motion the Committee rose.

The Speaker resumed the Chair.

The Chairperson of the Committee (Mr. Osborne) reported that the Committee of the Whole on Supply had considered the matters to them referred and had passed a certain Resolution and a Bill consequent thereto and recommended that Bill No. 67 be introduced to give effect to the Resolution.

Pursuant to order and on motion the following Resolution was read a first and second time:

"That it is expedient to introduce a measure to provide for the granting to Her Majesty for defraying certain additional expenses of the public service for the financial year ending March 31, 2009, the sum of \$1,544,600". (Resolution of Bill No. 67)

Pursuant to order and on motion a Bill entitled "An Act For Granting To Her Majesty Certain Sums Of Money For Defraying Certain Additional Expenses Of The Public Service For The Financial Year Ending March 31, 2009 And For Other Purposes Relating To The Public Service" (Bill No. 67) was read a first, second and third time and passed.

On motion it was ordered that Bill No. 67 be printed being entitled as above and that it be submitted to His Honour the Lieutenant Governor for his Assent.

It was moved and seconded that when the House rose it would adjourn until tomorrow, Tuesday, December 9<sup>th</sup> at 1:30 o'clock in the afternoon.

On motion the House then adjourned accordingly.
