The House met at 2:00 o'clock in the afternoon pursuant to adjournment.

The Member for Bonavista North (Mr. Harding) made a Statement to congratulate the 2910 Lions Royal Canadian Army Cadet Corp on an exceptional year of service.

The Member for Placentia – St. Mary's (Mr. Collins) made a Statement to pay tribute to Laval High School in Placentia.

The Member for Bellevue (Mr. Peach) made a Statement to recognize the North Atlantic Refining Company which has reached the pinnacle of 1.9 million person hours, an all time high record with respect to No Lost Time Injuries.

The Honourable the Minister of Intergovernmental Affairs (Mr. Hedderson) made a Statement to recognize Eileen Bartlett who is the recipient of one of five Today's Parent, For Kids' Sake Awards.

The Honourable the Government House Leader (Ms. Burke) moved, pursuant to Standing Order 11, that the House not adjourn at 5:30 o'clock in the afternoon and that the House not adjourn at 10 o'clock in the evening.
