The Member for Exploits (Mr. Forsey) made a Statement to congratulate Paul Brothers of Bishop's Falls who was one of five finalists in The Score Television Network/Gillette "Canada's Next Sportscaster Challenge" contest.

The Honourable the Minister of Fisheries & Aquaculture (Mr. Jackman) made a Statement respecting the Centre for Aquaculture Health and Development.

The Honourable the Minister of Labrador Affairs (Mr. Hickey) made a Statement respecting the status of the Labrador Transportation Grooming Subsidy.

By leave the Honourable the Minister of Finance and President of Treasury Board (Mr. Marshall), in accordance with section 26(4) of the **Financial Administration Act**, tabled copies of the Order in Council relating to the following funding precommitments for the year 2009-2010:

- 1. Order in Council 2009-177 which authorized the Department of Business to pre-commit up to \$500,000 against its 2010-11 budgetary allocation in order to facilitate approval of projects under the Aerospace and Development Fund that span two fiscal years;
- 2. Order in Council 2009-183 which authorized the Department of Natural Resources to pre-commit funds to a maximum of \$70,000 against its appropriations in each of 2010-11 and 2011-12 to facilitate the award of a contract for the chemical analysis of Voisey's Bay nickel concentrates;
- 3. Order in Council 2009-185 which authorized the Department of Innovation, Trade & Rural Development, under its Ocean Technology Sector Strategy, to pre-commit up to \$2,990,000 against its 2010-11 budgetary appropriations and \$2,590,000 against its 2011-12 appropriations in order to facilitate project approvals under its Ocean Technology Development Fund:

Pursuant to notice and on motion debate commenced and concluded on the following Resolution standing in the name of the Member for Bonavista North (Mr. Harding):

"WHEREAS rural and regional economic development has consistently been among our Government's highest priorities since 2003;

AND WHEREAS our Government since 2003 has consistently demonstrated its commitment to rural Newfoundland and Labrador by implementing a wide range of strategic policies promoting infrastructure, natural resource development, value-added production, diversification, education, innovation, investment, entrepreneurial initiative, business success, family growth, youth retention and attraction, and a reliable social support network;

AND WHEREAS in addition to ensuring our rural communities benefit from these initiatives, the Department of Innovation, Trade and Rural Development has established funds dedicated exclusively to rural development totaling \$25 million a year, and 80 percent of the Department's total funding in all of its programs benefits rural Newfoundland and Labrador communities;

THEREFORE BE IT RESOLVED that the Newfoundland and Labrador House of Assembly affirms its support for the determination of the Government of Newfoundland and Labrador to continue promoting the growth, prosperity and sustainability of our rural and regional economies."

During the debate on the Resolution the Member for The Straits – White Bay North (Mr. Dean) moved, seconded by the Member for Cartwright – L'Anse au Clair (Ms. Jones), the following amendment to the Resolution:

"That the Resolution be amended by deleting the last paragraph and substituting the following:

THEREFORE BE IT RESOLVED that the Newfoundland and Labrador House of Assembly affirms its support for the Government of Newfoundland and Labrador to promote and invest in the growth, prosperity, and sustainability of our rural and regional communities:

THEREFORE BE IT FURTHER RESOLVED that this House of Assembly call upon Government to place more focus on the fishery, agriculture, forestry and tourism industries, the lifeblood of many rural communities throughout Newfoundland and Labrador."

The Speaker suspended the proceedings at 3:32 o'clock in the afternoon to consider the amendment.

The Speaker resumed the Chair at 3:46 o'clock in the afternoon and ruled the amendment in order.

Debate continued and concluded on the amendment to the Resolution and on the Resolution itself.

The Speaker put the question on the amendment and declared the amendment lost.
