The Member for Bellevue (Mr. Peach) made a Statement to recognize the 50 Plus Club from Swift Current/Black River for their contribution to their community.

The Honourable the Minister of Education (Mr. King) made a Statement to congratulate Kaitlin Strong, a student at Hermitage Collegiate in Lethbridge, who has been named the winner of the Lester B. Pearson Scholarship.
