- **AND WHEREAS** these acute care facilities are not providing the appropriate social and recreational opportunities to our aging population;
- **AND WHEREAS** the improper care for our seniors creates severe stress on families and friends;
- **AND WHEREAS** Government policy has failed to provide the proper long-term care and community support services to the people of this Province;
- **BE IT RESOLVED** that this House calls on Government to consider committing sufficient resources in this upcoming budget to address the long-term care needs, facilities, equipment and appropriate staffing for the aged in our Province".
