The House met at 1:30 o'clock in the afternoon pursuant to adjournment.

The Member for Bay of Islands (Mr. Joyce) presented a Petition from certain residents of the Province calling upon the House of Assembly to urge Government to implement a new homecare model in 2012-13 to cover family caregivers.

The Member for St. John's Centre (Ms. Rogers) presented a Petition from certain residents of the Province calling upon the House of Assembly to urge Government to enact whistleblower legislation to protect public sector employees in Provincial departments and agencies.

The Member for St. Barbe (Mr. Bennett) presented a Petition from certain residents of the Province calling upon the House of Assembly to urge Government to implement a new homecare model in 2012-13 to cover family caregivers.

The Member for The Straits – White Bay North (Mr. Mitchelmore) presented a Petition from certain residents of the Province calling upon the House of Assembly to urge Government to support residents of White Bay North in their request to obtain adequate cellular phone coverage in rural Newfoundland and Labrador.

The Member for St. John's North (Mr. Kirby) presented a Petition from certain residents of the Province calling upon the House of Assembly to urge Government to conduct a review of school bus transportation policies and school restructuring to ensure safe and quality education for all school children in the Province.

Pursuant to order and on motion debate continued on the motion "That This House Approves in General the Budgetary Policy of the Government" (the Budget Speech).

During the debate the Member for Humber Valley (Mr. Ball) moved, seconded by the Member for Burgeo – La Poile (Mr. Parsons) the following amendment to the Budget motion (being a non-confidence motion):

"That all the words after "that" be struck out and the following substituted:

this House condemns the government for its failure to present a fiscally responsible program which addresses the immediate economic problems of rural areas of the Province as well as the serious social needs which exist in this Province and its failure to create a climate for sustainable economic growth within the Province."

The Speaker suspended the proceedings at 3:32 o'clock in the afternoon to consider the amendment.

Debate commenced on the amendment to the Budget Speech (being a non-confidence motion) and on motion debate adjourned for further debate on tomorrow.
