"WHEREAS the Federal Government has tremendous power and leverage to lower barriers between provinces and forge a path toward fairness and true community;

AND WHEREAS Quebec has frustrated Newfoundland and Labrador's attempts to wheel electricity fairly through that province;

AND WHEREAS Prime Minister Stephen Harper and his colleagues have committed to provide a loan guarantee or equivalent financial support for the Muskrat Falls Project, which includes a sub-sea transmission link to the Maritimes, because it has national or regional importance, it has economic and financial merit, and it will significantly reduce greenhouse gases;

AND WHEREAS the Prime Minister, in announcing funding for Ontario under the eco Trust on March 6, 2007, said that province could choose to use its funding to advance construction of "an East-West electrical transmission interconnect with Manitoba, allowing for the importation of clean hydroelectric power";

AND WHEREAS on September 16, 2009, the Prime Minister announced funding for the construction of the Northwest Transmission Line in northern British Columbia and the prospect of connecting the line to Alaska;

AND WHEREAS the opening of Canadian east-west energy corridors would give provinces the freedom to transmit energy to markets within Canada, create economic opportunity and strengthen the country;

BE IT THEREFORE RESOLVED that this House of Assembly urges all governments in Canada to cooperate in exploring opportunities to open east-west electricity transmission corridors within Canada."

The Honourable the Government House Leader (Mr. Kennedy) announced pursuant to Standing Order 63(3) that the Resolution standing in the name of the Member for Port de Grave (Mr. Littlejohn) would be debated on Private Members' Day, Wednesday, June 6th.

The Honourable the Minister of Fisheries and Aquaculture (Mr. King) continued and concluded his answer and tabled information relating to Question No. 19 placed on the Order Paper of May 16th, 2012 by the Member for St. Barbe (Mr. Bennett) respecting the buyout of lobster licenses.

Pursuant to order and on motion the Bill entitled "An Act To Amend The Aquaculture Act" (Bill No. 22) was read the second time and on motion it was ordered that Bill No. 22 be referred to a Committee of the Whole House presently.

Pursuant to order and on motion debate commenced and concluded on Second Reading of a Bill entitled "An Act To Amend The Student Financial Assistance Act" (Bill No. 15) and on motion it was ordered that Bill No. 15 be now read the second time.

Pursuant to order and on motion the Bill entitled "An Act To Amend The Student Financial Assistance Act" (Bill No. 15) was read the second time and on motion it was ordered that Bill No. 15 be referred to a Committee of the Whole House presently.
