

Tuesday, June 19th, 2012

The House met at 1:30 o'clock in the afternoon pursuant to adjournment.

The Honourable the Speaker (Mr. Wiseman) ruled on a point of privilege raised by the Honourable the Government House Leader (Mr. Kennedy) on June 14th respecting comments made outside the House by the Leader of the Third Party. The Speaker ruled that there was no *prima facie* case of breach of privilege but added that the remarks were an affront to the dignity of Members and suggested the Member apologize which the Member did.

The Member for Cape St. Francis (Mr. Parsons) made a Statement to congratulate Rose Auchinleck who has received the Queen's Diamond Jubilee Medal.

The Member for Bellevue (Mr. Peach) made a Statement to congratulate the Grade 6 Class of Woodland Elementary on the occasion of their graduation and transition to their new school Crescent Collegiate.

The Member for Fortune Bay – Cape La Hune (Ms. Perry) made a Statement to congratulate Devin Benoit who has received the Premier's Athletic Award for Powerlifting.

The Member for Baie Verte – Springdale (Mr. Pollard) made a Statement to congratulate Mr. Herb Pike on the occasion of his 89th birthday.

The Member for St. John's Centre (Ms. Rogers) made a Statement to recognize the work of RIAC, the Refugee Immigrant Advisory Council and to celebrate Refugee Week.

The Member for Lake Melville (Mr. Russell) made a Statement to congratulate the Happy Valley-Goose Bay Relay for Life organizing committee and participants.

The Honourable the Minister of Municipal Affairs (Mr. O'Brien) made a Statement to announce that there would be new infrastructure projects in the Province this year as a result of new investment provided for in the 2012 Budget.

The Honourable the Minister of Health and Community Services (Ms. Sullivan) made a Statement to inform the House about enhanced dialysis services in the Province.

On motion the report of the Committee was received and adopted and on motion it was ordered that the Committee have leave to sit again presently.

Pursuant to order and on motion debate commenced and concluded on Second Reading of a Bill entitled "An Act To Amend The Labour Relations Act" (Bill No. 37) and on motion it was ordered that Bill No. 37 be read the second time on tomorrow.

Pursuant to order and on motion the Bill entitled "An Act To Amend The Labour Relations Act" (Bill No. 37) was read the second time and on motion it was ordered that Bill No. 37 be referred to a Committee of the Whole House on tomorrow.

Pursuant to order and on motion debate commenced and concluded on Second Reading of a Bill entitled "An Act To Amend The Public Service Collective Bargaining Act No. 2" (Bill No. 38) and on motion it was ordered that Bill No. 38 be read the second time on tomorrow.
