Pursuant to order and on motion debate commenced and concluded on Second Reading of a Bill entitled "An Act To Revise And Amend The Law Respecting Pensions For The Members Of The Royal Newfoundland Constabulary, Correctional Officers And Certain Firefighters Of The St. John's Regional Fire Department" (Bill No. 44) and on motion it was ordered that Bill No. 44 be now read the second time.

Pursuant to order and on motion the Bill entitled "An Act To Revise And Amend The Law Respecting Pensions For The Members Of The Royal Newfoundland Constabulary, Correctional Officers And Certain Firefighters Of The St. John's Regional Fire Department" (Bill No. 44) was read the second time and on motion it was ordered that Bill No. 44 be referred to a Committee of the Whole House now.

On motion of the Honourable the Government House Leader (Mr. King) the House resolved itself into a Committee of the Whole House.

The Speaker left the Chair.

Mr. Littlejohn took the Chair of Committee of the Whole House.

On motion the Committee rose.

The Speaker resumed the Chair.

The Chairperson of the Committee of the Whole (Mr. Littlejohn) reported that the Committee of the Whole House had considered the matters to them referred and had directed him to report that they had passed the Bill entitled "An Act To Revise And amend The Law Respecting Pensions For The Members Of The Royal Newfoundland Constabulary, Correctional Officers And Certain Firefighters Of The St. John's Regional Fire Department" (Bill No. 44) without amendment.

On motion the report of the Committee was received and adopted and on motion it was ordered that the said Bill be read the third time on tomorrow.

On motion of the Honourable the Government House Leader (Mr. King) the House resolved itself into a Committee of the Whole House.

The Speaker left the Chair.

Mr. Littlejohn took the Chair of Committee of the Whole House.

On motion the Committee rose.

The Speaker resumed the Chair.

The Chairperson of the Committee (Mr. Littlejohn) reported that the Committee of Supply had considered the matters to them referred and had directed him to report that they had made some progress in their consideration of a Bill entitled "An Act To Amend The Loan and Guarantee Act, 1957" (Bill No. 39).
