The House met at 1:30 o'clock in the afternoon pursuant to adjournment.

The Member for St. Barbe (Mr. Bennett) raised two points of order alleging that the Honourable the Minister of Education (Mr. Jackman) made an inaccurate statement and that he had used unparliamentary language. The Speaker took the matter under advisement.

The Member for St. John's East (Mr. Murphy) made a Statement to congratulate Bernice Morgan who has been inducted into the Order of Canada.

The Member for Humber Valley (Mr. Ball) made a Statement to congratulate Mr. Sam Alexander on the occasion of his 98<sup>th</sup> birthday.

The Member for Cape St. Francis (Mr. Parsons) made a Statement to congratulate Jeremy Mueller for his accomplishments as a Special Olympian.

The Member for Bellevue (Mr. Peach) made a Statement to congratulate Mrs. Flo Peach, a dedicated volunteer, who has been awarded a Queen Elizabeth II Diamond Jubilee Medal.

The Honourable the Premier (Ms. Dunderdale) made a Statement to pay tribute to the late Hazel McIsaac.

The Honourable the Minister of Education (Mr. Jackman) made a Statement to offer condolences to the families, friends and colleagues of those tragically killed on December 11<sup>th</sup> at Sandy Hook Elementary School in Newtown, Connecticut.

The Honourable the Minister of Innovation, Business and Rural Development (Mr. Hutchings) made a Statement about the Youth Innovation Call for Proposals initiative.

The Member for Lewisporte (Mr. Verge) gave notice that he would on tomorrow ask leave to introduce the following Resolution:

**"WHEREAS** the Province's Fisheries Loan Guarantee Program supports the development of the Province's independent fish harvesting industry by making available a government guarantee on loans offered by financial institutions, including banks and credit unions, for such things as:

- (i) vessel related items such as construction, purchase and/or refit;
- (ii) combining of enterprises and license acquisitions;
- (iii) refinancing of loans owed to fish processors for fixed assets and/or license acquisitions; and
- refinancing of loans previously obtained from chartered banks for vesselrelated purposes and fish license acquisitions (concurrent with combining of enterprises);

**AND WHEREAS** the program offers loan guarantees for combining of enterprises up to \$3 million; vessel-related items up to \$2 million; and license acquisitions up to \$1.5 million; the guarantee can provide up to 100 per cent of an outstanding loan; and guaranteed loans are offered at the financial institution prime rate, as negotiated between the harvester and the lender, to a maximum of prime plus 2 per cent or 2.5 per cent, depending on the term of the loan, and a harvester may choose a fixed or floating interest rate and a floating rate may be converted to a fixed rate at any time:

**AND WHEREAS** the uptake under the program has been strong and the benefits have been great, demonstrating the program's success in strengthening the Province's independent fish harvesting industry;

**THEREFORE BE IT RESOLVED** that this Honourable House encourages the Provincial Government to continue supporting the development of the Province's independent fish harvesting industry by maintaining the Province's Loan Guarantee Program."

The Honourable the Government House Leader (Mr. King) announced pursuant to Standing Order 63(3) that the Resolution of which the Member for Lewisporte (Mr. Verge) had given notice would be debated on Private Members' Day, Wednesday, December 19<sup>th</sup>.

The Honourable the Government House Leader (Mr. King) gave notice that he would on tomorrow move, pursuant to Standing Order 11, that the House not adjourn at 5:30 o'clock in the afternoon and that the House not adjourn at 10 o'clock in the evening on Monday, December 17<sup>th</sup>, 2012.

The Member for St. John's Centre (Ms. Rogers) presented a Petition from certain residents of the Province calling upon the House of Assembly to urge the Government of Newfoundland and Labrador to repeal Bill 29.

The Member for Bay of Islands (Mr. Joyce) presented a Petition from certain residents of the Province calling upon the House of Assembly to urge Government to support their request to obtain cellular phone coverage.

Pursuant to order and on motion the Bill entitled "An Act To Amend The City Of St. John's Municipal Taxation Act" (Bill No. 54) was read the third time and passed.

On motion it was ordered that the said Bill be printed being entitled as above and that it be submitted to His Honour the Lieutenant Governor for his Assent.

Pursuant to notice and on motion the following Bills were introduced and read the first time:

A Bill, "An Act Respecting The Use And Expropriation Of Land For The Purpose Of The Muskrat Falls Project" (Bill No. 60);

A Bill, "An Act To Amend The Electrical Power Control Act, 1994, The Energy Corporation Act And The Hydro Corporation Act, 2007" (Bill No. 61).

On motion it was ordered that the above-noted Bills be read the second time on tomorrow.

Pursuant to order and on motion debate continued on the amendment to Bill No. 53:

That Bill No 53, "An Act To Amend The Churchill Falls (Labrador) Corporation Limited (Lease) Act, 1961 And The Electrical Power Control Act, 1994" be not now read a second time but that the Order be discharged, the Bill withdrawn and the subject matter referred to the Resource Committee.

The Speaker (Mr. Littlejohn) ruled on the point of order raised by the Member for Signal Hill – Quidi Vidi (Ms. Michael) on December 13<sup>th</sup>. The Speaker ruled that there was no point of order.

The debate continued and concluded on the amendment to Bill No. 53.

The Speaker put the question on the motion and declared the motion defeated.

The Honourable the Government House Leader (Mr. King) moved pursuant to Standing Order 43(1) the following motion "that the previous question be now put".

The Speaker suspended the proceedings at 4:28 o'clock in the afternoon to consider the motion.

The Speaker put the question on the motion that Bill No. 53 "An Act To Amend The Churchill Falls (Labrador) Corporation Limited (Lease) Act, 1961 And The Electrical Power Control Act, 1994" be now put and declared the motion carried and it was ordered that Bill No. 53 be referred now.

On motion the Committee rose.
