It was moved by the Honourable the Minister of Finance and President of Treasury Board (Mr. Kennedy) that debate on the Budget Speech be adjourned for further debate on tomorrow.

The Honourable the Minister of Finance and President of Treasury Board (Mr. Kennedy) informed the House that he had received a Message from His Honour the Lieutenant Governor. The Message was read to the House by the Speaker as follows:

"26 March, 2013

As Lieutenant Governor of the Province of Newfoundland and Labrador, I transmit Estimates of sums required for the Public Service of the Province for the year ending 31 March 2014, in the aggregate of \$7,360,131,700, and in accordance with the provisions of sections 54 and 90 of the *Constitution Act, 1867*, I recommend these Estimates to the House of Assembly.

Sgd. **Frank F. Fagan**, Lieutenant Governor".

It was moved by the Honourable the Minister of Finance and President of Treasury Board (Mr. Kennedy) that the Message together with the Estimates, be referred to a Committee of the Whole on Supply.

The Speaker put the question on the motion.

The motion was carried.

Pursuant to order and on motion the House resolved itself into a Committee of the Whole on Supply.
