Pursuant to order and on motion the Bill entitled "An Act To Amend The Insurance Adjusters, Agents And Brokers Act" (Bill No. 21) was read the second time and on motion it was ordered that Bill No. 21 be referred to a Committee of the Whole House now.

"That it is expedient to bring in a measure further to amend *The Loan and Guarantee Act, 1957*, to provide for the advance of loans to and the guarantee of the repayment of bonds or debentures issued by or loans advanced to certain corporations."

Pursuant to order and on motion the Bill entitled "An Act To Amend The Loan And Guarantee Act, 1957" (Bill No. 24) was read the first, second and third time and passed.

It was moved and seconded that when the House rose it would adjourn until tomorrow, Monday, December 2nd at 1:30 o'clock in the afternoon.
