The Member for Bonavista North (Mr. Cross) made a Statement to pay tribute to the late Bradley Mercer.

The Member for Torngat Mountains (Mr. Edmunds) made a Statement to recognize the founders of the Combined Councils of Labrador.

The Member for Kilbride (Mr. Dinn) made a Statement to commend Maureen Hynes, a long-standing member of the Goulds Lions Club, for her contribution to the community.

The Honourable the Minister Responsible for the Status of Women (Acting) (Ms. Shea) made a Statement to honour the memory of the 14 young women who were killed during the Montreal Massacre.
